### ACLU OF TN CHALLENGES POSTING OF TEN COMMANDMENTS IN COUNTY BUILDINGS

The ACLU of Tennessee reported on January 29 that they filed a lawsuit challenging the posting of the Ten Commandments in public buildings in Hamilton County.

"The posting of the Ten Commandments in public buildings is divisive to religious diversity," said Hedy Weinberg, Executive Director of the ACLU of Tennessee. "The role of government is to ensure that individuals have the freedom to choose whether or not they want to adhere to a particular religious faith. However, when government promotes religion, that right to religious freedom is jeopardized."

In the lawsuit, the ACLU argues that the posting of the Ten Commandments violates the Establishment Clause of the First Amendment, which prohibits government from promoting or supporting religious doctrine. The postings are in the Hamilton County Juvenile Court Buil-ding, the Hamilton County Chatta-nooga Courts Building, and the Ha-milton County Courthouse.

The ACLU is asking the court to order the removal of the three Ten Commandments displays in order to protect religious freedom for all Hamilton County residents.

"I believe firmly in the moral lessons that we have learned from the Ten Commandments," said local resident and ACLU client Robert Siskin. "However, when the government posts a religious document such as the Ten Commandments, it gives preference to one religious belief over another and threatens religious liberty. This country was founded by people who came seeking religious liberty. Religious liberty means having the right to select the religion you prefer or no religion at all."

Reverend Roland Johnson, Jr., another ACLU client in the case, added, "It is a dangerous thing when politicians attempt to co-opt religion

for their own selfish agenda."

Hugh Hamilton of Chattanooga and Susan Kay of Nashville are acting as ACLU cooperating attorneys in the case.

The ACLU brought the lawsuit at the request of local clergy and concerned residents, Weinberg explained, to ensure that individuals have the right to decide for themselves whether to practice a particular religious faith or to post the Ten Commandments in their homes or businesses.

"Were the government to prohibit the posting of the Ten Commandments in private homes or businesses, the ACLU would fight to protect the peoples' right to promote their religious beliefs and practice their religious faiths. That is what we are here for," she said.

#### PAC FORMED BY SUPPORTERS OF TEN COMMANDMENTS AMENDMENT

Bob Johnson of the Associated Press reported on January 7 that a political action committee was formed in Montgomery, AL, to fight the reelection of legislators who oppose a constitutional amendment to allow display of the Ten Commandments in Alabama schools.

Dean Young, executive director of the Gadsden-based Christian Family Association, said the amendment will be proposed in the regular session of the Legislature.

Young told a news conference that the amendment, if passed by the Legislature and approved by voters, would give local schools the option of allowing display of the commandments

The Ten Commandments amendment passed the Senate last year. It died in the House because it did not come up for a vote in the elections committee, chaired by House majority leader Rep. Ken Guin, D-Carbon Hill.

Young said that Guin, and possibly other legislators, would be targeted for defeat in this year's elections by the newly formed PAC if the amendment dies in the elections committee. "We've stood by far too long and let acknowledgement of God disappear from our schools," Young said. "The Ten Commandments show there is a God."

Young said the newly formed PAC will be active in Guin's rural northwest Alabama district, if the amendment does not come up for a vote in the elections committee.

"If it doesn't come out, we will spend every dime we've got to make sure the people in his district know," Young said. "Ken Guin will be crushed politically."

Guin said he was not worried about being the target of the newly founded political action committee.

#### **BUSH STILL PUSHING VOUCHERS**

Congress rejected private-school vouchers last year, but President Bush just won't take "No" for an answer.

In his 2003 budget released Monday, February 4, Bush proposes giving tax dollars to families trying to get their children out of struggling public schools. But rather than give families money for private-school tuition, Bush now wants lawmakers to give a tax credit of up to \$2,500.

The allowance could be collected even by families who don't owe \$2,500 in taxes, as long as they spend at least \$5,000 to send a child from a failing public school to a private school. Families could also recoup the costs of sending a child to a different public school, or of home schooling. Covered expenses would include transportation, textbooks and home computers.

The benefit would cost an estimated \$3.7 billion over five years.

Undersecretary of Education Eugene Hickok said the benefit would be primarily for low-income families, but that wealthier families living near struggling public schools and sending their children to private schools could probably also take advantage of the credit.

In his budget, Bush also asked Congress for \$75 million to help school dis-

tricts research and develop voucher and public-school transfer programs.

When Congress approved Bush's education plan last year, lawmakers modified his voucher proposal, allowing poor families access to tutoring or transportation if their children attend schools with persistently poor student scores on reading and math tests.

The Education Department estimates that 4.5 million children attend schools that need substantial improvement.

#### ROBERTSON PUSHES BILL ALLOWING CHURCHES TO ENDORSE POLITICAL CANDIDATES

Only a month after Pat Robertson resigned from the Christian Coalition and promised to devote his time to religious ministry, the TV preacher has returned to hardball politics.

On his Christian Broadcasting Network show on January 7, Robertson promoted a House bill that would revise provisions of federal tax law and allow houses of worship to en-dorse political candidates. The mea-sure, H.R. 2357, has been introduced by Rep. Walter Jones (R-N.C.) and has 110 cosponsors, almost all of them Republicans.

Appearing as a guest on Robertson's "700 Club," Jones urged the program's estimated one million viewers to contact their House members and pressure Rep. Bill Thomas, chair of the Ways and Means Committee, to schedule a hearing on the bill in March. Jones said the measure was drafted by the American Center for Law and Justice, the legal arm of Robertson's religio-political empire.

The push for the Jones bill comes in an election year when control of the Congress is up for grabs. In recent weeks, White House political strategists have expressed concern that evangelical Christians did not vote for Bush in 2000 in expected numbers. The Jones bill and Robertson's enthusiastic support for it may be part of a move to spark GOP endorsements by

by conservative churches in the 2002 and 2004 elections.

Robertson made the partisan character of the Jones bill clear. Railing against the "draconian" character of federal tax law, Robertson said on the show, "As it is now, if somebody comes out and says, 'I support George Bush,' theoretically the IRS can come in and take away their tax exemption."

Robertson's attempt to change federal tax law and prod America's churches into partisan politics comes only four weeks after his Dec. 5 announcement that he was quitting as president of the Christian Coalition to push national revival and "focus on those things that will bring forth the greatest spiritual benefit."

Robertson's critics were not surprised at his quick relapse into partisan politics. "This leopard will never change his spots," said Barry Lynn, executive director of Americans United for Separation of Church and State. "Robertson is as interested in winning votes for the Republicans as he is in winning souls."

During today's show, Robertson charged that Americans United has sent a "scare letter out to churches which was filled with misinformation" about involvement in politics. In fact, Americans United has simply provided accurate informational materials to church leaders about the kinds of activities that are allowed and forbidden under federal tax law.

Said AU's Lynn, "Robertson will never give up his dream of forging churches into a partisan political machine. If that dream ever comes true, it will be a nightmare for Ameri-ca. Both religion and government are harmed when the two are recklessly mixed." [From auactivist@au.org.]

#### RELIGIOUS GROUP EXPECTS COMPROMISE ON DAY-CARE

Sean Mussenden of the Orlando Sentinel reported on January 29 that a Volusia County (Florida) lawmaker is backing off her drive to place churchrun child-care centers under state regulation. State Rep. Evelyn Lynn, R-Ormond Beach, sought to license the roughly 500 facilities statewide after a 2-year-old girl died while attending a faith-based day-care center.

But lobbyists said Lynn has agreed to a compromise that would require church day cares to follow most state standards but let them police themselves. The state also would keep out of hiring practices, discipline matters and teacher training at the centers.

Lynn said that a change was in the works, but nothing was final. "All child-care facilities must be safe," she said.

Her campaign to change the law began with the death of Zaniyah Hinson, who was left for three hours inside a hot minivan in August after a day-care trip. A teacher at the Abundant Life Academy of Learning in Daytona Beach failed to make sure all the children left the van.

Such checks are one of the requirements for state-licensed facilities.

"Making faith-based day cares comply with state regulations is a good first step, but allowing *them* to enforce the regulations renders that step meaningless," said Jack Levine, president of the Center for Florida's Children.


"I don't believe that paper protects children. We can have any kind of statutory guidance, but unless there is a clear and consistent enforcement capacity, even good legislation can hold a false promise," he said.

Benjamin Crump, a Tallahassee lawyer representing the Hinson family, said Zaniyah's death illustrates the shortcomings of having religious groups police themselves. The Abundant Life Academy was accredited by the Florida League of Christian Schools at the time of the child's death.

"You need the power of the state to make sure the rules are followed," Crump said.

The bill still faces obstacles, including four committee stops, before it gets to the House floor.

Darwin Day is not owned by any individual or organization it is a celebration for one and all.

We encourage all science-enthusiasts to join us in the celebrations, whether as groups, schools, classrooms, organizations, businesses or individuals.


The one defining quality about Darwin Day is that it accepts and defends evolution and science education and challenges the creationist movement. The main focus of the program, however, is not to provide a defense against creationism but instead to promote and celebrate science and humanity. It is also not attached to any religious belief or lack thereof. Both religious and non-religious evolutionists are encouraged to participate.

#### There are a lot of freethought organizations involved in the Darwin Day Program. Does this mean Darwin Day is non-religious or anti-religious?

No. The Darwin Day Program is neither non-religious nor anti-religious. The topic of religion will undoubtedly come up at events and activities however, largely because the theory of evolution continues to be misinterpreted as a threat to religious belief. The life sciences continue to evoke controversy that fall within the realm of many religions. The creationist movement, being founded on a literal interpretation of the Bible, and having religion and politics as primary agendas, will also increase the likelihood that the topic of religion will surface every now and then, especially if the activity in question is a direct challenge to creationism, such as the popular evolution/creationist debates. In addition, because of the historical battles between religion and science and similar battles and reconciliations that continue to capture our attention and interest today, religion may play a role within the Darwin Day celebrations. The Celebration itself, however, does not promote religion or non-religion and especially not anti-religion. Groups, organizations, and individuals of all religious flavors or lack thereof, are invited to celebrate Darwin Day and the promotion of science and humanity.

Creationists equate evolution with atheism, claiming the theory has an underlying philosophical assumption that is non-religious or even anti-religious. By promoting the Darwin Day Celebrations within the freethought community are you not simply helping them propagate this myth further and adding fuel to the fire that reputable science organizations are attempting to extinguish? In other words, are you not harming science literacy and the defense of evolution and science education by creating this program?

The propaganda and misinformation being spread that evolution is a *belief* or a *religion* stemming from the atheist/naturalist/secular humanist philosophy is false. Who better to help show the fallacies of this claim than the secular community? Regardless, the focus of the Darwin Day Program is not on the religious beliefs of the participants involved and the diversity among the beliefs of program participants should provide evidence for this. To address another issue within the above question, the program has been designed with these concerns and sentiments taken into consideration. Program directors will use careful thought and analyses in all program developments (although this is not to suggest we will eliminate all fun and lighthearted ideas and suggestions.) Advisors for the program have been chosen based on their expertise and will aid in ensuring that the Darwin Day Celebrations help, not hinder, the promotion of science literacy and the defense of evolution and science education in our societies. Program Directors will also continue to welcome and encourage feedback and thoughtful criticism on all aspects of the program.






