American Atheists Billboards

Billboards are used sparingly but effectively

An atheist billboard on the New Jersey side of the Lincoln Tunnel that declared Christmas a myth has been replaced by a pro-Christian billboard.

The old billboard, put up in late November by American Atheists said "You know it's a myth. This season, celebrate reason."

The sign stirred controversy among Christian organizations, prompting the Catholic League to erect its own pro-Christmas billboard on the New York side of the tunnel that read "You Know It's Real: This Season Celebrate Iesus."

The new sign, which was posted by the Manhattan-based Times Square Church, reads "God is," and includes a word cloud of religious themes.

As for the old sign, an American Atheists spokesman said the organization's lease ran out on the space, as they'd only had it reserved for a month.

Since putting down \$20,000 for the billboard, American Atheists has earned \$65,000 in donations, which they attributed to the national publicity it garnered—with a little help from the Catholic League.

"We received e-mails from hundreds of agnostics and atheists who heard about the billboard and had never heard about us who thanked us for being there and letting them know they're not alone, and that was our target audience from the get-go," said spokesman Blair Scott. "We sent the Catholic League a thank-you letter."

Atheists, Humanists and other non-believers will gather in Huntsville, AL on January 29-30, 2010 for the Southeast Regional Atheist Meet (SERAM) —and they're spreading the word the same way they did outside the Lincoln Tunnel—with a strong and challenging billboard.

The new billboard depicts several houses of worship with diverse religious symbols, and the message "You KNOW they're all SCAMS."

The sign went up on New Year's

Scott says he finds it hard to believe that anyone still attends the Catholic church after the manifold evidence of ways the church hierarchy protected known child molesters, has uncovered

Day (Jan. 1, 2011) and is visible to northbound traffic on US-231 (Memorial Parkway) in Huntsville.

In a Dec. 23 press release, the President of American Atheists, David Silverman, said, "We're reaching out to Americans who attend religious services even though they know it's a scam. This is part of our 'You KNOW it!' campaign. As we did in New York, with this billboard we are challenging Alabama to face what they KNOW is the truth—that all religions are scams—they tell you how to live, and then they take your money, all in exchange for an afterlife that does not exist."

"We are challenging people. If you know it's a scam, why participate? Why are you letting this scam run any part of your life, or take any of your money? Why must you remain silent and compliant to protect the scam?"

Blair Scott, a local Huntsville resident and Communications Director for American Atheists, noted other frauds than the promise of an afterlife.

embezzling at high levels, and continues to ban condom use even though that could help save lives in AIDS-riddled Africa.

"All this, and people are still going to Mass," Scott said. "It boggles my mind. It's like after Tammy Faye and Jim Bakker got busted, people still sent them money!"

Scott said that the SERAM was one good way for people to find out the truth about organized religion.

"We are inviting all Atheists, Humanists, Freethinkers and anyone 'in the closet' to come and meet fellow nonbelievers, and get introduced to the thriving community we are building in Huntsville and throughout Alabama," said Scott. "Polls show that upwards of 15% of people intellectually reject religious teachings. They know it's a scam, and we think that's just the tip of the secular iceberg."

Further Developments on the May 21 Prediction

A not-so-wise use of money, time and billboards

The billboard reads "He is Coming Again! May 21, 2011." It's a message that some Christians claim, saying that Jesus will return on that date.

The billboards, much smaller than the American Atheists billboards, are located in at least 8 major U.S. cities, including Atlanta and Nashville. (Nashville has 40 such billboards; Atlanta has 50 of them.)

Fans of Family Radio Inc., a nationwide Christian network, paid for the billboards. Family Radio's founder, Harold Camping, predicted the May date for the Rapture.

Their message is simple—"He Is Coming Again"—and their aim is to get unbelievers to turn around quickly. But critics say the billboards are a waste of time, one more failed attempt to predict the end of the world.

The Rapture is going to be a great day for God's people but awful for everyone else, said Allison Warden, 29, who orchestrated Nashville's bill-board campaign. She's a volunteer with WeCanKnow.com, a website set up by followers of Family Radio. She and other fans designed the bill-boards, along with T-shirts, bumper stickers and postcards to get Camping's predictions out.

Warden traveled from her home in Raleigh, N.C., to Nashville in early December to check out the billboards, purchased through the end of the year. She wouldn't say how much they cost or name who paid for them.

She is absolutely sure that Camping's prediction is right.

"It's a certainty," she said.

But many Christian groups do not agree. In fact, most of them are distancing themselves from the message, quoting a bible verse that "No one knows the day or the hour."

David P. Gushee, a professor of Christian ethics and head of the Center for Theology and Public Life at Mercer University, also disagrees with the message. "I'm glad they have it figured out," he said. "No one knows the day or the hour. Only the Father knows and I think that teaching has provided good guidance to Christians throughout the centuries. You never attempt to fix a date for Christ's return."

If May 21 passes with no return, he said, it could prove to be embarrassing for the campaign organizers and a disappointment for those who take such things seriously. "It's really a bad idea."

Smyrna resident Ed Buckner, a member of the board and former president of American Atheists, said the group is considering a reply.

"In all honesty, I think Christians, and not just atheists, ought to ridicule these billboards and protest against them," he said. "They're really putting Christianity on the spot."

Predicting the second coming for Jesus dates to very early Christianity, when believers said he would return in their lifetimes. Since then there have been a series of failed predictions. One of the most famous, known as the Great Disappointment, happened in 1843, after William Miller and his followers sold their homes and waited out in a field for Jesus to come back.

Former NASA engineer Edgar C. Whisenant sold millions of copies of his book 88 Reasons Why the Rapture Will Be In 1988.

BILLBOARDS IN OTHER CITIES

Tom Evans, a spokesman for Family Radio, insisted the predictions are true, and he and other Family Radio supporters want to save their friends and neighbors from God's judgments. The billboards are also up in Louisville, St. Louis, Detroit, Little Rock, Omaha, Kansas City, Fort Wayne, Ind., and Bridgeport, Conn. In cities with Family Radio-affiliated stations, the message is on the air.

The latest prediction comes from a verse in Luke 17: "As it was in the days of Noah, so shall it be in the days of the Son of Man."

It's a matter of simple math, said Evans.

CALCULATION OF THE DATE

According to Camping's prediction, the Rapture will happen exactly 7,000 years from the date that God first warned people about the flood. He said the flood happened in 4990 B.C., on what would have been May 21 in the modern calendar. God gave Noah one week of warning.

Since one day equals 1,000 years for God, that means there was a 7,000-year interval between the flood and the Rapture.

"We hope that anyone would get a Bible out and try and prove that this is wrong," he said.

Camping says further that, following the Rapture on May 21, God will destroy the world on Oct. 21, 2011.

To spread their message, Family Radio is also sending out caravans of RVs across the country, with the Rapture message. They're also sending missionaries around the world to hand out tracts.

But he thinks only a small number of people—about 3 percent—will take the billboards seriously.

"Sadly, only eight people survived the flood in Noah's time," he said. "The number of people that are going to be saved is going to be very small."

At least one Nashville resident remained unconvinced. Sophie Boes is a manager at Whiskey Kitchen, the downtown restaurant closest to a Gulch billboard. She said she'd never seen a message like it.

"Wow," she said. "Welcome to the South."

CFI Seeks Camp Director

he Center for Inquiry, a national nonprofit organization located in Amherst, NY, is looking for a camp director for its summer camp program, Camp Inquiry. Camp Inquiry serves children ages 7-16. Applicants must be familiar with the organization's mission and demonstrate a commitment to humanism and skepticism. Applicants should have at least one season of camp administrative experience, as a director or head counselor, and must have substantial experience working with youth. The director for Camp Inquiry will be required, among other things, to prepare and conduct pre-camp and inservice staff trainings, plan the curriculum, develop routines, schedules, and procedures for camp operation, and supervise all operations and program staff.

Preparation for the camp begins on a part-time basis in February. The camp itself will be held on July 31-August 6, 2011 in Holland, NY. The camp director must be on site while camp is in session; preparatory work may be done remotely. The camp director will be an independent contractor. Compensation will reflect experience, but is expected to be in the range of \$9,000-\$14,000.

Problems with the Comprehensive Soldier Fitness Program

On December 23, I learned something rather startling. Apparently, according to the assessment tool currently in use by the US Army to measure mental fitness, I am deficient in the area of "spiritual fitness" and I need to "work hard" to improve my scores in this area.

Here's some background on the test. The Army has a new program called the Comprehensive Soldier Fitness Program that is supposed to "create an Army of balanced, healthy, self-confident Soldiers, Families, and Army civilians whose resilience and total fitness enables them to thrive in an era of high operational tempo and persistent conflict." This quote is extracted directly from the Army's official blog¹.

The mental health components of this initiative are Emotional Fitness, Social Fitness, Family Fitness, and Spiritual Fitness. All soldiers were required to complete the Global Assessment Tool (GAT) that was designed to measure these components of fitness and this requirement will soon apply to Army civilians as well.

As a civilian employee of the Army, I have access to the test, and after receiving several complaints, I decided to take the test and check this out for myself. According to the test web site, individual results are not reported to commanders by name, but commanders will receive an aggregated report of all the responses in their unit so that they can identify potential issues and conduct interventions and corrective training if issues are identified. However, since I did have to complete the test using my official Army login, it is a certainty that my individual results are a part of my electronic personnel record and I have no clear picture concerning what use these results could be put to in the fu-

I have no real way to know if the assessment is exactly the same for soldiers and civilians, but according to the complaints I received, at least some of the questions are the same. Here's a sample of some of the questions I had to answer:

Answer in terms of whether the statement describes how you actually live your life.

I am a spiritual person. My life has a lasting meaning. I believe that in some way my life is closely connected to all humanity and all the world. The job I am doing in the military has lasting meaning. I believe there is a purpose for my life.

I basically answered the questions in the following way, which is the way a lot of atheists would answer them. I am not a spiritual person, I don't believe my life has a lasting meaning, I do not feel connected to all of humanity and the world, and I don't believe my life has a defined purpose. What I do believe, and what's not possible to address using this assessment, is that although there are no such things as spirits or spiritual connections and human lives have no preordained meaning, we can make meaning for ourselves which doesn't require calling on anything spiritual. I also believe there is no such thing as being spiritually connected to humanity but that it is possible to honor and respect humanity and all life, and that while there is no preordained purpose to my life other than what I create for myself, there is nothing wrong with that.

Here's what the test had to say about my responses:

"Spiritual fitness is an area of possible difficulty for you. You may lack a sense of meaning and purpose in your life. At times, it is hard for you to make sense of what is happening to you and others around you. You may not feel connected to something larger than yourself. You may question your beliefs, principles, and values. Nevertheless, who you are and what you do matter. There are things to do to provide more meaning and purpose in your life.

"Improving your spiritual fitness should be an important goal. Change is possible, and the relevant selfdevelopment training modules will be

helpful. If you need further help, please do not hesitate to seek out help from the people you care about and trust - strong people always do. Be patient in your development as it will take time to improve in this area. Still, persistence is key and you will improve here if you make this area a priority."

To say the least, I found this evaluation to be utterly offensive. There is NOTHING wrong with me or my beliefs that needs to be fixed and I firmly believe that any strong atheist like myself cannot honestly answer the questions in a way that allows them to pass the test.

On December 23, American Atheists dispatched a letter to the Secretary of the Army that alleged that the assessment is flawed and discriminatory and will give commanders a misleading and false assessment concerning the state of their units' fitness and readiness. We further stated that this assessment violates the provisions of Army Regulation 600-20 by discriminating against atheist Soldiers due to their lack of spiritual beliefs and we requested the Army immediately cease

using the assessment until these flaws are fixed and Soldiers are no longer subjected to a religious test to assess their overall fitness for duty.

Appeals Court Nixes Rehearing in Utah Memorial Cross Case

The Court Affirmed That Christian Crosses Are Religious Symbols, Not Secular Memorials

A federal appeals court said it won't reconsider a case involving 14 memorial crosses on Utah highways that were ruled unconstitutional.

A three-judge panel decided in August that the 12-foot high crosses represent an endorsement of Christianity.

The Utah Highway Patrol Associa-

tion and two state agencies petitioned for a rehearing. They contend the memorials honor fallen officers and encourage safe driving.

The 14 white crosses were first erected in 1998 and were paid for with donations to the association. American Atheists filed a lawsuit in 2005 over the crosses' use of the Highway Patrol shield and argued that the crosses should be removed.

A majority of the judges on the 10th U.S. Circuit Court of Appeals in Denver rejected a rehearing in a split ruling issued on December 23.


