across the US and around the world. He is now retired and lives in Washington, DC.

He is a member of the Board of Directors of Washington Area Secular Humanists and a member of several Humanist organizations such as the American Humanist Association, the Council for Secular Humanism and the Center for Inquiry, as well as American Atheists, the Freedom From Religion Foundation and he supports Americans United for Separation of Church and State, and the Secular Coalition for America.

"The Great Agnostic": Robert G. Ingersoll was a



19th Century champion of Freethought, women's rights, civil rights, and DC voting rights. This famous orator and critique of religion toured the US and delivered over 1,300 speeches to packed houses. Ingersoll lived and worked in Washington, DC. He argued cases before the

Supreme Court, lobbied Congress and consulted with Presidents. This talk wil cover his two DC homes, one on Lafayette Square, and the places where he worked and spoke in downtown Washington, DC.





Darwin Day • February 12, 2015

Darwin Day is observed on February 12, 2015 and intends to commemorate the anniversary of the birth of **Charles Darwin** in 1809. The day is used to highlight Darwin's contribution to science and to promote science in general. Charles Robert Darwin was an English naturalist, who established that all species of life have descended over time from common ancestry, and proposed the scientific theory that this branching pattern of evolution resulted from a process that he called natural selection.

In the late 1990s, two Darwin enthusiasts, Chesworth and Stephens, co-founded an unofficial effort to promote Darwin Day. In 2001, Chesworth moved to New Mexico and incorporated the "Darwin Day Program." In 2004, the New Mexico Corporation was dissolved and all its assets assigned to the "Darwin Day Celebration," a non-profit organization incorporated in California in 2004 by Dr. Robert Stephens and others and the Mission Statement was expanded.

Some celebrants combine Darwin Day with a celebration of Abraham Lincoln, who was also born on February 12, 1809. Still others like to celebrate the many noted individuals that influenced or were influenced by Darwin's work, such as Thomas H. Huxley, Charles Lyell, Alfred Russel Wallace, Carl Sagan, and Ernst Mayr. (With material from: Wikipedia)



"Religious liberty" bill is misleading—at best

Dear Editor:

State Rep. Sam Teasley (R-Marietta), along with fired Atlanta Fire Chief Kevin Cochran and Concerned Women for America of Georgia, is misleading about the purpose and effects of legislation Teasley is pushing. His "Religious Liberty" bill, HB 29, is presented as needed to protect the religious liberty of conservative Christians, but that is not the aim. The religious liberty of all Christians, and of all the rest of us, is protected by the First Amendment.

What Teasley's bill would do is downright un-American: it would protect the "rights" of some—but only some—religious believers to use the power of government to promote their religious beliefs.

There are many examples that would make this point, but just consider these:

1. Chief Cochran published a book expressing his religious beliefs and used the power and title of his office to give those beliefs credibility and a captive audience. He passed out copies of his book to Atlanta firefighters who served under him. The chief has, under the First Amendment, every right to whatever religious beliefs seem right to him and to express those in whatever ways that suit him—but he does not have the right to use his secular, tax-funded job to proselytize. If you're not convinced, imagine a Muslim fire chief publishing a book on the need for sharia law and distributing it to his firefighters.

2. Tanya Ditty, in her letter to the Marietta Daily Journal (Jan. 9), cited three Georgia cities where she claimed religious expression had been curtailed—Savannah, Ellijay, and Pine Mountain. In all three cases, the restrictions imposed were on governments, not on individual citizens. Every American citizen has an unrestricted right to support Christianity, Islam, or atheism. No American citizen has the right to use governmental power to support religious or irreligious beliefs.

Ironically, to truly protect religious liberty of all Americans, we have what we need: the First Amendment. "Adding" a state law pretending to expand rights in fact endangers those rights.

What If God Doesn't Want It?

Ala. Town Declares Itself Property Of The Almighty by Rob Boston

Officials in the town of Winfield, Ala., passed an interesting resolution last month: They declared that God owns their community (http://www.al.com/news/index.ssf/2015/01/reaction_mostly_positive_after.html).

"Whereas we acknowledge God is the owner of the City of Winfield and that it is a City under God. We acknowledge that at all times, He is in control," reads a resolution that passed the city council unanimously.

It goes on like this for several more sentences. The town officially endorses prayer and acknowledges that "the City of Winfield is where it is today because of God's grace and mercy."

The town's mayor, Randy Price, told the news website AL.com, "I feel like we need to stand up

the Ten Commandments at his business. Sounding more like a preacher than a politician, he remarked, "I'm going to step on a lot of people's toes but there's not but one God and, that one God, to Him be the glory. There's no other way; there's no other God. There are a lot of religions out there but only one God."

Glad we got that cleared up.

Now, I've never been to Winfield, a town of about 4,500 in northwest Alabama. I think the chances that I will ever get there are slim – although the town's annual Mule Day Festival (http://winfieldsmuleday.com/) sounds like fun for the whole family. But I do have some questions for Mayor Price and the city council: If God owns the town, does that mean he'll be picking up the property taxes? Should residents just pray if they need a pothole filled? Where does God stand on the burning zoning issue, which I read about in the local newspaper, of the Winfield man who wants to open a store selling guns and musical instruments out of his house?

More to the point: Did anyone ask God if he really wants to own this



town?

Look, I'm sure that officials in Winfield don't literally believe that God owns their town – at least I hope they don't. But these folks need a history lesson. Price speaks of "forefathers" who declared America one nation under God.

Who exactly were these people? I challenge Mayor Price to name them.

The phrase "under God" was slipped into the Pledge of Allegiance in 1954. Before then, we were simply "one nation, indivisible with liberty and justice for all." The "forefathers" had nothing to do with that change – unless President Dwight D. Eisenhower counts as a forefather.

The members of the city council could also use a lesson in tolerance. Their job is to represent everyone – even the lonely atheists who

Price owns a towing service in town and displays

may reside in Winfield. Right now, they're not doing that. City officials are wading into theological matters and elevating one version of faith over others as well as over non-faith. That's not part of their job description.

I did a quick search online, and it looks like there's no shortage of houses of worship in Winfield. Let the men and women who pastor those facilities handle the God stuff. The city council can stick to issues like zoning, taxes, public services – and, of course, planning this year's Mule Day Festival.

Oppose Religious Electioneering: Contact Your Representative Now

That didn't take long. Congress is only in its first month, but religious right government officials are wasting no time in trying to tear down the wall of separation between church and state.

Earlier this month, Rep. Wal-

ter Jones (R-NC) introduced a bill, H.R. 153, which would "restore the Free Speech and First Amendment rights of churches and exempt organizations by repealing the 1954 Johnson Amendment." The Johnson Amendment being referred to is a piece of legislation that prohibits churches from endorsing or opposing political candidates.

If pastors are given the right to endorse candidates from the pulpit, their

parishioners may be coerced into supporting specific candidates because of a perceived religious obligation. This is fundamentally un-American, and weakens the state of our democracy by giving religious leaders untold influence.

Stand up for church-state separation by opposing this harmful bill! (http:// action.americanhumanist.org/p/dia/action/ public/?action_KEY=17059)

Church and state are separate for a reason, and attempts to de-secularize our government must be opposed by humanists just like you. Won't you take a moment to make your humanist voice heard by contacting your Representative?

We have a long congressional session ahead of us, but the American Humanist Association is dedicated to helping local humanists leave their mark on public policy. Thank you for defending the separation of church and state.


FFRF ends Georgia teachers' proselytizing

Elementary school faculty in the Whitfield County School District, Georgia, will no longer teach their young students religion thanks to a letter sent by the Freedom From Religion Foundation.

FFRF received a report from a parent whose Antioch Elementary School kindergartener was informed that Christmas was "Jesus's Birthday" and that "Jesus is the reason for the season." A project in the child's class involved making a nativity scene from construction paper while a teacher read students the story of the biblical nativity. When the parent contacted the school to complain, the solution offered was to remove the student "whenever anything religious was brought up," and to ask the parent what she should to do with the child "when they do activities for Easter."

Staff Attorney Andrew Seidel sent a letter to Superintendent Judy Gilreath on December 23, 2014. "Public schools have a constitutional obligation to remain neutral toward religion. When District staff assign children the task of making a project depicting a religious story, read students the nativity story, and tell students that Christmas is 'Jesus's birthday' and that Jesus is 'the reason for the season,' the District has unconstitutionally entangled itself with a religious message, specifically a Christian message," wrote Seidel. Gilreath responded on January 5, explaining that she met with the Antioch principal and "made her aware of the complaint and the legal restrictions concerning teaching of religion in a public school." She instructed the principal to speak with the teacher who did the nativity project to "make sure she understand she is not to celebrate religious holidays with her students."


