STATE/CHURCH WATCHDOG WARNS:

'Pulpit Freedom Sunday' crosses legal, ethical line

The Freedom From Religion Foundation, which was at the center of a high-profile lawsuit against the Internal Revenue Service over illegal church electioneering, warned that "Pulpit Freedom Sunday" on Oct. 5 deliberately seeks to incite church pastors into flouting the law.

All 501(c)(3) nonprofits, including churches, are prohibited from engaging in partisan politicking in exchange for the privilege of tax exemption. FFRF's federal lawsuit charged that political violations by churches were being selectively ignored. FFRF, a state/church watchdog with more than 21,000 nonreligious members, took the IRS to court in November 2012. After being given assurances this summer that the IRS has authorized procedures and "signature authority" to resume initiating church tax investigations and examinations, FFRF agreed to drop its suit.

FFRF criticized the Alliance Defending Freedom, which is behind Pulpit Freedom Sunday, for inciting illegal acts and for treating church pastors like pawns.

ADF reported revenue of more than \$50 million last year (http://www.alliancedefendingfreedom.org/about/financials).

ADF's FAQ on Pulpit Freedom Sunday says ADF is "actively seeking to represent churches or pastors who are under investigation by the IRS . . . by preaching Scriptural Truth in a way that expresses for — or opposition to — political candidates." (http://www.alliancedefendingfreedom.org/content/docs/issues/church/Pulpit-Freedom-Sunday-FAQ.pdf)

While claiming its strategy is to file "tactical lawsuits" against the IRS, ADF hasn't filed any such suits since declaring "Pulpit Freedom Sunday" in 2008.

"Churches and their pastors are not above the law. Ministers who claim to be moral leaders should realize it's not only illegal for tax-exempt groups to endorse political candidates, it's unethical. It's an abuse of the public trust," said Annie Laurie Gaylor, FFRF co-founder.

"Rogue pastors who endorse from tax-exempt pulpits are playing dirty

pool. Such an abuse creates an unfair election advantage. Donations to politicians are not tax-deductible, but donations to churches are. Imagine if tax-exempt churches — which don't have to file financial returns with the government like all other 501(c)(3) groups must — were allowed to openly engage in partisan politics? Church congregations could become political machines, and political donations could be 'money laundered' through tax-deductible church contributions," Gaylor warned.

FFRF Co-President Dan Barker added, "Pastors are free to endorse from the pulpit, but then their churches need to give up their tax exemption."

U.S. District Judge Lynn Adelman's order granting the joint motion for dismissal by FFRF and the IRS left open FFRF's ability to renew its lawsuit if the IRS reverts to previous inaction (http://ffrf.org/news/news-releases/item/21076-ffrf-antichurch-electioneering-victory-is-final).

Humanist group condemns religious monument at public school

The American Humanist Association's Appignani Humanist Legal Center sent a letter to officials at the Madison County School District in Daniels-ville, Georgia, on behalf of a concerned citizen about a monument on school district property.

According to the letter, the monument's prominent inclusion of biblical scripture, combined with the high school's logo, send the message that the



school district endorses religion, specifically Christianity, in violation of the Establishment Clause of the First Amendment. The monument, a large permanent sculpture entitled "Red Raider," is located in the Madison High School football stadium and was unveiled this school year. The sculpture includes religious language and Christian biblical references, such as quotations from Romans 8:31 and Philippians 4:13. The monument also features the Madison High School logo, and the high school football team customarily touches the sculpture before home games.

"Numerous cases make clear that public schools are prohibited from taking a position, or even appearing to take a position, on religious belief," said Monica Miller, an attorney with the Appignani Humanist Legal Center. "Erecting a monument on school property that includes Christian scripture sends the unequivocal message to school children that the school is endorsing religion."

"Promoting one religious perspective over all others is discriminatory toward students of religious minorities and toward humanist and atheist students," said Roy Speckhardt, executive director of the American Humanist Association.

The letter demands that the school remove the monument or at least strip the monument of all religious references. The letter also asks that the school keep the monument covered until such a removal can take place.

Atheist student sits out Pledge of Allegiance, threatened with punishment

The American Humanist Association's Appignani Humanist Legal Center sent a letter to officials at the Beaufort County School District in Beaufort, SC, on behalf of an anonymous student who has been denied his constitutional rights to refrain from participating in the school's daily Pledge of Allegiance exercise.

The student, a ninth grader at Right Choices Alternative School, identifies as an atheist and opposes the phrase "under God" in the Pledge. When he has attempted to remain seated at his desk in a quiet and undisruptive manner during the Pledge recitation, his teacher has instructed him to stand, has told him that school policy requires him to stand and has also threatened him with punishment. In addition, the teacher has argued with the student about his atheism, has questioned the student's patriotism and has insisted that his actions are offensive to members of the U.S. armed services. The student contacted the American Humanist Association's Appignani Humanist Legal Center through the organization's DontSaythePledge.com campaign website.

"Threatening a student with punishment simply for exercising his or her right to sit out the Pledge demonstrates a shocking disregard for the rights of free speech and religious freedom," said David Niose, legal director of the Appignani Humanist Legal Center.

"No one should have her or his patriotism questioned for objecting to the phrase 'under God' in the Pledge of Allegiance," said Roy Speckhardt, executive director of the American Humanist Association. "Doing so marginalizes humanist and atheist kids as second-class citizens merely for exercising their constitutional rights."

The letter demands that students and teachers at the school be informed students may refrain from participating in the Pledge exercise. The letter also demands that teachers be instructed that they must not persuade students from sitting out the Pledge and that they should not even questions students who choose to do so. Finally, the letter demands that no disciplinary or other retaliatory measures of any kind be directed toward any student who remains seated during the Pledge.

September 30, 2014, was the fifth International Rights Day,

CFI to raise the alarm about the global crackdown on free expression, particularly criticism of religion, and to show solidarity with those suffering from persecution for their dissent. It is one day

on the calendar that highlights a cause that is at the heart of what we at CFI do 365 days a year.

Heavily citing the work of CFI, Brian **Pellot at Religion News Service** marks the day with an expression of solidarity with imprisoned Saudi dissident Raif Badawi (http:// brianpellot.religionnews.com/2014/09/30/ blasphemy-rights-dayreligious-freedom-unit-

ed-nations-saudi-raif-badawi-waleed-al-kahir/) soon to face 1,000 lashes and ten years in prison for blasphemy (http://www.centerforinquiry.net/ blogs/entry/saudi court denies raif badawis appeal/)—and stern words for the Saudi government, lamenting that the Kingdom's "normalized position on the world stage and Raif Badawi's plight represent the tragedy that can and does ensue when

international economic and political considerations

overshadow fundamental human rights."

CFI president and CEO, Ron Lindsay, chose this occasion to take stock of the current state of free expression and religious dissent around the world (http://www.centerforinquiry.net/blogs/entry/international blasphemy rights day 2014 2/); things are not rosy, but he reminds us of the importance of the cause. "Protecting the fundamental human right to free expression, including the right to express one's views on religious issues, is an ongoing struggle," he writes. "Whether this fundamental right will ever gain truly universal recognition remains an open question. What is not in doubt is that if we who support free expression


