Roberto Moraes (1941–2014) was a familiar face at AFS meetings and events and, it turns out, at one heck of a lot of other organizations' events as well. A memorial held for him on 5 April was attended by around 100 people, including leaders or representatives of 15 different progressive cause organizations in the Atlanta area: Atlanta Freethought, Common Cause, Sierra Club, Grandmothers for Peace, ACLU, Cobb Democratic Women, and many others. Two Georgia Representatives came and spoke—David Wilkerson and Stacey Evans. Rep. Evans also presented two of Roberto's daughters who were

present, Vicki and Chris, with a formal resolution that had been passed by the Georgia General Assembly—a resolution that praised Roberto Moraes

for his activism and support for human rights and that specifically mentioned the Atlanta Freethought Society.

Rep. Stacey Evans told us all that, like a mother with her children, an elected official is not supposed to admit to having a favorite. But she couldn't help it—Roberto Moraes was her favorite constituent.

Everyone that spoke about Roberto—probably 20 people including the several impromptu offerings—commented on his calm, level-headed demeanor, persistent activism, his love of his fellow human beings, his sense of humor, and his strong support for civil rights and for women's rights. He will be missed mightily by many, including those of us in AFS.

National Day of Protest Against the National Day of Prayer!

Atlanta Freethought Society to Lead Protest Versus National Day of Prayer in Acworth, GA

(Atlanta) Atlanta Freethought Society President Rick Pace announced today that AFS will take the lead in protesting an event apparently designed

Ackworth City Hall

to make it appear as if Acworth, Georgia—and the whole US—is only for Protestant Christians.

The protest will be held near Acworth City Hall from 11:30 a.m. to 1:30 p.m. on Thursday, I May 2014 CE. AFS members are urged to e-mail Ed Buckner, ebuckner@atheists.org, if they can participate. Pace noted that "the annual National Day of Prayer event is

exclusionary, pretending to fuse public and religious interests while excluding freethinkers, atheists, and even many of their fellow theists."

The prayer event in Acworth at City Hall is a perfect example: though perhaps not an officially city-sponsored event (it is promoted by the city's Parks and Recreation Department), it is presented as if it is. And probably only Protestant Christians—no Catholics, Muslims, Mormons, or Jews—will be speaking or leading prayers. Acworth leaders seem determined to violate the edict against such ostentatious praying "to be seen of men" supposedly issued

by Jesus himself in Matthew 6: 5-6.

Pace added, "I cannot personally lead this protest, because I have to work then—but I've asked Ed Buckner, the chair of our Activism Task Force and a seasoned activist, to organize and lead our efforts in Acworth." Buckner noted that "all Americans have and must keep the right to express their religious beliefs—but no one has the right to invoke governments in support of their religion. Governments, from the national government to the City of Acworth, lack any power to make religious decisions for Americans."

Other organizations have been asked to join AFS in this peaceful, non-disruptive protest in favor of religious liberty, of separation of government and religion, and against religious hypocrisy.

Acworth City Hall is located at 4415 Senator Russell Ave, Acworth, GA 30101, (770) 974-3112. Be sure to dress comfortably for the weather and make placards.

Please remember that, by City of Atlanta Ordinance, pets are not allowed at Festivals, "unless part of a planned festival program or assisting persons with disabilities."

This prohibition includes "dogs, cats, snakes, birds, pigs, etc." and applies whether or not the pet is leashed. As the ordinance says, this is for the pet's protection as well as for the protection of festival patrons.

Police chief uses office to blatantly promote Christianity

The Freedom From Religion Foundation sent a letter of complaint and records request March 11 to Birmingham, Ala., Police Chief A.C. Roper objecting to his organizing and endorsing a Christian ministry called Prayer Force United.

FFRF, a state-church watchdog based in Madison, Wis., has about 20,000 members nationwide and about 180 in Alabama, including a chapter, the

Alabama Freethought Association. FFRF also addressed Roper's inclusion of Christian prayer at mandatory department staff meetings and events.

Roper, an ordained minster, leads monthly prayer walks in different Birmingham neighborhoods under the auspices of the Prayer Force United ministry. The prayers are supposed to lower crime. FFRF Staff Attorney Andrew Seidel's letter details Roper's stated belief in the power of prayer and the powerlessness of his police force: "[T]he police are not the answer, never have been, never will be. Jesus said that he's the answer," and "one of the biggest problems [Birmingham is] facing is a lack of godliness."

Seidel explained the law to Roper: "It is unconstitutional for government officials to

use their government office and email to advance, promote or endorse one religion over another, or religion over nonreligion. You must keep your religion to yourself when acting in your official capacity as police chief."

Seidel noted that prayer as a crime-fighting technique is ineffectual: "The walks themselves may lower crime simply by having crowds on the streets escorted by police cars with flashing lights, but that is not because of the power of prayer — it is the power of people. Prayer cannot stop violence. Scientific studies show that societies with less prayer have less violence."

FFRF called on the chief to stop forcing prayer on city employees: "Federal courts have found that prayers at government employee meetings constitute illegal government endorsement of religion."

FFRF has created a video with clips from Ropers' sermons and Prayer Force United videos with commentary on their legality. "There was so much video footage, we thought citizens might like to see how the police are abusing their office 'in Jesus' name,' said Seidel, who put the video together. "It's an opportunity to explain the law and provide compelling examples of exactly how the Constitution is being violated."

Prayer Force videos show Roper appearing while using his title and office to endorse the ministry and "claiming the city of Birmingham for God." Roper also explains that Prayer Force is part of the police department: [I]t's a prayer ministry, it's an intercessory ministry, that, in addition to our officers working every day to make the streets of Birmingham safe, we have a prayer force that's interceding."

FFRF also filed an open records request asking for all records relating to the department's official endorsement of the ministry.

The Freedom From Religion Foundation, based in Madison, Wis., a 501(c)(3) nonprofit educational charity, is the nation's largest association of freethinkers (atheists, agnostics), and has been working since 1978 to keep religion and government separate.

Discrimination by a Notary Public—Insignificant?

Back in late March the president and managing director of American Atheists, David Silverman and Amanda Knief, visited a New Jersey branch of TD Bank to get some documents related to AA's nonprofit status notarized. The employee they asked to do this was a notary public, duly authorized to attest to signatures under the laws of New Jersey. But that employee declined to serve as notary regarding their signatures because they were representatives of an atheist organization. They did manage to get the documents notarized, after a delay, by another staffer. There was substantial publicity over this incident—see, for example, http://news.atheists.org/2014/03/27/americanatheists-responds-to-td-banks-statement/ or http://www.examiner. com/article/bank-notary-refuses-service-to-american-atheists. Some, including some online atheists, have decried the reaction of American Atheists as overkill or as mere publicity-seeking aggrandizement. But I'd argue that those critics are misguided, and I've actually experienced very similar discrimination myself, so my opinion is based both on experience and on important legal and social grounds.

First, my own experience: in 2010, while I was president of American Atheists, I needed to get some routine documents notarized involving real

estate in California (a member had left the organization some property in his will). I took the documents to our local bank, a Smyrna branch of Regions Bank where our family had banked for a couple of years, one that had notarized at least one document for me earlier. The staffer who had earlier notarized my signature looked over the real estate documents and said she'd need to check

with her manager before she could notarize anything. She knew me and I had plenty of ID as well as an account with the bank, but she came back and told me that she'd be unable to notarize. Pressed, she claimed that the bank did not notarize "those kind of documents" or similar words. I managed to get the documents notarized down the street at a public surveyor's office—and we took our bank account and business elsewhere thereafter. It seemed quite clear to me that I was refused service because of the name "American Atheists" prominently displayed on the documents and not for any other reason, but proving that would have been difficult.

Did the two women, both bank employees, from New Jersey in 2014 and Georgia in 2010, respectively, have a right to refuse service to atheists? And even if technically they had no such right, was it wise to make a fuss?

They had no such right, as I understand the law and the U.S. Constitution. The job of a notary public in such matters is to provide evidence that the person claiming to sign a document is in fact that person and did in fact sign.

The details of the transaction are mostly* irrelevant to the notary. A public service or accommodation was being offered and therefore the staffer should be denied the right to discriminate. It is parallel to whether lunch counters or bakers can refuse service because of the color of someone's skin or a perception that the customer is gay. And it is more broadly parallel to the current US Supreme Court Case involving Hobby Lobby. Legally, if Regions Bank can refuse to provide service for atheists or Hobby Lobby can avoid the effects of federal requirements based on the owners' religious beliefs, then no legislation or regulation for the public good can be effective.

The National Notary Association proudly evaluates the role of its members as being one of trust-worthiness and integrity—and declares, "Impartiality is the byword of the Notary office and the

foundation of its public trust. Notaries are duty-bound not to act in situations where they have a personal interest. The public trusts that the Notary's critical screening tasks have not been corrupted by self-interest. And impartiality dictates that a Notary never refuse to serve a person due to race, nationality, religion, politics, sexual orientation or status as a non-customer." 
