# Satanic Temple trolling proves that there should be no religious afterschool programs

Dear Editor:

The Marietta Daily Journal editorial on the Satanic Temple (5 August) was poorly written, illogical, and even poorly edited, but it did have one thing right: "The Cobb School District is under no obligation to allow any afterschool clubs in its schools and needs simply give the word to shutter them." I'm no lawyer, but the Cobb Board could probably simply disallow clubs related to religion at all elementary schools—and should.

I'm in no way affiliated with the Satanic Temple and cannot speak for them, but it seems pretty clear that their objective, however provocative their approach, is to enforce the First Amendment and keep government and religion separate. This goal is, it is worth noting, a quintessentially American one and is aimed at limiting governments, not citizens. By the way, I'm an atheist, not a Satanist—some Christians believe in the existence of an actual Satan who personifies evil, but I don't.

Your editorial ridicules the Satanic Temple for wanting to indoctrinate young children, when in fact they are plainly striving to eliminate such indoctrination by the government or on government property. I'm nearly certain that neither the *MDJ* nor anyone on the school board complained when The Good News Club set up shop at Still Elementary to do exactly that. **Katherine Stewart** has written a compelling warning book about the group, *The Good News Club: The Christian Right's Stealth Assault on America's Children* (Public Affairs Books, 2012). When Still Elementary got a Good News Club, did the *MDJ* declare that "the shattering sound is our culture, in free-fall since the 1960s, striking rock bottom"?

Does the *MDJ* honestly think that defending the First Amendment and religious liberty, as board members like **David Banks** and **Susan Thayer** seem inclined to do, is a "Neville Chamberlain approach?"

As board member **David Chastain** noted, in an earlier *MDJ* article, the crucial question may be "Why elementary students?" But that question applies equally to the Good News Club and to the proposed Satan club. As a wise friend suggested, maybe these groups should seek members at high schools instead. The Marietta High Blue Devils would be a good place to start.

## The hypocrisy of Hines should be of no concern to Smyrna police

In the Sunday July 31 edition, the Marietta Daily Journal reported that columnist Roger Hines took objection to the Smyrna Police appointing, as a matter of "best practices," a liaison officer to the LGBT community, someone responsible for "diversity training." It seems that Mr. Hines suffers from serious hypocrisy—not "seems," does— for we have his column as clear evidence of the fact.

Mr. Hines thinks that Mayor Max Bacon could direct his police to give advice about the IRS to churches, as well as to protect Smyrnans from the evil effect of pro-gay stances on the "children and youth." Mr Hines thinks that we should be a nation of laws and equal justice for all—but as he takes strong issue with the police liaising with a community or with them being treated with respect as merely "bowing to the god of diversity."

But—and this is where the strong hypocrisy of Mr. Hines is on full display—there is not a word in Hines' column about the special, substantial privileges long afforded the churches he now claims are being treated so poorly. Those conservative churches receive now—and have for decades both automatic social prestige and tax advantages available to no other groups. Those churches, as churches, pay not a dime for fire and police protection, paved roads, or towards the maintenance of the civilization that protects their views (rational or not). That protects them, please note, in the holding and expressing of opinions destructive to citizens elsewhere in the community and the nation.

The mayor of Smyrna has not sought my advice and is not likely to, but if he did, I'd urge him to recognize and learn about *all* groups in the Smyrna community, and to direct his police officers to continue to serve and protect *all* law-abiding citizens—even Mr. Hines and the preachers of conservative churches who don't pay their fair share.

## American Atheists: Trump's Pledge to Allow Church Politicking is a Disaster

In his acceptance speech at the Republican National Convention Thursday, July 21, Republican presidential nominee **Donald Trump** pledged to end the long-standing ban on churches engaging in political activities.

Since 1954, the so-called "Johnson Amendment" has banned political activity for churches, other houses of worship, and all other tax-exempt organizations. This requirement applies equally to religious and secular nonprofit organizations. Repealing this critical protection of our nation's secular character would fundamentally undermine the First Amendment's Establishment Clause and upend more than 60 years of law.

Pastors and religious leaders are free to endorse candidates and engage in politics—and frequently do. But we draw the line when it comes to taxpayer subsidized tax-exempt organizations climbing into the political arena.

Churches already flaunt the law and engage in politics from the pulpit while the IRS does nothing. Repealing this law would turn religious organizations into political ones. American Atheists opposes Mr.Trump's pledge.

## Action Alert: Commend Tennessee county commissioners for stopping land transfers to churches

The commissioners of a Tennessee county need to be thanked for stopping the giveaway of land to churches.

The Shelby County Board of Commissioners had repeatedly transferred land to churches for nominal sums under a Tennessee provision that permitted this for nonprofits. For example, the county conveyed eight parcels of land to Memphis' Kingdom Fellowship Baptist Church in 2012 and a further four parcels to the same church in 2015.

When FFRF informed Shelby County that it was violating both the U.S. and Tennessee Constitutions by its actions, county officials heeded FFRF's advice and suspended the land transfers for the time being. County commissioners need to be thanked for being willing to mend their ways, especially since they'll likely get blowback from the Religious Right.

## Staver's Switcheroo: Religious Right Attorney Who Said Satanic Clubs Have A Right To Meet In Schools Now Might Sue To Stop Them

In a predictable twist, a prominent Religious Right attorney who recently said after public school Satanic clubs have a "right to meet" is now threatening to sue if those clubs are actually allowed to form.

As we reported earlier this week, the Satanic Temple is seeking to create "After School Satan Clubs" in public schools in several states in response to the activities of local Good News Clubs.

The Satanic Temple is a humanist group that supports separation of church and state and rebellion against traditional religious dogma. Its proposed after-school sessions would emphasize things like critical thinking and science.

Good News Clubs, which also meet after school hours, are run by an outside organization, Child Evangelism Fellowship (CEF), which works aggressively to indoctrinate children into fundamentalist Christianity. CEF members believe that children as young as 5 are sinners who can make faith professions; they even use "wordless books" aimed at children who haven't yet learned to read.

Even though such clubs operate in public schools, the U.S. Supreme Court said back in 2001 that if public schools have a policy of allowing outside groups to use their space, they must treat all equally. This means that schools with these policies cannot exclude religious clubs, but it also means that schools cannot give them special treatment.

Initially, at least, it seems Liberty Counsel head Mat Staver didn't have a problem with the concept of After School Satan Clubs. Staver, who **represents** anti-gay Rowan County, Ky., Clerk Kim Davis, said just last month that there is no legal basis for preventing the clubs from meeting after school.

statement. "Schools do not have to tolerate groups which disrupt the school and target other legitimate clubs. No sane parents would consent to allow their child to attend this group. Full of sound and fury, this group will soon fade away."

It's nice to see that Staver knows some Shakespeare. And while it's difficult to say if any schools will take Liberty Counsel up on its offer, given Staver's own admission that Satan clubs have the right to meet, it seems unlikely that he will succeed.

The Religious Right fought hard to make sure Good News Clubs can meet in public schools. The tradeoff for that victory was the right to equal access—meaning if an evangelical Christian club can meet, a Satan club has that same right. It's all or nothing.

But as usual, the Religious Right wants it all while conceding nothing to its opponents. Sorry to break it to you, Mat, but that's not how this works. You pried open the door so the Good News Club could enter public schools. You shouldn't be surprised that others want to come in as well.

"I would definitely oppose after-school Satanic clubs, but they have a First Amendment right to meet," Staver said. "I suspect, in this particular case, I can't imagine there's going to be a lot of students participating in this. It's probably dust they're kicking up and is likely to fade away in the near future for lack of interest."

It seems this week things have changed in Staver's world. Now he's looking to sue, having offered his services for free to any school that receives a request to form a Satan club.

"The so-called Satanist group has nothing good to offer the students and its entire reason for existence is to be disruptive," Staver thundered in a media


