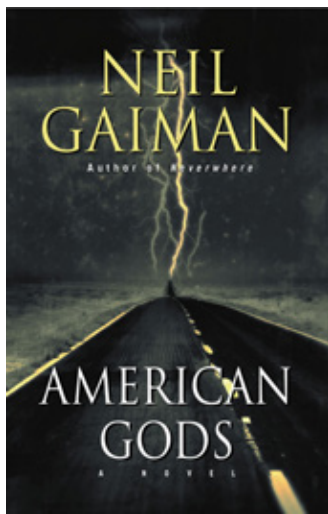

## FFRF alarmed about Tennessee high school

The Freedom From Religion Foundation is alarmed about multiple constitutional violations occurring in a Tennessee high school.

A Christian club called FISH meets every Friday during lunch at David Crockett High School in Jonesborough. An employee at the high school, Jerry Day, leads this group. Community church members frequently attend these meetings, and they bring fast food to entice students to attend. FISH meetings include Christian songs, prayers and other Christian content. Guest speakers from fourteen local churches often speak, as well. Teachers also reportedly participate, sometimes leading prayers with students. Under the federal Equal Access Act, religious clubs must be student-led with no involvement from school staff or outside adults.

Members of a Christian group called Young Life also frequently enter the school shortly before school starts in order to pass out fast food biscuits and proselytize to students. Part of Young Life's mission is "sharing the truth of God's love with adolescents." The school has apparently not vetted any of these visiting adults, but still permits them unsupervised among the students.

"It is a well-settled principle of jurisprudence that public schools may not advance, prefer, or promote religion," FFRF Senior Staff Attorney Rebecca Markert writes to Washington County Attorney Thomas Seeley. "It is unconstitutional for school staff to host, sponsor, lead or promote a Christian club, or to have outside adults come in during the school day to lead religious teachings."

Additionally, there is a bible verse displayed on the high school's website. The David Crockett Lady Softball team webpage includes the following: "Philippians 4:13 – I can do all things through him who gives me strength."

"The placement of a bible verse on the school's website is unconstitutional," Markert writes. "Courts have continually held that school districts may not display religious messages or iconography in public schools."

FFRF asks that the school district investigate these matters immediately and take appropriate action. Staff should be informed that school-sponsored religious activity violates the U.S. Constitution as well as the rights of the students and their parents. Furthermore, the school district must dissolve FISH, and dissociate David Crockett High School from Young Life. FFRF also requests that the district remove the bible verse from its website.

The Freedom From Religion Foundation is a nonprofit organization dedicated to the constitutional separation of state and church, with 24,000 members across the country, including more than 300 in Tennessee.

# Bitten By A Tiger: Huckabee Must Pay For Unauthorized Use Of Song

Former Arkansas governor and Religious Right favorite **Mike Huckabee** has not been having a good year.

Huckabee won the Iowa GOP caucus in 2008 and hoped to repeat that magic in 2016. But he ended up struggling for attention in a crowded field of Republican presidential candidates.

In an effort to gin up his far-right evangelical base, Huckabee traveled to Kentucky in September of 2015 for a campaign rally with **Kim Davis**, a clerk in Rowan County who became a folk hero to the Religious Right after she refused to issue marriage licenses to same-sex couples.

During the rally, Davis took the stage as the song “Eye of the Tiger,” a number-one hit from 1982 by the band Survivor, blared over loudspeakers. The song, which served as the theme for “Rocky III,” has become an anthem for underdogs everywhere.

The chorus goes: “It’s the eye of the tiger / It’s the thrill of the fight / Risin’ up to the challenge / Of our rival / And the last known survivor / Stalks his prey in the night / And he’s watching us all with the / Eye of the tiger.”

There was a slight problem, however: No one in Huckabee’s campaign thought to ask the members of Survivor for permission to use the song. **Frankie Sullivan**, the guitarist for the band and co-author of “Eye of the Tiger,” wasn’t pleased and made that known.

Huckabee decided on an unusual defense: His appearance with Davis, Huckabee’s attorneys argued, wasn’t really a campaign event, it was a “religious assembly” – so you see, Huckabee had a right under the First Amendment to use the song!

Nice try. Rude Music, the firm that owns the copyright for “Eye of the Tiger,” sued. An attorney for Rude Music pointed out that Huckabee had clearly listed the Davis rally as a campaign event.

The media certainly **treated it that way**. Davis, who had been in jail for her defiance, emerged to a cheering crowd. Serving as emcee of the event, Huckabee crowed, “If somebody needs to go to jail, I’m willing to go in her place!” Other GOP candidates were frozen out of the rally. Huckabee wanted Davis – and the limelight – all to himself.

The lawsuit over the use of the song was settled out of court. It recently **came to light** that Huckabee had to pony up \$25,000.

Here’s looking at you, Mike Huckabee.

And now for the coda: The Iowa caucuses were held on Feb. 1, 2016. U.S. Sen. **Ted Cruz** (R-Texas) was the winner with 27.6 percent. **Donald Trump** came in second with 24.3 percent. Huckabee captured a pathetic 1.8 percent of the vote. The next day, he dropped out of the race.

As for Davis, she has of late been trying to **claim victory** in her strange case, but the fact is, same-sex couples in Rowan County are being given wedding licenses and are getting married. Davis and her allies may try to spin it differently, but so far she has lost.

In a way, it’s ironic that Huckabee and Davis tried to co-opt that old rock anthem. “Eye of the Tiger” speaks of a heroic underdog who “Had the guts, got the glory” and “Went the distance.”

That hardly describes a pair of fundamentalist zealots who sought the power to use their rigid religion as a vehicle to discriminate against others and deny them their legal rights.



# The Times, They Are A'Changin': New Poll Shows Evangelical Voters Acknowledge Cultural Change – But Continue To Resist It

White evangelicals no longer believe that the United States is a Christian country, according to a [new Public Religion Research Institute \(PRRI\) survey](#). The survey, which was conducted in conjunction with the Brookings Institution, shows that 59 percent of white evangelicals believe that the country has moved away from its “Judeo-Christian” roots.

That’s a change from previous years. PRRI reports that in 2012, most white evangelicals still believed that America is now, and had always been, a Christian nation.

As Americans United has [explained repeatedly](#), the United States was not founded to be an officially Christian nation. But the insistence that it was – against all evidence – has been a hallmark of conservative evangelicals for decades.

PRRI’s overall results reveal significant evangelical discomfort with demographic change. Seventy percent of white evangelicals believe that America has changed for the worse since the 1950s. Another significant majority – 77 percent – say that discrimination against Christians in the United State matches the discrimination faced by minority religious groups, and 74 percent think Islamic values are incompatible with American values.

But there’s no evidence that evangelical voters intend to abandon the so-called “culture war.”

“No religious group is more likely to believe that it is important to keep fighting laws and cultural changes that go against their personal beliefs, regardless of prevailing public sentiment, than white evangelical Protestants,” the report states.

Fully 70 percent of white evangelicals agreed that it’s important to “fight cultural change” – even if their religious views aren’t held by most people. It won’t surprise many readers, then, to find out that the same report shows that three quarters of the same demographic share what PRRI terms an “authoritarian” orientation toward politics.

It’s important to view PRRI’s results with certain caveats in mind. The “evangelical” label means different things to different people; not all self-identified evangelicals belong to the Family Research Council or the American Family Association. Some do support marriage equality, access to contraception and other socially progressive values. Others may not support those issues but do oppose the Religious Right’s ongoing campaign to sanction discrimination in the name of religious freedom.

But data reliably shows that this demographic overall tends to affiliate with the Religious Right, and PRRI’s poll is therefore a useful look at the movement’s current mindset.

Though it’s tempting to applaud the

headline, most white evangelicals haven’t actually stopped believing in the sort of revisionist history promoted by figures like David Barton. They simply think the country strayed from its theocratic roots. It doesn’t appear to matter to them that this version of American history has been debunked multiple times – something we’ve covered repeatedly on this blog and in *Church & State*. They’re still committed to the idea that our country benefits from some unique divine mandate, evidence be damned.

Of course evangelicals have the right to believe whatever they wish about the country’s religious character – even if it’s wrong. But PRRI’s data tells us that this belief isn’t actually harmless. Instead, it correlates to nostalgia for a less-progressive America, a time when many people were legally second-class citizens. (How many African Americans, Latinos and Asians pine to return to the 1950s?) It also promotes xenophobia and prejudice toward other religions, like Islam.

And that could mean we’re in for troubling times. The United States is becoming more **ethnically** and **religiously** diverse every year. Most Americans welcome that pluralism. But the Religious Right seems determined to man the same old barricades.

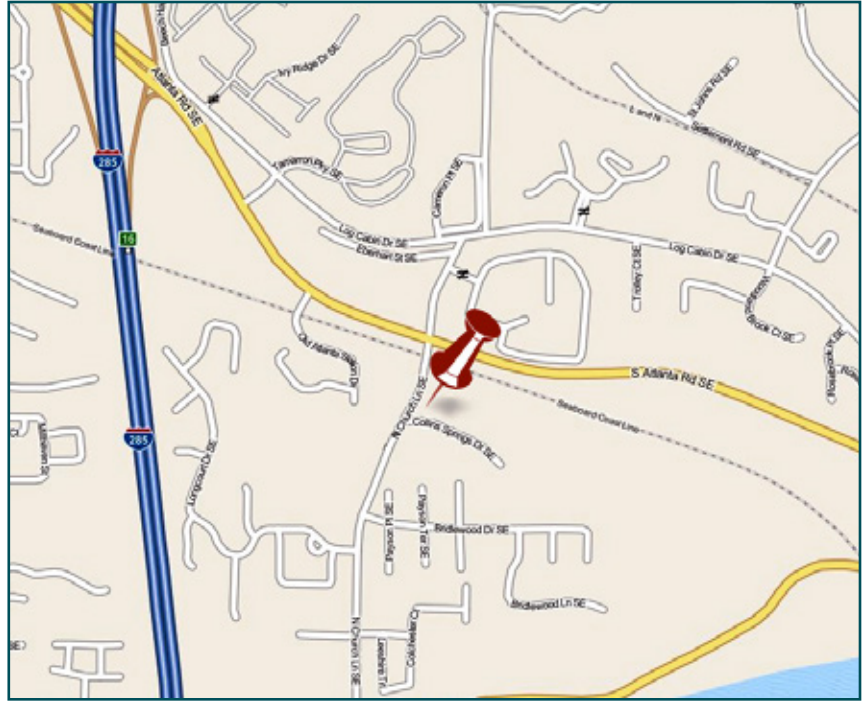
