Recently the [Georgia State Board of Education](#) mandated the teaching of national holidays to public school kindergartners, including Christmas, with the exclusion of other non-federal nationally celebrated religious holidays.

While it hasn't been kept a secret, it has been somewhat kept under the radar. However, some of the Georgia citizenry has paid attention to it as is indicated by [an article in Atlanta Jewish Times](#) by [Rabbi Steve Lebow of Temple Khol Emeth in Cobb County](#). There will usually be a very short semi-interactive sermon (5 – 10 minutes), a group discussion on the topic and then there will be time to socialize.

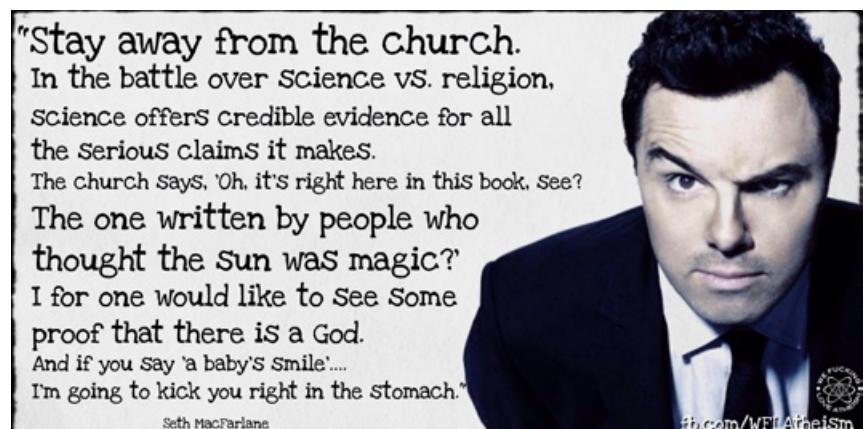

## Atheists Condemn Trump's Anti-Trans Military Policy

In response to a series of tweets from President **Donald Trump** declaring that trans military service members would be banned from serving “in any capacity in the U.S. military,” American Atheists President **David Silverman** released the following statement:

“The President is attacking trans members of our nation’s military, men and women who are already serving openly and bravely, as a way of shoring up his support among anti-equality religious bigots. This is a purely partisan decision that has no basis in fact or reality.

“Despite the President’s assertions, the Department of Defense and military leaders have affirmed that allowing transgender individuals to serve in the military has no impact on readiness and almost no added financial cost.

“That President Trump would expel thousands of dedicated, brave, and patriotic Americans who want to serve their country as a way to appease religious extremists speaks volumes. Using transgender service members as a political football is cruel and disgusting.

“Contrary to the President’s claim of ‘tremendous medical costs,’ the **RAND Corporation** estimated that allowing trans service members to receive gender transition-related health coverage would cost ‘between \$2.4 million and \$8.4 million annually, representing a 0.04- to 0.13-percent increase in active-component health care expenditures.’

“Gen. **Joseph Dunford**, the chairman of the Joint Chiefs of Staff, **said in June that there was no issue with currently serving transgender service members** and that their ability to continue to serve would not be impacted by any future changes to military policy. The President’s statement that transgender individuals would not be allowed to serve in any capacity is at odds with Gen. Dunford’s previous statement.”



## Atheists Issue Joint Statement Condemning Trump Administration for Lack of Outreach to Secular Community

On July 28, 2017, four national organizations representing atheists, agnostics, humanists, and secular Americans released statements condemning the Trump Administration’s lack of outreach to the nontheist community.

In March 2017, leaders representing **American Atheists**, the **American Humanist Association**, the **Center for Inquiry**, and the **Secular Coalition for America** sent a joint letter to the White House welcoming **Donald Trump** as the 45th President of the United States. The letter, made public for the first time today, urges President Trump to continue the Obama Administration’s policy of regularly engaging with the nontheistic community. In closing, the four signatory organizations urge President Trump to call upon them as a resource so they can work together to “ensure religious freedom and inclusion for all Americans throughout [his] tenure as President of the United States.”

After nearly five months, the White House has yet to respond to the letter or offer any formal recognition to the one-quarter of Americans who identify as nonreligious. Over the same time period, the Trump Administration has pursued a policy agenda that blatantly privileges religion and is overtly hostile to the separation of church and state. These actions include: issuing an Executive Order calling for the IRS to relax the ban on churches engaging in electoral politics, instituting a religiously-discriminatory travel ban, appointing an Attorney General who explicitly slandered secular Americans during his confirmation hearing, and, as recently as July 26, repeating a frequently used campaign talking point that implies patriotism requires belief in a God.

Because of these policies and continued incendiary rhetoric, the four signatories to the letter are again calling on the White House to meet with them and speak to the concerns of nonreligious Americans, the single largest “religious group” in the United States.

On Page 5 are statements by representatives from each of the nontheist organizations signed on to the letter.

## Statements by representatives from each of the nontheist organizations signed on to the letter to the Trump administration for lack of outreach to the secular community:

“This administration has continually appeased and kowtowed to the most extreme elements of the religious right. Their attacks on the foundation of the separation of church and state and their use of religious as a weapon against LGBT people, religious minorities, and women have confirmed our fears that the President would allow religious fundamentalists to drive the agenda in this White House. President Trump needs to realize that the tide has turned on religion in America. Our community is growing while the ranks of the extremists he has aligned himself with continue to shrink. Atheists demand equality, respect, and a seat at the table in American politics and we will fight at every step to secure those goals.”

## FFRF slaps Trump with lawsuit for legalizing church politicking

The Freedom From Religion Foundation (FFRF) today released a new ad, “You’re Sued!” challenging President Trump’s executive order to legalize church politicking, in violation of the *U.S. Constitution*.

“President Trump wants to convert churches into the next political super PACs, but he better check the Establishment Clause of the Constitution first,” said FFRF Co-President Annie Laurie Gaylor. “FFRF filed our lawsuit and launched this ad campaign to raise awareness of the dangers of church politicking.”

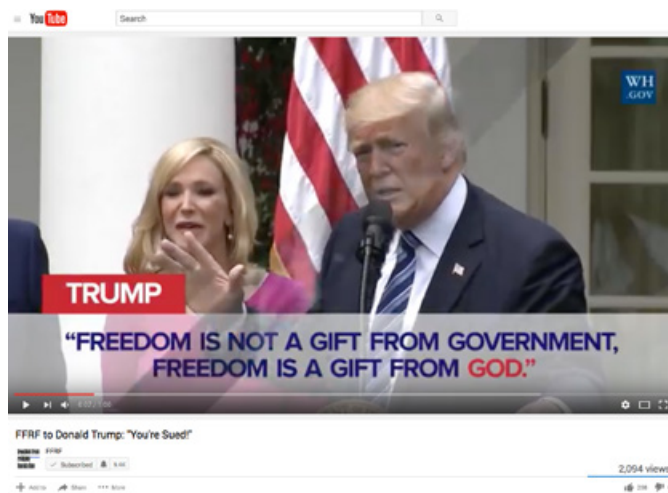
The ads will run on Facebook, Google and Instagram targeting secular Americans nationwide this month.

Trump signed his “Religious Liberty” executive order in early May with

great fanfare during a National Day of Prayer ceremony in the Rose Garden. FFRF filed suit shortly after in the U.S. District Court, Western District of Wisconsin.

FFRF’s suit argues that Trump has used his order to usher in a new era of church politicking, greenlighting endorsements from the pulpit and opening the door for dark money political spending. Meanwhile, the order discriminates against secular organizations such as FFRF, which must follow strict guidelines to maintain their 501(c)(3) tax status.

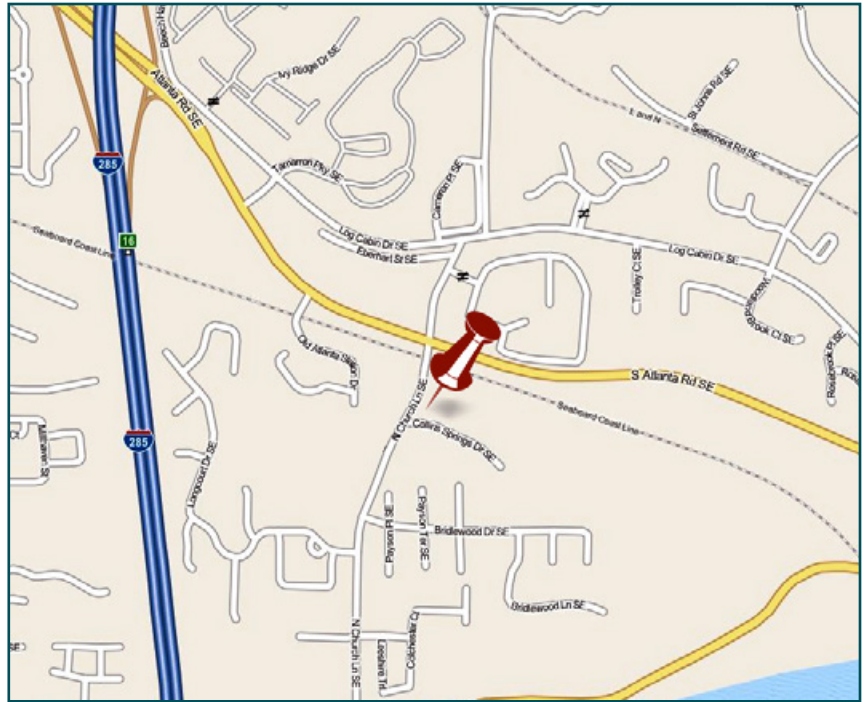
