On Sunday, January 8, Atlanta Freethought Society is fortunate to welcome investigative writer

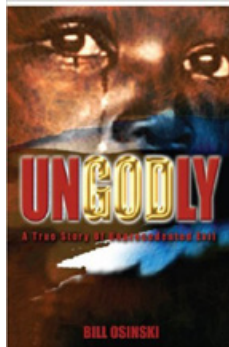

Bill Osinski, who wrote the book *Ungodly* about the tragic story of the Nuwaubians and their cult leader **Dwight "Malichi" York**, convicted in the largest child molestation case in the USA.

This is the strange, shameful story of how a street kid declared himself a god and was thus granted immunity for a long career of crime.

Dwight York, aka Imam Isa, Dr. Malachi Z. York, and Baba, among others, was so adept at playing the race and religion cards that, for 35 years he successfully trumped a series of politicians, prosecutors, police and school officials, academicians and journalists who might have, or should have, stopped him. So this is also the shameful story of how the fear of being politically incorrect, of being accused of practicing discrimination based on race and religion, silenced the majority and allowed the abuses to continue unabated, while young lives were destroyed.

To save court — ‘Time to roll up our sleeves and fight back’

The *Washington Post* had a chilling report on Christmas Day revealing that **Donald Trump** will inherit more than 100 judicial vacancies when he becomes president.

Even if Trump’s presidency is short-lived, the effects of decisions by Trump’s lifetime appointees could linger on for generations. These judges will decide on access to abortion and contraception, on immigration and voter rights, anti-discrimination policies, gun control — not to mention the ever-controversial principle of separation between state and church.

Since 2015 when they seized control of the Senate, Republican senators have obstructed **Obama** nominations. No floor votes were scheduled on 25 of Obama’s recent court nominees, even though they’d been approved out of committee with bipartisan support.



Then came the shameful, shameful decision by Majority Leader **Mitch McConnell** and Sen. **Charles Grassley**, chair of the Judiciary Committee, to ignore Obama’s nomination to replace the late Supreme Court Justice **Antonin Scalia**. Sen. **Patrick Leahy** of Vermont, the ranking

Democrat on the Judiciary Committee, has denounced the blocking of that solid and centrist nomination — **Merrick Garland**, chief justice of the U.S. Court of Appeals for the District of Columbia — as “the most outrageous act of obstruction and irresponsibility” witnessed in his 42 years in the Senate.

Despite the GOP stonewalling, Obama did manage 329 judicial appointments, naming more female, minority and gay or lesbian judges than any other president. Democrats currently make up 51 percent of circuit court judges. Unfortunately, according to the Brookings Institution, that is expected to drop to 43 percent by 2020 under Trump, while Republican appointees, currently about 34 percent of district judgeships, are projected to rise to about 50 percent. The Brookings Institution notes one silver lining: Many to-be-departing judges are Republican appointments, meaning Trump replacements may not significantly shift the balance of power. Also hopeful is the fact that the Senate tradition is to consider nominees only if supported by both senators from the nominee’s home state — and more than half the states are represented by at least one Democratic senator.

Meanwhile, here are some of the chilling possibilities deemed to be on the short list as Scalia’s replacement, according to NPR’s court-watcher **Nina Totenberg**:

- **William Pryor**, former attorney general of Alabama, who was appointed to the 11th Circuit by President **George W. Bush** while Congress was in recess. As Totenberg notes, “Judge Pryor is an outspoken critic of the Supreme Court’s decisions

on abortion, homosexuality and the so-called Miranda warning.”

- **Diane Sykes** of Wisconsin, an arch-conservative appointed by Bush to the 7th Circuit. Totenberg notes, “She authored an opinion expanding the rights of employers to limit their workers access to contraceptives on religious grounds . . . [and] mandating state subsidies for anti-gay religious groups on college campuses, a position subsequently reversed by the Supreme Court.”

- Judge **Raymond Gruender** of Missouri, who, Totenberg relates, “wrote a decision upholding state-mandated suicide warnings before abortions.”

The dismaying list of the remaining 21 Heritage Foundation and Federalist Society-stamped nominees goes on and on. But whomever Trump appoints to replace Scalia at least will not change the partisan balance on the Supreme Court, which was already a 5-4 swing to the Republican side.

Let’s toast the health of our elderly liberal justices on the highest bench!

And a toast to the opposition, such as South Carolina’s Democratic Party head **Jaime Harrison**, who won’t forget how the GOP treated Obama’s nomination and has urged: “It’s time to roll up our sleeves and fight back.”

It’s long past time, actually.

Will Donald Trump Give Some Late Gifts To The Religious Right?

It hasn't been a secret what members of the Religious Right sought under their Christmas trees this year, and voters playing the role of Santa Claus delivered: **Donald Trump** for president.

Even though his own advisors have indicated you can't take what Trump *says literally*, his voiced support for issues dear to the hearts of far-right evangelicals was enough for them to overlook the reality television star's three marriages, *permissive attitude on adultery* and boasts about *sexually assaulting women*.

Exit polling showed 81 percent of white, evangelical Christian voters cast their ballots for Trump.



Family Research Council President **Tony Perkins** noted the “bridge between Donald Trump and Christian conservatives” was the candidate's pledge to appoint conservative judges on the U.S. Supreme Court and other federal benches. (As *The Washington Post* reports this morning, *there are more than 100 vacancies on the federal bench*, meaning Trump is well poised to deliver on this promise.)

Perkins said other decisive issues included Trump's backing of efforts to allow businesses

to discriminate against LGBTQ citizens and his vow to repeal the Johnson Amendment, a provision in federal law that prohibits non-profits, including houses of worship, from endorsing or opposing political candidates.

Perkins *was involved* in developing the Republican Party's 2016 platform, which espoused conservative social priorities. It echoed Trump in supporting another issue of concern to Americans United: the expansion of private school voucher plans that would direct tax dollars to religious schools.

Trump also had an “evangelical advisory board” full of far-right voices willing to overlook the candidate's less-than-righteous past in exchange for a potential ally in the White House.

Some of those *advisors* included:

James Dobson, founder of the Family Research Council, Focus on the Family and Family Talk, who *referenced the election* as a “single-issue” race revolving around the appointment of at least one Supreme Court justice. He called Trump's list of proposed conservative justices “stellar” and also was encouraged by Trump's running mate selection of Indiana Gov. **Mike Pence**, who has deep ties to the Religious Right.

Jerry Falwell Jr., president of the fundamentalist Liberty University, was one of Trump's early Religious Right endorsers. “In my opinion, Donald Trump lives a life of loving and helping others as Jesus taught in the great commandment,” *Falwell said* as he introduced Trump at the Virginia university in January 2015. After the election, Falwell said he was *offered but declined* the role of secretary of the U.S. Department of Education.

Ralph Reed, founder and chairman of the Faith & Freedom Coalition, *told The Washington Post* that “people of faith are voting on issues like who will protect unborn life, defend religious freedom, grow the economy, appoint conservative judges and oppose the Iran nuclear deal.” He added that the taped

conversation featuring Trump's comments about groping women ranked “pretty low on [evangelical voters'] hierarchy of their concerns.”

Apparently, those same voters' concerns have changed since 1998, when Reed, then running the Christian Coalition, referenced then-President **Bill Clinton** to *The New York Times*: “We care about the conduct of our leaders, and we will not rest until we have leaders of good moral character.”

It remains to be seen whether Trump will try to fulfill his promises, or if this is a gift Christian conservatives will wish they could exchange. I suspect the former. Trump doesn't have to sincerely believe in the Religious Right's agenda to attempt to deliver on it, and since he wants the Religious Right's ongoing support, why wouldn't he try to keep its leaders and members happy? Trump is already doing that. Just look at his cabinet appointees.

One thing's for sure: Americans United will have its hands full next year. We're going to need your help, so if you're not a card-carrying member, *now is the time to sign up*.

Frank R. Wolf International Religious Freedom Act Signed into Law

(Washington, DC, Dec. 19, 2016)—President Obama has signed H.R. 1150, the Frank R. Wolf International Religious Freedom Act, the *first piece of legislation* to specifically mention and include protection for “non-theists,” into law.

Upon learning of the Act's passage, American Humanist Association Executive Director Roy Speckhardt said, “The American Humanist Association is proud to see this historic legislation signed into law and looks forward to working with the US Department of State to ensure religious liberty for non-theists and religious minorities abroad. That non-theists are now recognized as a protected class is a significant step toward full acceptance and inclusion for non-religious individuals, who are still far too often stigmatized and persecuted around the world.”

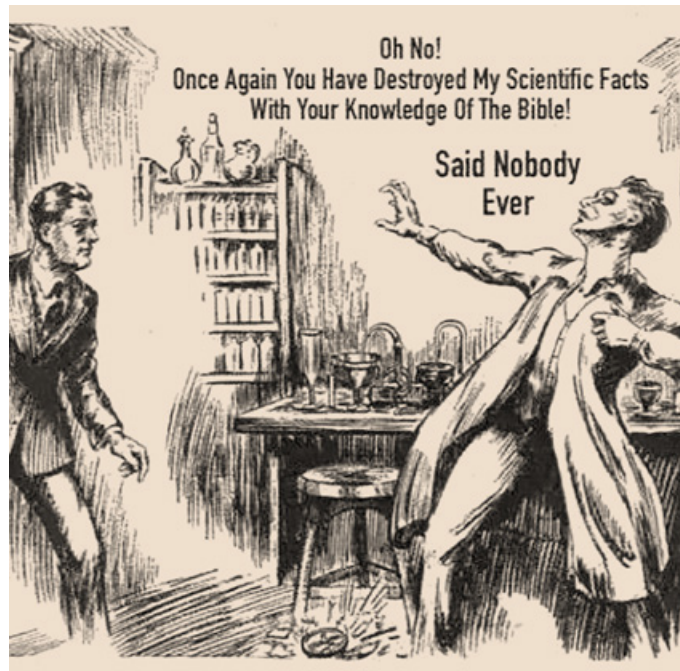

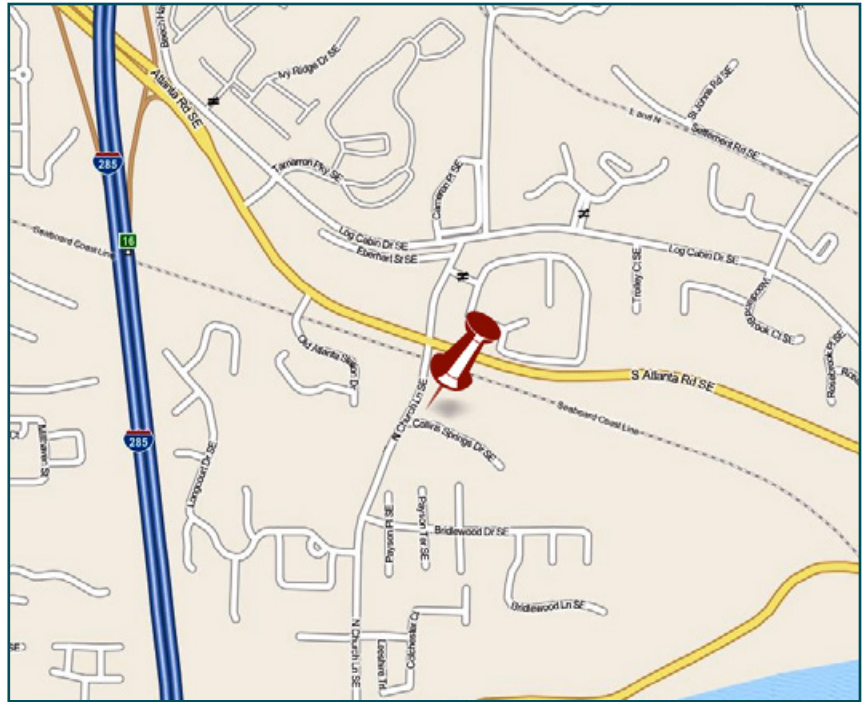
