

## The October AFS Meeting Dennis Martin - “Freethinkers’ BFFs”

Our program for October 8th will be by **Dr. Dennis Martin** on the topic of “*Freethinkers’ BFFs: Inconsistency & Impossibility.*”

When you see or hear an inconsistency and point it out, what happens? Try it a few times before coming to this talk. How do people react?

In this talk, Dr. Martin will discuss the deeper role that detecting inconsistencies plays in freethought and scientific thought. The importance of the relationship between inconsistency and impossibility will be discussed with a defense against its detractors. Finally, Dr. Martin will make

some suggestions on how freethinkers should deal with inconsistent statements. Topics also include multiverses, Gödel’s proof of God, superposition, alternate logics, and the agnosticism-atheism link.

From Dennis: “I was concerned that some so-called atheists or skeptics who I otherwise greatly respect – Victor Stenger, Jerry Coyne, and Michael Shermer, among others – say that God might ‘possibly’ exist. This led me to examine how logicians, mathematicians, scientists, and philosophers use these terms – consistency, possibility, probability, etc. I think the AFS group will be interested in my musings, and I am interested in hearing from audience members.” In his usual informal style, Dennis will engage the audience and seek their insights on these topics.

Dr Dennis Martin is a 15-year member of AFS. He is a retired philosophy professor who lives in metro Atlanta. Dennis has a mathematics degree from Georgia Tech and a PhD in philosophy from Emory. Dennis has spoken at AFS on eight previous occasions, in addition to teaching a 6-week course on secular humanism at AFS in 2010. Dennis notes, “I always try to bring some original thinking to AFS in my talks, and I admire the clear-thinking, important comments that AFS members bring.”

## Help Nonbelief Relief help Puerto Rico & other disaster victims

**Nonbelief Relief**, a humanitarian agency created by the board of the Freedom From Religion Foundation, is wiring \$10,000 today in the name of nonbelievers to a Puerto Rican disaster relief group.

The nonprofit **ConPRmetidos** partners with the **Foundation for Puerto Rico**, a 501(c)(3) organization.

Hurricane Maria has taken the U.S. island's entire power grid offline, slowing down the disbursement of the grant. Only as of September 27 has Nonbelief Relief been able to make direct connection with the development agency.

Calling the crisis in Puerto Rico a humanitarian emergency, Nonbelief Relief will continue raising money to aid the U.S. territory.

Adding to the major gifts it announced last week totaling \$98,000, Nonbelief Relief additionally has bestowed a \$10,000 gift to a well-organized relief group formed by former military members. Founded in 2010, **Team Rubicon** sends out 48,000 volunteer military veterans as first responders who go out like a "rapid response team" in cases of natural disasters. So far, the vets have alleviated suffering in more than 200 disasters across the United States and the world. A quarter of the military and veterans today are nonbelievers.

community for the **2012 Reason Rally** in Washington, DC.

"It means so much for AAoA to present me with the Dawkins Award," said Silverman. "Our community is strongest when we stand together and this is another example of the progress we have made to set aside the differences of the past and work toward the common goals of a society that is more accepting of atheists and less tolerant of religious privilege."

"Atheist activism has come a long way in the years since David started his work," said **Mark W. Gura**, vice president of Atheist Alliance of America. "So much of that progress can be directly attributed to his outspokenness and his work at American Atheists.

"We're proud to recognize David with this award," added Atheist Alliance of America's executive director, **CW Brown**. "I wouldn't be standing here today without David's work. His outspokenness inspires people to become activists."

# Forced Patriotism: You Don't Have To Stand For It

Last week, as Puerto Rico and other American territories were reeling from the aftermath of Hurricane Maria, President **Donald J. Trump** had other things on his mind – primarily professional football players who chose to “take a knee” during the playing of the National Anthem.

As usual, Trump kicked things off with an obligatory string of **tweets**. He then ramped up the rhetoric in other forums.

“Wouldn't you love to see one of these NFL owners, when somebody disrespects our flag, to say, ‘Get that son of a b\*tch off the field right now, out, he's fired? He's fired,’” **Trump said at a Sept. 23 rally**, referencing pro football players who have been kneeling during the anthem to protest racial injustice. “You know, some owner is going to do that. He's going

to say, ‘That guy that disrespects our flag, he's fired.’ And that owner, they don't know it [but] they'll be the most popular person in this country.”

Trump's rhetoric stands in contrast with the words of the U.S. Constitution. Under the First Amendment, people can't be compelled to stand for patriotic or religious ceremonies if they don't want to. That includes the National Anthem. Obviously, the NFL is not bound by the First Amendment, but, as

President, it is disappointing that Trump does not appear to value freedom of speech.

Trump also fails to grasp what's going on here: This started as a protest over racial injustice, not the anthem itself. In that sense, the protests were not unpatriotic – but even if they were, it would not matter. It's a violation of basic rights to compel someone to participate in a patriotic ritual.

Nevertheless, some of Trump's most prominent supporters, **including former White House chief strategist Steve Bannon**, have praised his comments.

“If people in this country take a knee and the National Football League players want to take a knee, they should take a knee at night, every night, and thank God in heaven Donald J. Trump is president of the United States,” Bannon told Fox News in a Sept. 25 interview. “He has saved this country so much grief. He has done such a tremendous job with virtually no help.”

Trump, Bannon and many of their backers are abysmally ignorant of the history of this issue. Americans have the right to decide if they will take part in patriotic rituals thanks to a 1943 church-state case called ***West Virginia State Board of Education v. Barnette***.

The *Barnette* case occurred in the public school context and concerned the Pledge of Allegiance, not the National Anthem – but the general principles laid down in the decision are clearly applicable here.

Many states used to have laws requiring public school students to

salute the flag and recite the Pledge of Allegiance every morning. Jehovah's Witnesses argued that their only allegiance was to God and instructed their children not to take part. Witnesses' children were expelled from some public schools, and the matter entered the courts.

In 1940, the Supreme Court actually upheld mandatory participation in the flag ritual in public schools in a case from Pennsylvania titled ***Minersville School District v. Gobitis***. But just three years later, the high court took up the matter again and ruled the other way in *Barnette*.

The ruling contains this eloquent and often-quoted passage by Justice **Robert H. Jackson**: “If there is any fixed star in our constitutional constellation, it is that no official, high or petty, can prescribe what shall be orthodox in politics, nationalism, religion, or other matters of opinion or force citizens to confess by word or act their faith therein.”

Why did the court reverse itself so quickly? In part because many Jehovah's Witnesses were **attacked in the interim**. (There had also been some changes among personnel on the court.)

Although NFL players are not objecting to the anthem for religious reasons as students in the *Gobitis* and *Barnette* cases did, *Barnette* laid down a powerful rule: If participation in a patriotic ritual clashes with the right of conscience, the latter takes precedence.

So, as week four of the NFL season kicks off tonight, players can, when the National Anthem is played, take a knee, lock arms or stand. It's their constitutional right to choose as they please.

Thanks to the *Barnette* church-state case, we all have that right – and we should be thankful for it.



# Most Americans Believe Religion Is No Excuse To Discriminate Against The LGBTQ Community

A recent survey by the **Public Religion Research Institute (PRRI)** revealed that at 53%, the majority of Americans oppose restricting the rights of the LGBTQ community. An even more promising finding for America's future: About two-thirds of young adults believe wedding-based businesses should not be allowed to refuse services to same-sex couples on religious grounds.

The commitment of American youth to equality was demonstrated this month when **Biolans' Equal Ground**, a Christian LGBTQ student group at Biola University, penned a letter of opposition to the Christian university's president after multiple Biola professors signed the "**Nashville Statement**."

Signed in August by Religious Right leaders, the Nashville Statement proclaimed signers' views on human sexuality and gender identity, including the view that they "DENY that adopting a homosexual or transgender self-conception is consistent with God's holy purposes in creation and redemption."

But many, including Christians, are pushing back against this divisive view and any attempts to translate it into public policy. As AU's Faith Organizer **Bill Mefford** noted: "All people have the right to practice their religious beliefs – or to practice no religious belief at all – so long as their practice does not cause harm or discriminate against others."

Biola students also are standing up and asking their university to maintain a supportive environment for all students: "Your silence on this is sending a confusing and damaging message to both LGBTQ students who are affirming as well as to those who have chosen celibacy," they wrote **in the letter published in the *Huffington Post***.

Youth activism like this is extremely important in shaping the debate about true religious freedom. These current and former students recognized that religious freedom is about fairness, not discriminating against others based on belief, so they did something about it and made their voices be heard.

Thankfully, the vast majority of Americans agree with them. According to the PRRI poll, 56% of Americans oppose allowing small business owners to use their religion as an excuse to deny service to LGBTQ people, while 72% of Americans support non-discrimination laws that protect LGBTQ people.

Ensuring that religion is not being used to harm people or take away their rights is why Americans United started the **Protect Thy Neighbor** campaign. We're assisted by **Faith Leaders United**, a network of religious leaders; if you are a member of the clergy, you can **get involved**.

Stopping religion from being used as an excuse to discriminate is also why we're involved in a pending U.S. Supreme Court case, **Masterpiece Cakeshop v. Colorado Civil Rights Commission**, which could have huge implications for religious freedom. This case involves a Colorado bakery that is using religion as an excuse to discriminate against same-sex couples by refusing to bake them wedding cakes. Americans United will file a legal brief telling the Supreme Court that the First Amendment does not excuse businesses from their obligation to treat all customers equally – even when the desire to discriminate is motivated by religion.

## On the Trump Administration's Plan to End DACA

In response to the Trump administration's announcement that it would suspend the Deferred Action for Childhood Arrivals (DACA) program, American Atheists president **David Silverman** released the following statement:

"This is a difficult time for the more-than 800,000 people who have been helped by DACA.

"As atheists, we know that it is only through human action that the lives of those in our community can be improved. There is no question that DACA has improved the lives of the men and women brought to our nation as children and, indeed, strengthened our communities.

"This is about more than politics. This is about recognizing our shared humanity and celebrating the contributions made by all Americans, including those brought here as children. Just as our nation is made stronger by the diversity of religious views of its citizens, it is made stronger by its immigrants.

"I have no doubt that countless DACA recipients were brought to our

nation because of our commitment to religious freedom, religious equality, and government neutrality. I fight to protect those commitments and I will fight to protect those who come to the United States in search of them. Just as atheists are your friends, neighbors, and classmates, DACA recipients are as well. This is an issue that impacts us all.

"I call on President Trump and Congress to act quickly to pass legislation that recognizes the shared humanity of these young people who are as much a part of our community as you or me. Threatening almost a million people with deportation does not make our nation stronger and is fundamentally at odds with our constitution's promise of a more perfect union."

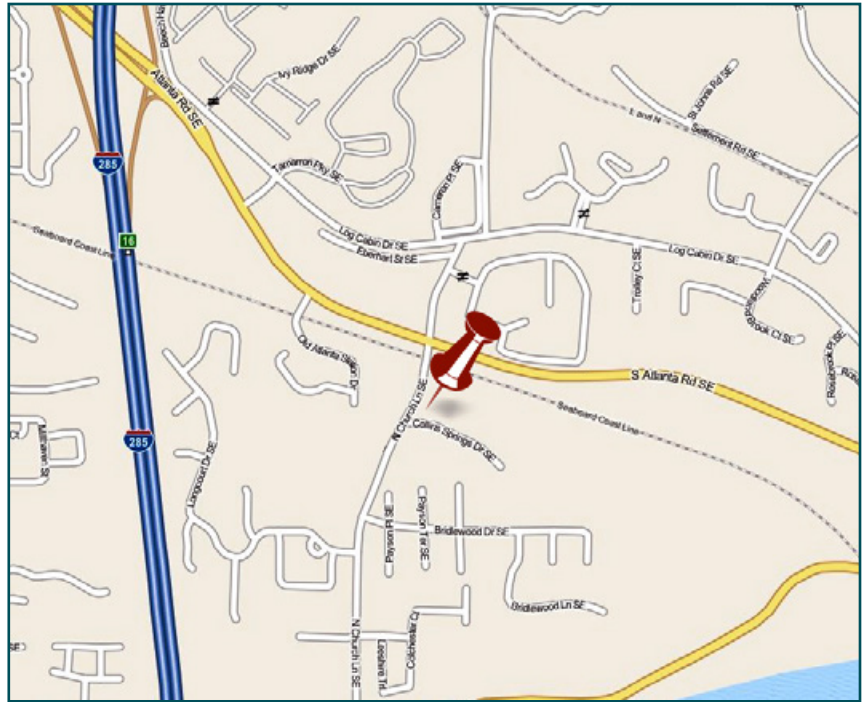
