Ed Buckner & Amjad Taufique “The Problem With Religion”

The September meeting of the Atlanta Freethought Society will center on a discussion of “Religion, Violence, and Religious Liberty” led by our own **Ed Buckner** and by **Amjad Taufique**, a Muslim leader who has been identified as one of the [100 Most Influential Muslims in Georgia](#). Each of them will offer a brief few minutes of talk on the subject, and this will be followed by questions from members and discussion. Amjad Taufique, a leader for the West Cobb Mosque, is a Cobb County resident who has lived in the US for 47 years and whose children were all born here. He has worked with a variety of leaders of different religious groups, including Christian, Jewish, and Unitarians, to encourage peace and denounce violence.

The commenter **Nixons_BACK** on Reddit **wrote about the post 9/11 world**: The US had such a preponderance of power pre 9-11 that we were the hegemon. No combination of actors could beat us. And no would would dare to attack the US because as a rational actor they would realize that they could not possibly win. We were as safe as any actor could ever wish to be. Or so we thought. 9-11 showed us that actors who could not be tied to a specific state could attack us and cause significant harm because there is no threat of retaliation. Terrorists don't have a country or a base we can bomb or take over, so all of our military might does us no good. Atheists Reach \$41,000 Settlement with Tennessee County Sheriff

Chattanooga, TN—American Atheists and Bradley County and the Bradley County Sheriff's Office have reached a settlement in a federal lawsuit alleging First Amendment violations of the U.S. Constitution by Bradley County and Bradley County Sheriff **Eric Watson**.

As part of settlement agreement, the new official Bradley County Sheriff's Department Facebook page will not be used to "promote or further any religion, religious organization, religious event or religious belief." Additionally, the sheriff's office has decided to not allow any comments on this Facebook page, making it an informational Facebook page only. The office's original Facebook page was deactivated earlier this year and will be permanently deactivated.

While the county and sheriff admit to no wrongdoing under the agreement, the county will pay a total of \$15,000 in damages to American Atheists and the local plaintiffs, **Joshua Stevens and Jane Doe**, and \$26,000 in attorney's fees. Plaintiffs were represented by attorney **Perry Craft** of Nashville.

"This settlement is a clear win for the plaintiffs, whose First Amendment rights to free speech and to be free of government establishment of religion were infringed upon," said **Amanda Knief**, National Legal and Public Policy Director of American Atheists. "We are pleased the sheriff has agreed to do the right thing by no longer using this official government social media account to promote religion."

"What is unfortunate, is that it took a lawsuit and more than \$40,000 in taxpayer money for the county and sheriff to put this common sense policy in place," Knief said. "We would have preferred that the sheriff allow citizens the freedom to comment and interact with the sheriff's office on the Facebook page, but we were not able to reach agreement on that during mediation."

The anonymous Bradley County resident represented by American Atheists added, "I have always said that Constitutional rights are worth fighting for, and I am proud that when tested, I stood by that principle. It was not easy to stand up to the county sheriff and some people in my community who disagreed with me. Despite some negative backlash, I do not regret taking action against government censorship. If you don't stand up for yourself, you risk losing your rights."

Sheriff Watson will be allowed to maintain a personal Facebook page that is clearly marked as containing only his personal opinions and not those of the department.

The lawsuit arose in May after Sheriff Watson posted an explicitly religious Easter message on the sheriff's office's official Facebook page. American Atheists sent a letter to the sheriff advising against such religious messages on a government-sponsored social media site. The sheriff responded by telling a local newspaper that he intended to use his position as sheriff to proselytize. After posting the local newspaper article on the sheriff's office's Facebook page, commenters began criticizing the sheriff's statements. The sheriff and employees of the sheriff's department began deleting and blocking critical comments and users who were critical of the sheriff while leaving favorable comments on the governmental Facebook page.

Nonbelievers grant \$10,000 to flooded public school district

A freethought charity is providing financial assistance to a flood-hit Louisiana public school district.

Nonbelief Relief, which functions as the charitable arm of the Freedom From Religion Foundation, has just donated \$10,000 in flood relief to the Livingston Parish Public Schools. The group, which represents nonbelieving donors nationwide, has asked that it be used for the repair or rebuilding of public school infrastructure or buses.

NonBelief Relief, Inc., is a humanitarian agency for atheists, agnostics, freethinkers and their supporters "to improve this world, our only world," says its administrator, **Annie Laurie Gaylor**, who also serves as co-president of FFRF.

On the same day \$10,000 was funneled to help the Livingston public school district, which suffered loss of many school buses and other major flooding damage, Gaylor also sent a polite but pointed letter to Superintendent **Rick Wentzel**.

The letter says, "It has come to our attention that the parish public schools website has a banner message reading in part, 'Praying for all of our Livingston Parish people – Superintendent Rick Wentzel.'" FFRF, extending "sincerest sympathies for the tragedy facing the school district" and greater area, notes that the school district has an obligation to concentrate on secular, not religious, needs.

"A famous freethinker of the 19th century, Robert Green Ingersoll, once wrote, 'The hands that help are better far than lips that pray,'" Gaylor adds. "To that end, Nonbelief Relief is very pleased to provide the practical assistance of \$10,000 in flood relief to the Livingston Parish Public Schools."

"We have a saying around our office: Nothing fails like prayer. We humans need to join together to make this a better world, to get off our knees and get to work," she further states.

Nonbelief Relief seeks to remediate conditions of human suffering and injustice on a global scale, whether the result of natural disasters, human actions or adherence to religious dogma. Such relief is not limited to but includes assistance for individuals targeted for nonbelief, secular activism or blasphemy.

In other action this month, Nonbelief Relief voted to give a \$5,000 stipend to a major Bangladesh atheist author whose life is under threat, and is holding stipends in reserve for two other endangered bloggers. The charity this year has now spent about \$50,000 in grants to individuals whose lives have been imperiled because of public atheist activism.

Humanist Groups Collaborate to Promote International Volunteering

The American Humanist Association is a proud 2016-2017 program sponsor of Foundation Beyond Belief's Humanist Service Corps, a one-of-a-kind initiative that promotes international volunteering guided by humanist principles. "Foundation Beyond Belief is grateful to the American Humanist Association for supporting the Humanist Service Corps," said **Noelle George**, executive director of Foundation Beyond Belief. "HSC's culturally responsible support of human rights organizations is an embodiment of humanist principles, which makes it an important opportunity for the individuals represented by the AHA and a visible symbol of the good that can be done without belief in any gods."

In 2013, Foundation Beyond Belief instituted Pathfinders Project to establish a humanist service corps that would give volunteers the opportunity to put their humanist values into action by working internationally with well-established nonprofit organizations. Michele Bachmann Says God Chose Donald Trump To Win GOP Nomination

Four years after running unsuccessfully for president, former U.S. Rep. **Michele Bachmann** (R-Minn.) is back in the news cycle in yet another election year – this time for saying that God chose **Donald Trump** to become the Republican presidential nominee.

“God raised up, I believe, Donald Trump who was going to be the nominee in this election,”

Bachmann **told CBN**, a conservative Christian network owned by TV preacher **Pat Robertson**, in an interview released Tuesday. “I don’t think God sits things out. He’s a sovereign God. Donald Trump became our nominee. I think it’s very likely that in the day that we live in, that Donald Trump is the only individual who could win in a general election of the 17 who ran.”

Bachmann, who’s currently an advisor on **Trump’s Evangelical Executive Advisory Board**, a group of right-wing evangelicals who back Trump, continues her streak of taking far Religious Right positions. She’s previously taken stances against LGBTQ+ rights and feminism and promoted Islamophobia.

“Maybe I’m wrong, I don’t know, but I do know that the Bible is true and that Daniel teaches the most high God, which is one of God’s names, is the one who lifts up who he will and takes down who he will,” Bachmann **continued**. “And so that’s why my prayers and my actions and my work on a daily basis is to make sure that Donald Trump becomes President Trump the first Tuesday of November this 2016.”

Bachmann is certainly entitled to believe that God, for whatever reason, is using a thrice-married nominal Presbyterian who has bragged about his affairs with married women as his instrument. The problem is, Bachmann couldn’t stop at trumpeting The Donald; she had to question the spiritual commitment of politicians who oppose him.

She cast doubt on President **Barack Obama’s** commitment to Christianity and inquired whether Democratic nominee **Hillary Clinton** is even a woman of faith – despite the fact that Obama has

been a member of the United Church of Christ for years, and Clinton has long been a Methodist. (Perhaps those denominations don’t count as “Christian” in Bachmann’s book, but most Americans would see them that way.)

“If you look at Barack Obama, by contrast, if you look at Hillary Clinton, by contrast, tell me where the strong people of orthodox Christian faith or orthodox Jewish faith who believe that the Bible is true, who believe that God is who He says who He is ... I don’t know of any. Maybe [Clinton] has some, but I don’t know of any,” Bachmann rambled on.



Not only did she narrow America’s religious demographic to people “who believe that the Bible is true,” but her criticism of how religious Obama and Clinton are goes back to a point Americans United’s Executive Director **Barry Lynn** wrote in an **op-ed** this month.

“A politician’s religious views have little or nothing to do with how he or she does the job,” Lynn wrote. He added that it only becomes an issue when far-right fundamentalists like **Kim Davis** become convinced that their faith gives them the right to refuse to do the jobs they were elected to do.

Instead of promoting her narrow version of Christianity as a qualifier for president, Bachmann would do better to look inwardly. It’s time for Bachmann and other Religious Right leaders to admit an uncomfortable truth: They’re willing to back any candidate who proclaims support for their right-wing political agenda, even if he has virtually no fealty to the faith they claim to treasure.

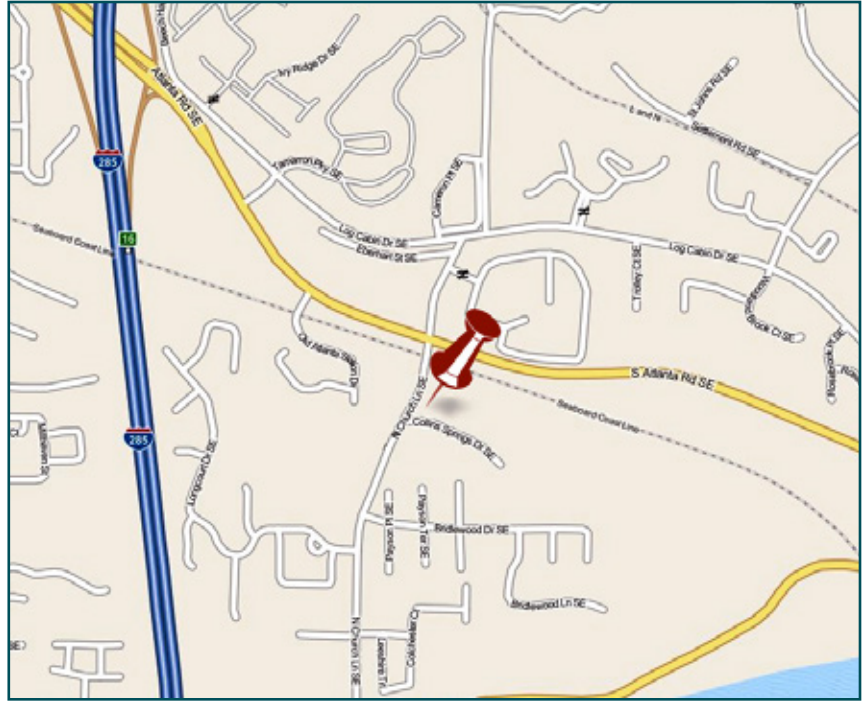
