Eli got to know Dr. Charles Stanley on a personal basis and even had dinner with Jerry Falwell in his home.

But, having been disillusioned with the ugly side of televangelism and politics in the ministry, Eli converted to a more liturgical form of Christianity and was tonsured an acolyte. Eli also drifted through several progressive Christian traditions and even socialized with Bishop John Spong and Marcus Borg from the Jesus Seminar.

But, after reading Nietzsche, Robert Ingersoll, Charles Templeton, Anton LaVey, and Marjoe Gortner's biography, Eli knew he was done with Christianity for good. Eli's spiritual and intellectual journey is candid, emotional, and unique because he was so fearless and charismatic about his faith.

Eli has been an "out of the closet" agnostic for about five years and works as an Engineer at CNN in Atlanta.

The wall between state and church is under assault as perhaps never before, FFRF contends. All of us should strive to ensure that religion and government are separated from each other, as our Founders envisioned.



Fallacy of the Month Illegitimate Appeal to Authority

This is the seventh in a monthly series discussing the kinds of faulty reasoning that you are likely to run across in everyday discussions and debates. Atlanta Freethought Society's mission includes teaching how to avoid faulty reasoning so that your thoughts are free from mistaken reasoning and unsupported authoritative claims.



No one can be an expert in every subjectmatter. We have to trust someone or some source of knowledge as we go through life. So-called knowledge is 'authored' or expressed by someone or some group as purported authorities. Since we assume that there is a difference between true and false statements, we also assume there are

legitimate and illegitimate authorities. Criteria can be established for specific areas of expertise. An illegitimate authority would then be someone who didn't meet the criteria in that field. Sometimes this fallacy is simply called "appeal to authority", which is incorrect and why the word "Illegitimate" is important in the name. The **Illegitimate Appeal to Authority** fallacy occurs in a number of ways.

Appeal to a Saying or Proverb is illegitimate, because the authority in this case can't respond to questions of more evidence. Citing religious Scripture falls into this category. A saying might be proven by modern scientific experiments, but then its authority doesn't rest in the saying itself, but in the evidence behind the saying.

An **Out of Date Authority** is citing someone who used to be an authority but is no longer. This can happen in fields of knowledge that have changed slowly but drastically, such as geography – you wouldn't want to cite ancient Egyptians. Or it can happen in fields that change quickly – you wouldn't want **Alan Turing** to show you how to use a cell phone. Some fields don't progress in a cumulative way (one expert building upon prior expertise) – such as literary criticism – so citing 'older' authorities remains relevant and legitimate

An authority is illegitimate if testifying **Outside Their Field of Exper-tise.** This is the version of fallacy that most critical thinkers can recognize immediately. A spokesperson appears on TV who you vaguely recognize as being an authority on something, so you pay attention to what they are saying. Later you realize they were just an authority on some TV drama, or they are an authority on a completely different topic.

Often an authority is **Not Clearly Identified.** "They say," "I heard," "A recent study reports" are examples of vague references. References can also be made to organizations which are fancy-sounding but non-existent.

Sometimes people claim to be authorities on subjects that are **Not a Matter for Expertise.** The subject of love comes to mind. Simply being able to recite everything ever written on a subject is not necessarily expertise. An 'authority' ought to be able to squeeze out and 'author' new information from their knowledge of the subject. Otherwise, why do we need their authority? Just trust the authorities that they claim to know.

Finally, freethought in the tradition of **Ingersoll** espouses a healthy skepticism of all authority. Freethought doesn't reject authority. It relishes expertise in knowledge. What freethought rejects is authoritative claims which are unsupported by factual evidence that can be tested.



Those of us without any god-beliefs have lives as full of love and meaning as those who're sure meaning must be imposed. Historically, concluding that meaning has to have external origins just plays into the hands of people eager to have power over others.

Stephen Hawking's conclusion beats Bill Tinsley's: faith "is a fairy story for people afraid of the dark."

Trump Administration Launches Task Force To Aid In Using Religion To Discriminate

Attorney General **Jeff Sessions** announced the formation of a "Religious Liberty Task Force" to enforce the Department of Justice (DOJ) guidance he issued last fall that would allow religion to be used to discriminate.

The announcement came during a **Religious Liberty Summit** on July 30 - an event that was replete with religion and representatives of organizations that strive to undermine the separation of church and state.

"Americans from a wide variety of backgrounds are concerned about what this changing cultural climate means for the future of religious liberty in his country," Sessions said. "President Trump heard this concern. I believe this unease is one reason that he was elected. In substance, he said he respected people of faith and promised to protect them in the free exercise of their faith."

What Sessions really means is that the Trump administration is committed to an agenda of preserving the power of the Christian fundamentalists who carried Trump into office and who want to use their religious beliefs as justification to discriminate against women, LGBTQ people, religious minorities and anyone else who doesn't conform with their narrow vision of Christianity.

The new task force is the Trump administration's most recent step to undermine people's rights in the name of religious freedom. Sessions charged the task force with implementing his infamous guidance on religious liberty, which is a blueprint for using religion to discriminate. AU Legislative Director **Maggie Garrett previously described** some of the harmful outcomes that could result from the guidance:

- People and corporations could cite religion to ignore nondiscrimination laws that protect women and LGBTQ people.
- Taxpayer-funded organizations could use religion to justify discriminating against the employees they hire and the people they serve, even if it conflicts with the terms of their government grant or contract.
- The government could give religious exemptions to businesses and government employees, even if the result meant taking away a right or benefit the law guarantees to someone else.

In other words, the guidance would allow people, businesses and taxpayerfunded organizations to use religion as a trump card to almost any law.

There's no doubt that using religion as a sword to harm others is the administration's intent with this new task force. Just consider who surrounded Sessions at Monday's summit:

- The owner of Masterpiece Cakeshop, the Colorado bakery that asked the Supreme Court to condone its use of religion to discriminate against a gay couple seeking a wedding cake. The DOJ had supported Masterpiece's argument.
- Louisville Archbishop Joseph Edward Kurtz, a leader in the U.S. Conference of Catholic Bishops, who advocated for allowing taxpayer-funded adoption and foster care providers to discriminate against parents and children and for nonprofits to deny women access to birth control, all in the name of religion.
- Sen. James Lankford (R-Okla.), a proponent of several pieces of legislation that would undermine church-state separation, including the Child Welfare Provider Inclusion Act that would allow adoption agencies to discriminate and the Conscience Protection Act that would allow

health care providers to deny medical care.

 Several people who have been affiliated with the conservative Christian legal organizations Alliance Defending Freedom and Becket Fund, some of the leading advocates for these types of policies.

"The event by the Justice Department offends the true meaning of religious freedom," said **Rachel Laser**, AU's president and CEO. "Far from seeking to safeguard religious freedom, Trump, Sessions and their allies are hard at work trying to destroy that precious right by favoring the religious views of a select few at the expense of religious freedom for all Americans. They seek religious freedom for some, not for all."

FFRF emphasizes necessity to bar church politicking ffrf.org

The Freedom From Religion Foundation is pleased to learn that the U.S. Senate has voted for a mustpass spending bill that does not contain language to repeal the ban on church electioneering.

This news comes after the U.S. House approved a provision slipped into the FY 2019 Financial Services and General Government Appropriations bill to cripple the Johnson Amendment. The provision in the House bill would make it nearly impossible for the Internal Revenue Service to enforce the Johnson Amendment, enabling churches to promote political viewpoints and endorse candidates running for office without penalty.

Moreover, this language in the bill weakens this crucial protection for churches against political corruption. Diluting the Johnson Amendment would make the Citizens United decision look trivial and nominal by comparison. If the amendment is repealed, billions in dark money will inevitably flow into and out of churches for political purposes, pressuring churches to become dark money conducts.

The spending bill will now go to a congressional conference committee that will hash out what language gets put into the final version of the bill.

FFRF is affirming the need to maintain the full enforcement of the Johnson Amendment in this must-pass legislation and condemns any attempt to turn churches into PACs.

The Search For Any Evidence Supporting Trump's Muslim Ban Continues

It's been 18 months since President Donald Trump issued his first Muslim ban. It's just shy of a year since Trump enacted his third and current Muslim ban. And a month has passed since the U.S. Supreme Court said this cruel ban that separates American Muslim families can remain in effect.

And yet, we still have no proof from the administration that the Muslim ban was based on anything

other than Trump's hostility toward Muslims.

When Trump issued Muslim Ban 3.0 last September, he claimed a "worldwide review" by the Departments of State and Homeland Security of other countries' immigration procedures justified his ban. But the government hasn't provided any evidence to back up these claims; instead, the adminis-



In addition to our Brennan Center lawsuit, we've also joined Muslim Advocates and the Southern Poverty Law Center as plaintiffs in Muslim Advocates v. Department of Homeland Security, a lawsuit to compel the Trump administration to explain the process and qualification standards for obtaining waivers to the Muslim ban. And still active is our lawsuit that directly challenges

tration's process to create and enforce the Muslim ban remains shrouded in secrecy.

Americans United and our allies Muslim Advocates, the Brennan Center for Justice at NYU School of Law and the law firm Covington & Burling LLP in July 2017 filed a Freedom of Information Act (FOIA) request with the State Department to produce critically important reports the government says led to the creation of Muslim Ban 3.0 and its predecessors. But the government never produced any documents.

Then AU and its allies filed a lawsuit, *Brennan Center for Justice v. U.S. Department of State*, to force the government to fulfill its legal obligation to provide the information or explain why it couldn't. A federal judge in January ordered the government to produce the documents we requested by Feb. 9, 2018, or provide an explanation for why the reports were being withheld. But still, the Trump administration hasn't produced any substantive documents.

The court battle over these documents continues; last night we filed our written argument in the district court explaining why the American people are entitled to know whether there is any basis for excluding millions of people because Muslim Ban 3.0 – Iranian Alliances Across Borders v. Trump, which was filed on behalf of individuals and organizations harmed by the ban.

know what's in them. It's telling that the administration insists these reports

justify the Muslim ban while at the same time refusing to disclose what they


Given Trump's long history of anti-Muslim rhetoric, it's clear his intent

has always been to ban as many Muslims from the United States as possible.

The Muslim ban, which has no expiration date, continues to harm countless Americans and their family members abroad – parents are separated from children, husbands are separated from wives. And Trump's anti-Muslim rhetoric and this ban have emboldened not only hate crimes and hate speech against Muslims, but also violence and verbal attacks against other religious minorities and people of color. In their submissions to Americans United's essay contest, Rimpal Bajwa, a Sikh-American high school student from

Washington, and Ariel Hall, a Muslim African-American high-schooler from Ohio, described how they and people in their communities have experienced intolerance as a result of the ban.

Americans United will continue to fight the Trump administration's attempts to undermine church-state separation and single out Muslims for disfavored status. Because religious freedom is for all of us, not just some of us.




