

## July AFS Meeting

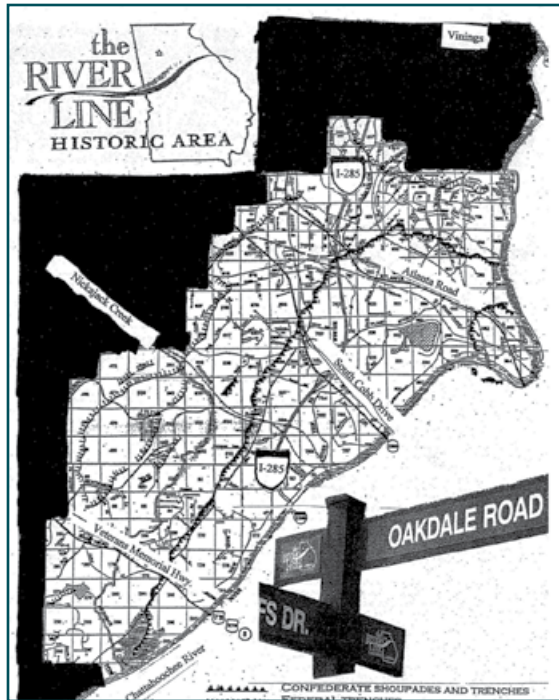
### Roberta Cook - River Line Historic Area

"The River Line Historic Area derives its name from Johnston's River Line, a long line of Civil War trenches named after Confederate General Joseph Johnston who authorized its construction. Johnston's River Line is particularly significant due to its unique fortifications called Shoupades, a worldwide exclusive to Cobb County designed by Brigadier General Francis Abbey Shoup." - Mableton Improvement Coalition

# Fallacy of the Month

## Strawman

This is the sixth in a monthly series discussing the kinds of faulty reasoning that you are likely to run across in everyday discussions and debates. Atlanta Freethought Society's mission includes teaching how to avoid faulty reasoning so that your thoughts are free from mistaken reasoning and unsupported authoritative claims.



The **Strawman** fallacy is when a statement, standpoint, or theory is mischaracterized, usually on purpose, in order to more easily attack or refute it. Entire books, entire theories, entire careers have been based on the strawman fallacy. The fallacy gets its name from the figurative metaphor that it is easier to knock over a human figure made of straw than a real human.

The Strawman fallacy has several named subtypes – **Distortion, Oversimplification, and Exaggeration** – being self-explanatory. **Extension** is when the original claim is extended to things it wasn't originally meant to cover. **Slippery Slope** is when it is claimed that adopting position A is purported to lead to B and then to C; C is then characterized so negatively that step A should not be taken. This can be seen as a Strawman if it is not known that A will lead to C, and it is done on purpose to attack A. **Attacking Illustrations** is when a person only focuses on the examples given to illustrate the original position, not focusing on the reasons given for the position. **Weakest Reasons** is similar, when one focuses only on the weakest reasons for the original position, not all of the reasons or the strongest reasons given.

**Quoting out of context** is another way in which the Strawman occurs. The meaning of a statement can be changed simply by pulling the statement out of its original context and placing it in another. Often this is done to make the original statement sound silly. Finally, **Stereotyping** (placing individuals in mischaracterized groups) can also be seen as a form of Strawman, if the characterization is used for an attack.

Caveat: The Principle of Charity in argumentation is to give your interlocutor the benefit of the doubt. Give them a chance to correct their fallacy. In the case of the Strawman fallacy, it is not fallacious if the criticizer simply doesn't understand the original statement or theory. But if not corrected when given the chance, or if the mischaracterization is done on purpose, then it is a Strawman fallacy.

### How to Spot

As with many fallacies, the Strawman fallacy is easiest to spot when it is being used against your own position. As a freethinker, when I am reading, I pay particular attention to the way freethought, secularists, science, evolution, atheists, etc. are characterized. It is easy to spot strawman characterizations, because they are mischaracterizations of my thinking. It is much more difficult to spot strawman attacks of views that you might disagree with or know nothing about.

Some terms frequently accompany strawman attacks which are trying to minimize the original, such as 'only' or 'merely'. Any time an author is characterizing their opponent's point-of-view, you need to be suspicious and seek other, outside characterizations of that same point-of-view. That might tell you if the author is pulling a strawman.

# American Atheists' Statement on the Retirement of Justice Anthony Kennedy

On June 27, 2018, in a letter to the President, **United States Supreme Court Associate Justice Anthony Kennedy announced his retirement**, effective July 31, 2018. In response, American Atheists' legal and policy director **Ali-son Gill** released the following statement:

"With the retirement of Justice Kennedy, **President Trump** has the opportunity to nominate someone who could maintain the Court's balance and garner broad, bipartisan support. Unfortunately, the President has shown that he is more interested in packing the courts from top to bottom with ideologues and extremists than he is in ensuring equal protection under the law for all Americans.

"The 'short list' of 25 candidates for the Supreme Court the President has released have been hand-picked by organizations that would gut civil rights protections, severely limit access to reproductive healthcare, and funnel billions of our tax dollars into religious education, all in the name of their distorted conception of 'religious freedom.'

"The Senate must exercise its constitutional duty to fully examine the record of any nominee to the Court and not simply serve as a rubber stamp for a President whose judicial nominees have shown a total lack of respect for precedent and outright hostility to the shared values of the American people. The American people deserve a Justice who will jealously guard true religious freedom for all.

"Considering the 'rule' invoked by Senate Majority Leader **Mitch McConnell** after the death of **Justice Scalia**, the Senate should allow the American people to first weigh in on the direction of our nation during this year's upcoming midterm elections before moving forward with any nomination. As Leader McConnell said, 'The American people are perfectly capable of having their say on this issue, so let's give them a voice. Let's let the American people decide.' We agree. The American people shouldn't be denied a voice."

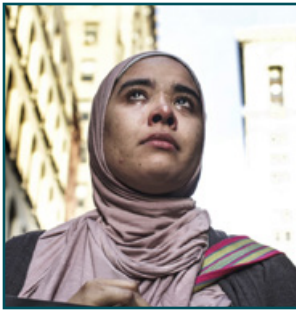

# Members Of Congress Showed Up To Denounce The Supreme Court's Muslim Ban Ruling and Call for a Legislative Fix

On the steps of the U.S. Supreme Court June 26, 2018, Americans United, allies and activists gathered to hear community leaders and government officials speak in opposition to the Court's ruling that allowed President Donald Trump's Muslim ban to remain in effect indefinitely.

In a 5-4 decision, the Supreme Court upheld President Trump's Muslim ban, which bars immigration from several Muslim-majority countries. Any reasonable observer of Trump's campaign and presidency would conclude that

the ban was inspired by anti-Muslim animus—with Trump repeatedly declaring Muslims unworthy of basic dignity. But the Court ignored Trump's anti-Muslim statements. They allowed the government to single out one religion for discrimination, and brushed aside the fundamental American principle of religious freedom for all.

Seventeen members of Congress—four senators and 13 representatives—joined the rally outside the Court organized by the **Justice for Muslims Collective** to denounce the Supreme Court's ruling. These members of Congress spoke alongside many of our tireless allies and **Americans United's own president and CEO, Rachel Laser**. Fortunately, they promised to continue fighting to protect Muslims and religious freedom in American.

“What has happened today is an absolute travesty to the core value of freedom of religion in the United States of America,” U.S. Sen. **Jeff Merkley** (D-Ore.) said at the rally.

Among the speakers were also Sen. **Cory Booker** (D-N.J.) and Rep. **Joe Kennedy III** (D-Mass.).

“We are not a country that bans people based on their faith, we are a country that embraces all,” Booker said.

**Kennedy**, meanwhile, criticized the Supreme Court for not living up to the words engraved into the entrance of the building: “Equal Justice Under Law.”

Throughout the rally, members of Congress condemned the ruling, and called for a legislative fix to the ban in Congress.

As Rep. **Barbara Lee** (D-Calif.) stated: “Congress has the power to overturn this hateful decision and pass a law to stop this cruelty.” We agree with Lee, and we hope that Congress acts to end this ban.

Lee pointed to **HR 4271**, a bill introduced by U.S. Rep. **Judy Chu** (D-Calif.), which blocks the implementation of Trump's ban.

U.S. Rep. **Don Beyer** (D-Va.) appealed to his colleagues in the House and

Senate: “It is up to Congress to pass the **Freedom of Religion Law**, which would ban any law that would prevent other people from coming to this country because of their religious views.”

Other members also pledged to fight back and called out the court for ruling in the favor of religious discrimination.

“To my Muslim brothers, friends and neighbors... we are going to fight this racist, discriminatory policy,” U.S. Rep. **Ruben Kihuen** (D-Nev.) said.

U.S. Sen. **Mazie Hirono** (D-Hawaii), the only Buddhist serving in Congress, concurred. “This is not a nation of Christians only... We need religious diversity,” she said.

Take U.S. Rep. **Debbie Dingell's** (D-Mich.) speech at the rally. She represents the 12th district of Michigan, which is home to the largest Muslim community in America. At the rally, she shared a heart-wrenching story.

“An 8-year old girl hugged me in school and started crying and she told me she feared that

someone would come in the middle of the night, knock on their door and tear her family away,” she said. “I have now heard that story 30 times.”

This is heartbreaking, and it's why we believe America is at its best when people of all religions feel welcome here. For people of all faiths and for non-believers — religious freedom means that the law treats everyone equally regard-

less of faith. Americans United will continue to protect this ideal because the fight against the Muslim ban is not over.

As U.S. Rep. **Darren Soto** (D-Fla.) stated, “There is nothing more un-American than a country founded on religious dissonance now having enshrined in our Constitution discrimination against those based upon religion.”

## Ruling against Truth: NIFLA v. Becerra

On Tuesday, June 26, the Supreme Court ruled against women, against evidence- and science-based healthcare, and against truth. In a highly contested **5-4 vote**, the justices decided in favor of the National Institute of Family and Life Advocates (NIFLA). The court said that the California Reproductive Freedom, Accountability, Comprehensive Care, and Transparency Act (the “FACT” Act) violated the First Amendment, and that NIFLA’s free speech and free exercise rights were infringed upon with this act. The FACT Act required all state-licensed clinics to provide information about a range of family planning services, including the telephone numbers of abortion providers, and to do so in thirteen languages, while requiring unlicensed clinics, including those sponsored by NIFLA, to provide the same abortion services information and declare that they were unlicensed and not true medical providers. Justice **Clarence Thomas**, writing on behalf of the majority, decided that the notices are a “**content-based regulation of speech**” and that requiring clinics that oppose abortion to give information about the procedure “alters the content” of these clinics’ speech enough to violate the First Amendment.



The clinics supported by NIFLA are commonly called crisis pregnancy centers and are almost always run by “pro-life” religious groups. These centers routinely target low-income women, shaming, pressuring, and misleading them into carrying their fetuses to full term. CPCs pretend to offer the “full range” of family planning services and appear to be an attractive alternative to state-sponsored family planning services for women who are unexpectedly pregnant but are maybe unsure about getting an abortion. However, what crisis pregnancy centers don’t tell the women they claim to serve is that they’re often not licensed and not staffed by real, credentialed medical doctors. Furthermore, as part of their “religious mission” against abortion, these CPCs

often spread lies that abortion causes breast cancer or that women who have abortions will never be able to conceive again. They play with vulnerable women’s emotions by showing them ultrasounds of their fetuses, asking if they want to hear the fetus’s heartbeat, telling them the sex of the fetus when the women have not asked for it, and going so far as to flat-out lie to their clients about how far along they are in their pregnancies, falsely pushing the date back so that when women go back to these CPCs or a true medical doctor for follow-up appointments, they’re too far along to legally get an abortion. No wonder California enacted the FACT Act.

Ironically, the CPCs won their argument on free speech grounds. California argued that it could require medical centers to provide abortion information as a form of “professional speech,” a category that allows states to require doctors and medi-



cal professionals to disclose other ethical and legal information. However, Justices Thomas and **Kennedy** disagreed. They thought the state was unfairly targeting these fake clinics “**on the basis of their religious beliefs.**” But it seems to me as though the religious beliefs of CPC donors and staff interfere with the state’s ability to safeguard public health.

To best protect public health, the state has a duty to make sure its constituents are as informed as possible. This includes providing information that may make certain religious adherents uncomfortable. But the state can do that because the First Amendment **also states** that “Congress shall make no law respecting the establishment of religion.” However, by ruling that CPCs can take religiously motivated actions and not disclose certain essential health facts because it would violate their freedom of expression according to their religious beliefs, it seems like the Supreme Court is giving Congress free rein to “respect the establishment of religion.” In his concurring opinion, Kennedy **wrote** that the FACT Act “is a paradigmatic example of the serious threat presented when government seeks to impose its own message in the place of individual speech, thought, and expression.” But by being allowed to operate and use their religious beliefs to restrict women’s access to information, the government is instead letting NIFLA “impose its own message in the place of individual speech, thought, and expression.”

Although this case was framed as a free speech case, it’s also an Establishment Clause case, and therefore a humanist case. By letting so-called “medical professionals” use their religious beliefs to obstruct the advancement of public health, the Supreme Court has knocked down quite a few bricks of the now-shaky wall between church and state. Regardless of your feelings about abortion, we humanists have a responsibility to ensure that people’s personal religious beliefs do not affect the proper functioning of the state. Therefore we must fight back against these CPCs and make sure religious advocacy doesn’t prevent women from getting the information they need to make the best decisions possible for their bodies and their lives.

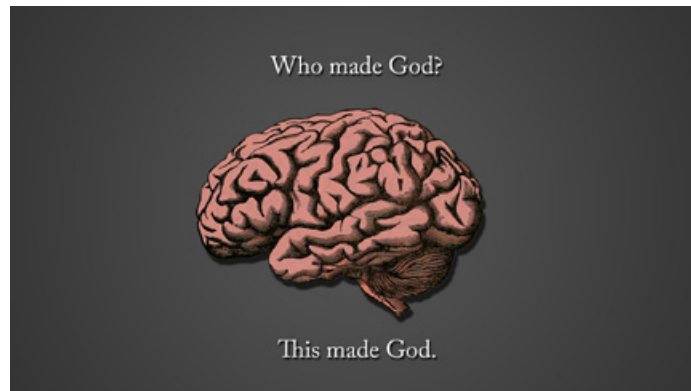

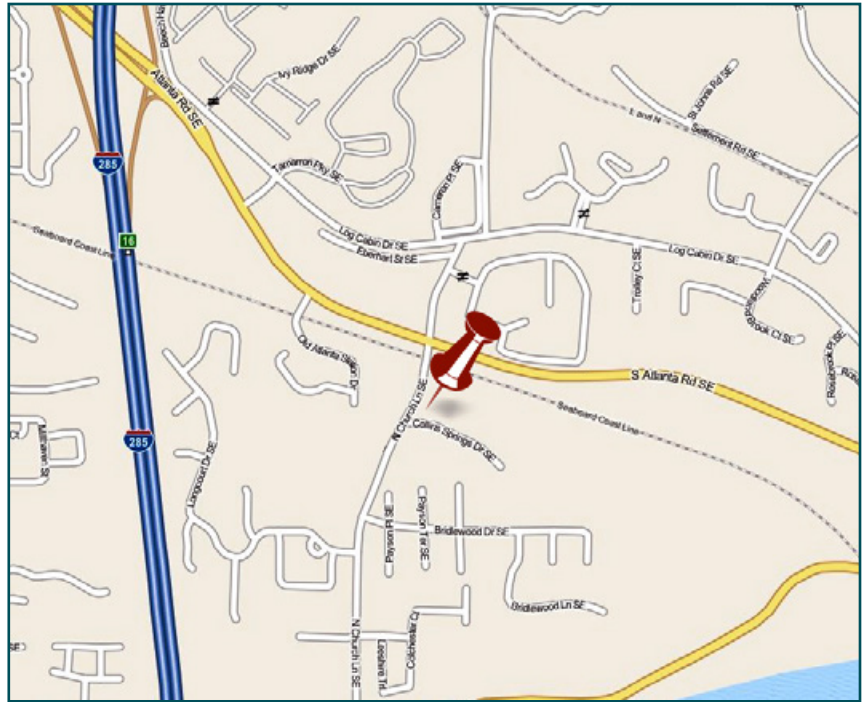
