As interim executive director, Buckner will oversee the operations of American Atheists and provide guidance and support to the full-time staff while the Board of Directors searches for new permanent leadership for the organization.

"For over fifty years, American Atheists has been the organization willing and able to lead the unapologetic charge to support atheism, atheists, and the absolute complete separation of government and religion," said Buckner. "I'm proud to have led this group before, to have been a long-time life member, and to now have another chance to contribute."

"His many years of support for the work of this organization and this community, as well as his steady hand of leadership, will ensure that American Atheists continues to be an outspoken voice in this nation for atheists and atheism as we move forward and continue our work protecting the separation of religion from government."

In addition to his service as president of American Atheists, Buckner was a member of the Board of Directors from 2010 to 2015. He previously served as the executive director for the Council for Secular Humanism from 2001 to 2003 and as president of the Atlanta Freethought Society.

Dr. Buckner holds a bachelor's degree in English from Rice University and a master's degree and Ph.D. in education from Georgia State University.

Fallacy of the Month False Dilemma

This is the fourth in a monthly series discussing the kinds of faulty reasoning that you are likely to run across in everyday discussions and debates. Atlanta Freethought Society's mission includes teaching how to avoid faulty reasoning so that your thoughts are free from mistaken reasoning and unsupported authoritative claims.

The **False Dilemma fallacy** is often called the Either-Or Fallacy, the Black-or-White Fallacy, and Bifurcation. It occurs when a speaker offers several (usually two) alternatives in an argument or discussion when there are actually more alternatives. This is one way it can occur, but there are other ways. I need to explain a dilemma first.



A **Dilemma** is the name a formally valid argument with a specific pattern: A or B. If A, then C. If B, then D, So, C or D. Simply put, A leads to C, B leads to D, and you have to pick A or B. So, either C or D is going to happen. The structure of this valid argument pattern is called a "Dilemma."

"I can stay married or get divorced. If I stay married, I will be miserable. If I get divorced, I will be poor. So, I will be miserable or poor." This is a real dilemma if the three premises are true. However, there are three ways that this can be a false dilemma.

Picture the Dilemma as two horns. One horn is A leading to C. The other horn is B leading to D. The two horns are joined at base by the A or B statement. **Going Between the Horns of a Dilemma** is the same as the Either-Or Fallacy above—saying that between the choices of A and B is another choice E that hasn't been discussed yet. You can try marital counseling first. **Taking the Dilemma by the Horns** is to show that one of the horns (the if...then statements) isn't necessarily the case. Getting divorced doesn't necessarily mean you will be poor. **Showing the Desirability of an Alternative** is a third way that a false dilemma can occur. In the above example, you might re-think: Being poor is a simpler life; that might be good for me right now. In other words, it's only a real dilemma if both consequences are C and D are undesirable.

How to Spot

Unlike some fallacies which can be spotted in what is being said, the False Dilemma fallacy is found in what is not being said— in the alternatives and other solutions that are not being discussed. You don't have to have a full-blown dilemma structure. Any either-or statement that is incomplete is a false dilemma. So, as a critical thinker, you have to come up with these other alternatives.

Certain terms alert you to the fact that you are being given alternatives. Terms such as: or, unless, either...or..., and/or, alternatives, options, choices, electives, picks, selections, etc.

House Flap Over Chaplain's Firing Highlights The Dangers Of Mixing Religion And Government

On April 16, **Paul Ryan** announced that the House of Representatives' chaplain, the **Rev. Patrick J. Conroy**, would be stepping down in May. This week, it was revealed that Ryan, after being pressured by some Republicans, forced Conroy out of his post. The ouster has prompted outrage among members of the House.

That there is controversy surrounding the House Chaplain should surprise no one. The House chaplaincy is the quintessential mixing of religion and state that our founders warned us about.

There is a lot of speculation about why Ryan and other Republicans called for his firing. In fact, U.S. Rep. **Gerry Connolly** (D-Va.) and three other members are circulating a bipartisan letter requesting more information from Ryan that they plan to send to the speaker today.

Many believe the firing was sparked by a Conroy invocation that some Republicans perceived to be critical of the Republican tax bill. The words that offended: "May their efforts these days guarantee that there are not winners



and losers under new tax laws, but benefits balanced and shared by all Americans."

Meanwhile, some members are questioning Ryan's authority to fire the chaplain and are contemplating legislation to prevent similar action in the future. Others are

questioning Ryan's Catholicism, since Ryan appears to have fired Conroy, a Catholic priest, for statements about protecting the poor. And a debate is now swirling over whose theology, Ryan's or Conroy's, is more Catholic. Others still are asking whether the invocation itself—potentially touching on a political matter—was proper or whether Ryan has any ability to put restrictions on what the chaplain says.

The controversy, however, doesn't end with the firing of Conroy. The issue of the hiring of the new chaplain is creating problems of its own. U.S. Rep. Mark Walker (R-N.C.), who is on the hiring committee, says he wants to hire a chaplain who has a family and can better relate to the experiences members of Congress face. Of course, such a requirement would preclude the hiring of another Catholic priest. Rep. Connolly responded: "We, on its face, would consider such a remark to be anti-Catholic—on its face. So you're eliminating anyone who's a Catholic priest, a Catholic nun, from being the chaplain of the House. The largest denomination in the country."

Ryan has fed the anti-Catholic concerns with vague remarks like, "not all of my members feel that they got spiritual guidance from him."

U.S. Rep. **Emmanuel Cleaver** (D-Mo.), the only Democrat on the chaplain hiring committee and an ordained Methodist minister, appears to recognize that fighting over the chaplain doesn't look good for Congress, remarking, "All I would like is to prevent us from looking like the House of

Clowns. And having yet another controversy that may boil down to fighting over religion and which side is right—this is just not healthy."

But what Cleaver's statement seems to overlook is that there is no way to have a House chaplain without inviting the "fighting over religion" and determining "which side is right." It is just that usually, the debate is not so open and visible.

As **Charles Haynes**, vice president of the Newseum Institute/Religious Freedom Center, tweeted about the current controversy, this is a "case study in why government-funded prayers are bad for authentic religion and violate liberty of conscience."

Having a chaplain puts the House of Representatives in the position to pick one religious leader over all others. Yet the House membership includes representatives who are Buddhist, Humanist, Muslim, Hindu, Jewish, Orthodox Christian, Catholic, numerous Protestant denominations and those with no religion at all. Some members of the House and the public will be represented while others aren't, sending a message that Congress has sided with and favors some faiths over others. And with the remarks from some quarters, it seems like there might be an unspoken religious test being placed on the next chaplain's selection. And that, too, is a big problem.

Of course, the House is unlikely to abolish the chaplaincy because the Supreme Court has upheld legislative chaplains and prayers. But the court has also made clear that governmental bodies must not discriminate based on religion in selecting chaplains. The House should pay heed to that principle, both in picking its next chaplain and in ensuring that its guest chaplains represent reflect the religious diversity of its members and all Americans.

On the morning of April 27, Conroy's invocation asked God to give members "the wisdom and magnanimity to lay aside what might divide us." I might suggest that mixing religion and government is the source of division.

Editor's note: On Thursday, May 3rd, Speaker Paul Ryan flip-flopped on the decision to retain House Chaplain Patrick Conroy through the rest of his term, in an attempt to bypass the controversy. Maybe Congress should honor the first amendment and keep government out of the religion business.

FFRF Offers 'A' Badge to Counter Scout Bias

Even as the Boy Scouts of America is overhauling its membership and nomenclature to be inclusive, it still has a blind spot regarding a marginalized group: the nonreligious.

"For 108 years, the Boy Scouts of America's flag-



ship program has been known simply as the Boy Scouts," the Associated Press reports.

"With girls soon entering the ranks, the group says that iconic name will change. The organization on Wednesday announced a new name for its Boy Scouts

program: Scouts BSA."

The Freedom From Religion Foundation welcomes this move, as it did the group's repeal of its ban on gays. But it decries the fact that the scouts will still discriminate against the nonreligious and their families, excluding atheists, agnostics and nonbelievers. After it announced last fall that the membership was being opened up to girls, the leadership reiterated its prejudice.

"We believe this nation needs and deserves more youth focused on the foundations that still serve as bedrock of our movement — duty to God and country with a desire to help other people at all times," an October statement signed by the organization's national president, commissioner and chief scout executive said, with the bold emphasis in the original letter.

FFRF has come up with a creative way to address the Boy Scouts' prejudicial attitude toward non-believers. At the urging of its member **Richard Kirschman**, it has produced a badge similar to the scouts' merit badges, which are typically sewn on uniforms or sashes. The badge, featuring a red "A" based on a symbol of atheism and agnosticism popularized by distinguished scientist and atheist **Richard Dawkins**, is being issued in collaboration with the **Richard Dawkins Foundation for Reason & Science**.

Scouts who wish to earn this badge are asked to help disprove the group's misguided claim that nonbelievers cannot be good citizens. At Dawkins' suggestion, the scout or youth seeking a badge need only send FFRF a short essay addressing the Boy Scouts of America's claim that nonbelievers can't be good citizens. FFRF will not charge scouts money for the badge. The requirements, paralleling typical merit badge requirements, ask scouts to learn about secularism and the rich history of dissent from religion.

Trump Administration Continues Daily Assault on Religious Freedom

At a ceremony in the White House Rose Garden on May 3rd, President **Donald Trump** signed an **executive order** creating the "White House Faith and Opportunity Initiative," an office that would further undermine religious freedom and pour even more taxpayer money into religious groups that are free to discriminate, have little accountability and zero transparency.

"The separation of religion and government has never been under greater attack," said **Alison Gill**, Legal & Policy Director of American Atheists. "This executive order would permit religious groups receiving taxpayer

money to offer public services steeped in religion without providing opt-outs or referrals to alternative providers. Americans should not have to wade through religious messages and proselytizing in order to access essential government services."

Unlike faith-based initiatives by previous administrations, Trump's initiative will require every department of the federal government to look for ways to partner with religious groups, not just faith-based of-



fices, under the coordination of the new White House office.

"The new initiative will channel ever more federal money into churches aligned with the President, ostensibly for public services, but far too often used for proselytizing and religious activity," said **Ed Buckner**, Interim Executive Director of American Atheists. "Our nation's Founders believed that it was unjust and tyrannical to tax all to fund the religious beliefs and practices of a few. Mr. Trump should spend less time watching cable news and more time reading the plain language of the Constitution."

This executive order joins a long list of unconstitutional actions committed by this administration to advance their distorted view of religious freedom.

In February, Attorney General Jeff Sessions installed "religious freedom" czars in every US attorney's office and announced that all litigation that could potentially involve religious issues must receive prior approval from political appointees at the Department of Justice. In January, the Department of Health and Human Services created a new office tasked with allowing healthcare institutions to deny services to patients on the basis of their own religious beliefs.

And this week, the New York Times reported that new federal policies are diverting disaster relief funds away from victims and public services and instead directing them to churches and religious schools.


