To check out a book, leave book title, your name, and either a phone or email address on the list in the library. If you would like to donate books to AFS, there is a location in the library. Books that aren't used by the library will not be returned. They will be traded for books that the library can use.

I'd like to encourage you to use the AFS Library. We have many books by the Four Horsemen of the New Atheism – **Dawkins, Hitchens, Dennett, and Harris**. We have lots of books on evolution (in the Science section), including some books refuting evolution (in the Religion section). **Joe Lieberman's** book *The Gift of Rest* (2011) looks interesting, if you can ignore the religion parts. There are several books on how to raise freethought children, as well as books for children that teach humanist values.

Sometimes I forget how humorous freethought

writing can be. We have books from **Mark Twain** (1880s) and **Ambrose Bierce's** *The Devils' Dictionary* (1911) to **Penn Jillette's** *God No! Signs You Already May Be An Atheist* (2011). And don't miss *The Two Kings: Jesus and Elvis*. (I laughed out loud several times.)

There are books on the Jonestown disaster, UFO investigations, and how people are manipulated by church and media. Other books vary from **Ballen's** *Terrorists in Love: True Life Stories of Islamic Radicals* (2011) to **Maclver's** *Kill the Stupid and Other Musings* (2017). There's an array of books on the separation of church and state, including two by our own **Ed** and **Michael Buckner**.

Our largest section is Atheism, Humanism, and Religious Criticism. I'm guessing we have every book ever published by Prometheus Books. Many authors have spoken at Atlanta Freethought Society: **McGowan, Barker, Buckner, McKown, Parsons, Whitehead**, and others. There are several books on contradictions in various scriptures, and a couple of books on the X-rated sections of the Bible. Recent books include **Boston's** *Taking Liberties* (2014), **Ehrman's** *Jesus Interrupted* (2010), **Murphy's** *The Everyday Atheist* (2013), **Wenke's** *You've Got to be Kidding* (2012), and **Mnookin's** *The Panic Virus* (2011).

# In The Religious Right's Bizarro World, Brett Kavanaugh Is The Victim

One thing they were not doing was showing any concern or sympathy for **Prof. Christine Blasey Ford** or any of the other women who have courageously come forward with their own stories of sexual assault in the wake of her going public.

Since then, I am sorry to report, things have only gotten worse.

Let's start with **Jerry Falwell Jr.**, perhaps the biggest of the **President Donald Trump's** Religious Right sycophants, **who in a tweet** called on conservative Christians to stop electing "nice guys" and go with more street fighters like Trump.

**Jerry Falwell @jerry-falwelljr:** "Conservatives & Christians need to stop electing "nice guys". They might make great Christian leaders but the US needs street fighters like @realDonaldTrump at every level of government b/c the liberal fascists Dems are playing for keeps & many Repub leaders are a bunch of wimps!"



Somehow, I'm having a hard time imaging Jesus offering the same advice, but let's put that aside for a moment. I've not heard one peep from Falwell about Ford's ordeal, and his call for more obnoxious people in government is hardly a balm to other women who have been victimized. (By the way, who are these "nice guys" right-wing Christians supposedly love to elect? **U.S. Sen. Lindsey Graham**, perhaps? Maybe **U.S. Sen. Ted Cruz**?)

Next out of the gate is the always-appalling **Franklin Graham**, whose tweet be-moaned that the hearing "ruined [Kavanaugh's] reputation and devastated his family." Graham said not one word about what Ford has been going through. Nothing about the death threats, the fact that she had to flee her home, split up her family and hire security guards. He's oblivious to the anxiety she faced as she appeared before a panel composed of the some of the most powerful men on the planet, men who hired an aggressive professional prosecutor to cross-examine her.

**Franklin Graham @Franklin\_Graham:** "Yesterday's hearing was an embarrassment. Let's pray that our country will do better than this. Judge Brett Kavanaugh said this has ruined his reputation and devastated his family. Unfortunately, I'm afraid that is exactly what the minority leadership wanted to do."



Someone must have told Graham that he looked insensitive because a few minutes later he issued another tweet calling for prayers for all involved – first for the Kavanaughs, then for Ford and then for Judiciary Committee members. Yes, it felt perfunctory.

Then our old friend **TV preacher Pat Robertson** struck. Fresh off of his latest hurricane-diversion triumph – **Robertson prayed** that Hurricane Florence would not hit his empire in Virginia Beach, but unfortunately, he failed to use his awesome powers to send it out to sea, and the storm slammed into the Carolinas, killing 42 people and leaving thousands homeless – the volatile televangelist asked God to "throw confusion" into Kavanaugh's opponents.

He went on to rant, "The Supreme Court of the United States is the power center of the liberal left. They have done their bidding for years and years and years, and now comes a decisive moment as to whether they will lose control of that particular body and they are putting an all-out assault to destroy the reputation of one of the finest judges in America. It is a pre-planned plot, it is unbelievable, and if anybody buys it, they'd be willing to buy the story of the Great Pumpkin and any other myth that you can think of."

It was vintage Robertson. I have no doubt that he did manage to draw up a generous amount of confusion, but it's not afflicting the people he thinks. (A hat tip to the folks at Right Wing Watch for capturing the video.)

I just got back from a series of speaking engagements in Sarasota, Fla., and the Orlando area. At every event, I was asked questions about Kavanaugh. People were familiar with these antics by the leaders of the Religious Right and are rightly appalled by them.

I reminded people that this incident is yet another reminder of the amorality of these alleged "values voters"; it's another example of how they'll excuse pretty much anything from this president as long as he keeps dishing out the treats. The Religious Right is salivating over the possibility of a right-wing high court giving them more power to meddle in our lives and usher in their neo-Puritan Handmaid's Tale-lite society, and they simply do not care about the human cost.

Remember that the next time you run into a moral majoritarian eager to lecture you about how everything would be great if we'd just get back to "traditional values."

# Remember, Alabama: When You Listen To Roy Moore, Bad Things Happen

When we last left “Ten Commandments” judge **Roy Moore**, he was licking his wounds after being defeated for a U.S. Senate seat by **Doug Jones** in Alabama.

Well, kind of. See, Moore insisted **he hadn’t really lost**. Nefarious forces had bused people in from out of state, suppressed the vote or done something like that to cause Moore to lose. His defeat certainly wasn’t because reports surfaced of him **allegedly assaulting a teenage girl** in the 1980s and harassing others at a mall.

Moore raised money claiming he was going to expose the plot that kept him from office, but suddenly he’s gone quiet about that. Now Moore has decided on another flim-flam operation: bringing prayer back to public school football games in Alabama.

“Nobody stands up for the students of this state and we’re going to do that,” **Moore vowed during a press conference last week**. He announced that the Foundation for Moral Law, a group his wife supposedly runs, was sending memos to all Alabama school districts advising the superintendents on ways they can supposedly allow prayers before games.

It came out during his Senate campaign that Moore’s foundation is little more than a **grifting operation**, so I’d be highly skeptical of any advice it’s peddling. In fact, the U.S. Supreme Court settled this business of school-sponsored prayers before public school football games back in 2000 in a case called **Santa Fe Independent School District v. Doe**. The high court ruled that broadcasting prayers over a loudspeaker was coercive and put a stop to it.

Moore also has a rather checkered history when it comes to following the law, to put it mildly. After Americans United and its allies **successfully sued him** over a Ten Commandments display at a judicial building in Montgomery in 2001, he defied the federal court’s order to remove the monument. The incident led to Moore, who was then chief justice of the Alabama Supreme Court, being removed from that body.

For some reason, Alabama voters saw fit to return Moore to the Alabama high court in 2012. Three years later, after the U.S. Supreme Court upheld marriage equality, Moore again engaged in judicial defiance. He ordered probate judges in the state not to recognize the ruling. This stunt led to Moore’s second removal from the court.

To sum up: What we have here is a man who has been accused of sexually assaulting a teenage

girl, a man who founded a charity and then used it to pay himself a handsome salary, a man who was twice removed from Alabama’s highest court because he would not follow the rulings of higher courts. (Have I mentioned that he also **writes really bad poetry?**)

Here’s a little suggestion for school superintendents in Alabama: You know that letter you just got from Roy Moore? Turn it into a paper airplane, recycle it, use it to line a birdcage, etc. Do anything but listen to it.

## Prayer at football games in Toombs Co, GA

The FFRF is calling timeout on a Georgia school district for its **multiple violations of the U.S. Constitution**. Not only are coaches and an outside pastor praying with the high school football team, religious propaganda is also being posted on its official social media.

Football coaches at Toombs County High School (located in Lyons, Ga.) have been promoting religion to students. A video posted on Facebook shows coaches making religious statements and **initiating a religious chant with students after a game**. In the video, each coach makes a statement before reciting the phrase, “God is good,” to which the students respond: “All the time.” Each coach then says, “All the time,” and the students respond: “God is good.” This is repeated a dozen times. A coach tells students to “know who you are and know He’s given you purpose” while pointing to the sky. After each of the coaches repeat this religious chant, one of the coaches says, “Pastor Toole, pray us out.” Pastor **Steven Toole** then leads the team in an elaborate prayer that includes the following language: “God, I thank you that I see wins every day. And God, as you work in them and you show them purpose in their lives beyond ... God, I just pray for your protection on everyone as we return home. And God, in everything that we do ... so that you receive all glory. In Jesus’ name, amen.”

Toole is apparently a local pastor who the school employs to pray with and promote religion to the team.

“The Supreme Court has continually struck down school-sponsored prayer in public schools,” FFRF Legal Fellow **Chris Line** writes to Toombs County Schools Superintendent **Barry Waller**. “It is unconstitutional for public school employees to participate in the religious activities of their students. Federal courts have held that even a public school coach’s silent participation in student prayer circles is unconstitutional.”

The district’s employment of a chaplain is an additional constitutional violation. Public schools cannot appoint or employ a chaplain, seek out a spiritual leader for students, or agree to have a volunteer teach other people’s children that character centers on religious belief, because public schools may not advance or promote religion. The school’s endorsement of Christianity is particularly troubling for those parents and students who are nonreligious or not Christian.

The Toombs County High School football program also regularly posts religious messages and bible verses on its official Twitter account, another unlawful and disturbing practice.

It is well settled that public schools may not advance, prefer or promote religion. Advancing, preferring and promoting religion is exactly what a school district does when its employees post religious messages on official public social media pages. These proselytizing messages give the appearance of district endorsement of religion over nonreligion, and Christianity over all other faiths.

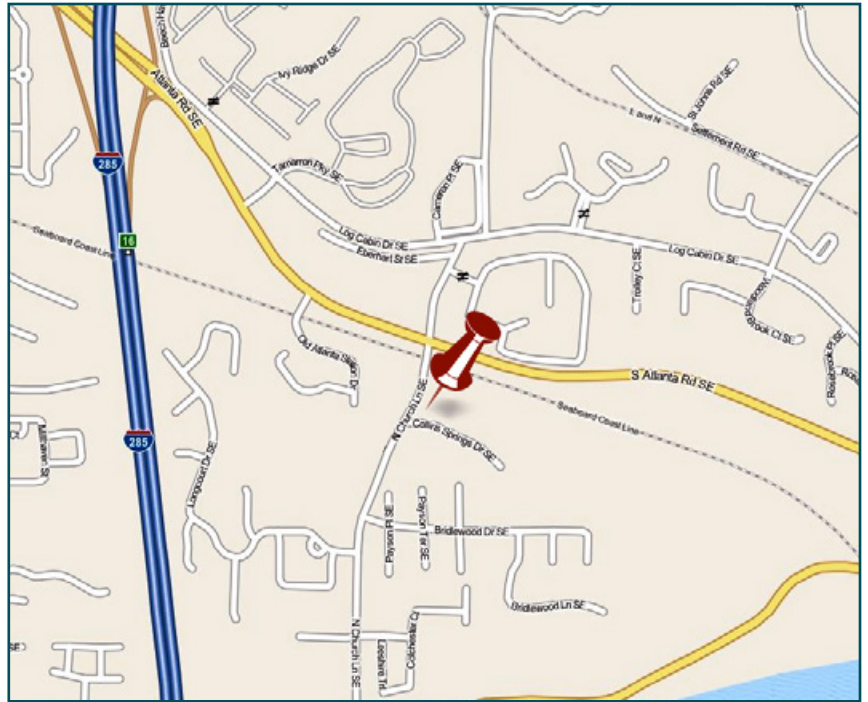
