## **February AFS Meeting** Christopher Cameron: "Socialism, Communism, and African American Freethought"



Atlanta Freethought Society is delighted to present our February Speaker, Christopher Cameron. This talk will explore the intersections of Black radical politics and secularism from

the early 20th century through the 1930s. While most historians attribute the growing appeal of socialism and communism among African Americans to the Great Depression and immigration from the Caribbean, he argues that these parties' secular orientation is what most appealed to black leaders and thinkers such as Hubert Harrison, W.E.B. Du Bois, and Louise Thompson Patterson.

Christopher Cameron is an Associate Professor of History at the University of North Carolina at Charlotte. He is also the founder and past president of the African American Intellectual History Society. He received his B.A. in History from Keene State College and his M.A. and Ph.D. in American History from the University of North Carolina at Chapel Hill. His research and teaching interests include early American history, the history of slavery and abolition, and American religious and intellectual history. Cameron's first book, entitled To Plead Our Own Cause: African Americans in Massachusetts and the Making of

the Antislavery Movement, was published by Kent State University Press in 2014. His second book, Black Freethinkers: A History of African American Secularism, was published by Northwestern University Press in September 2019. Cameron is also the co-editor of New Perspectives on the Black Intellectual Tradition, published by Northwestern University Press in 2018.

### Thank the Ones Who Need Thanking

Sent to Marietta Daily Journal, 26 Jan 2020 Dear Editor:

Nelson Price (his column, "Shakespeare on Impeachment," is reprinted below for the benefit of a few out of town/non-*MDJ* readers I'm sending this to; Sunday, 26 January 2020) is, unusually for him, trying to display his erudition with lots of Shakespeare quotations rather than Bible verses or phony founding father lines. Unfortunately for him, his concluding salvo reveals him as a mere pretentious pedant.

His last quote is from Macbeth, and Price thinks it's an apt description of the impeachment trial as "a tale told by an idiot, signifying nothing." But Macbeth uttered these words in bleak despair after his wife's suicide, indicting any creator god as an "idiot" and author of meaninglessness. The fuller context, from Act V, Scene V, makes it crystal clear that "life" is the tale told by an idiot:

She should have died hereafter;

There would have been a time for such a word.

To-morrow, and to-morrow, and to-morrow,

Creeps in this petty pace from day to day To the last syllable of recorded time, And all our yesterdays have lighted fools The way to dusty death. Out, out, brief candle!

Life's but a walking shadow, a poor player That struts and frets his hour upon the stage

And then is heard no more: it is a tale Told by an idiot, full of sound and fury, Signifying nothing.

It also seriously undercuts Price's use of the quote that Macbeth himself goes on to die, revealed as a corrupt and treacherous (though not as treacherous as Lady Macbeth) traitor. Is that what Shakespeare foretold about Trump?

#### **NELSON PRICE:** Shakespeare on impeachment

Shakespeare, where are you when we need you? A tragedy — or is it a comedy? — is playing out in Washington. It needs a title. Perhaps of all the many expressions Shakespeare originated, this one would be a good title: "Foregone Conclusion." The cast of characters consists of two cadres. The one on the left is confident their foil, formerly known as "The Donald," before he became a titled leader, called President **Trump**, is guilty. The solipsist director of Act One, **Nancy Pelosi**, and her minions have successfully sent the approved script of the play, aka Articles of Impeachment to the Senate. Now the drama is being played out.

In his numerous plays, both tragedies and comedies, Shakespeare left us bits of wisdom related to such a cast of characters.

He was never so correct as in the play of Richard III when it was said, "Now is the winter of our discontent."

Hamlet's appraisal of his mother was tailored for Pelosi, "The lady doth protest too much, methinks."

This line is taken from "As You Like It" Act 2, Scene 7: "All the world's a stage, and all the men and women merely players." Never has such a large cast of dramatists appeared on a stage at the same time.

In "The Tempest," Act I, scene 2, is found this wisdom: "Good wombs have borne bad sons." That is sons and daughters. That speaks of many a mother's grief.

From "Measure for Measure," the character Angelo speaks, "When once our grace we have forgot, nothing goes right." The word "grace" appears 25 times in this play that contrasts law and grace. Perhaps the absence of grace explains why so few things have gone right.

From the masterpiece, "Othello," comes this line: "When I love thee not, chaos comes again." How brilliant is that? Think of what he is saying: "Chaos comes to us when we choose not to love." Where there is no grace, there is no love.

In "A Midsummers Night's Dream" is found this gem: "Love looks not with the eyes, but with the mind, and therefore winged Cupid is painted blind." What of Cupid's features is pictured as being blind? The mind. This is apparently true of some of these play characters.

Then of time he says in "Richard II": "I wasted time and now doth time waste me."

Of the brain and memory in "Hamlet" he speaks of carrying on "whil'st memory still holds a seat in this distracted globe." That is much cooler than just calling it is mindless. Many acts today in Washington seem mindless.

These words attributed to Shakespeare himself seem to reveal President Trump's attitude, "Love me or hate me, both are in my favor ... if you love me, I'll always be in your heart ... if you hate me I'll always be in your mind."

This council for President Trump, comes from the play Henry IV, Act 5, Scene 4, "The better part of valor is discretion."

Shakespeare left us this final quote regarding guilt or innocence as our drama draws to an end: "To be, or not to be: that is the question."

This quote originated by Shakespeare may well define this entire event as being a "wild goose chase."

When it is over, hopefully these words from "Macbeth" won't sum it up: "It is a tale told by an idiot, full of sound and fury, signifying nothing."

I appeal for persons to do as Nancy Pelosi urged and proceed "prayerfully."

We are living through an epic experience. Looking back on experiences of our government historically, this one will someday be looked back upon as a Mount Everest.

## **End blasphemy Laws Internationally**

American Atheists submitted testimony on January 27 in support of House Resolution 512, which calls for the global repeal of blasphemy, heresy, and apostasy laws.

The resolution calls on **President Trump** and **Secretary of State Pompeo** to prioritize the repeal of blasphemy laws and the release of imprisoned blasphemers in bilateral relationships with all countries.

"Thankfully, [the U.S.] Congress has the ability to promote international religious freedom and encourage other governments to follow the protection of freedom of thought, conscience, expression, and exercise," wrote **Alison Gill**, American Atheists' Vice President for Legal and Policy. "Several countries have taken steps toward repealing these blasphemy laws, including Greece, Ireland, and Canada, but more needs to be done on the international scale."

The resolution also encourages the President and the Secretary of State to designate countries that enforce blasphemy laws as "countries of particular concern for religious freedom."

Finally, it urges the President and the Secretary of State to oppose the United Nations and other international forums if they support blasphemy laws.

"Sadly, we must note that the United States does not have a perfect record when it comes to anti-blasphemy laws," said Gill. "States such as Massachusetts, Michigan, Oklahoma, Pennsylvania, South Carolina, and Wyoming continue to have inactive anti-blasphemy provisions within their state law. Just as the U.S. condemns blasphemy overseas, Congress should encourage states to repeal these outdated statues."

## Paula White must resign from White House after 'satanic pregnancy'

The Freedom From Religion Foundation, a national state/church watchdog, is calling on evangelist **Paula White** to resign her official post after she appealed to Jesus Christ to "command all satanic pregnancies to miscarry right now." Long known as **President Trump's** "spiritual adviser," White was appointed late last year to a paid position with the White House's Faith & Opportunity Initiative.

"It's an embarrassment to our nation that White is a government employee," says FFRF Co-President **Dan Barker**. "If White doesn't step down, Trump should fire her. Such primitive thinking, superstition and bigotry should have no place in 21st century U.S. governance."

On Friday, Jan. 24, the same day Trump became the first president to address the anti-abortion March for Life rally in Washington, D.C., Right Wing Watch **posted video of White** appearing to wish miscarriages for a certain category of pregnancies defined by her. The off-the-wall sermon was given to the congregation at New Destiny Christian Center, an Apopka, Fla., megachurch, at which she was formerly senior pastor:

In the name of Jesus, we command all satanic pregnancies to miscarry right now. We declare that anything that's been conceived in Satanic wombs, that it'll miscarry. It will not be able to carry forth any plan of destruction, any plan of harm.

White's bizarre miscarriage "command" followed a long rant, which included the following remarks:

## **Tennessee Should Put Kids First And Reject Discrimination**

The very first thing the Tennessee Senate did when it reconvened in January was pass a bill to allow discrimination that would harm children in foster care. HB 836, passed by the House last year, would authorize taxpayer-funded foster care agencies to turn away couples seeking to foster or adopt children because they are LGBTQ or the "wrong" religion.

Republican Gov. Bill Lee said he intends to sign this harmful bill (even telling one news outlet that he already had). If he does, the law would undermine the bedrock child welfare standard that requires these foster care agencies to provide services based solely on what is in the best interest of the child. He will be hurting kids in need of loving homes and the families that want to provide for them.

Across the country, there are more than 111,000 children in care who are eligible for adoption; there are nearly 9,000 kids in foster care just in Tennessee. Many states already face a shortage leaving care without finding their forever family increases.

Our client, Aimee Maddonna, knows the harm these bills can cause. Aimee, a Catholic mother of three, grew up in a family that provided a home for countless children in foster care. She tried to work with Miracle Hill Ministries, a government-funded foster care agency. Miracle Hill initially told her that her family was a great fit to work with kids. But after Aimee told Miracle Hill that she is Catholic, she was turned away because Miracle Hill only works with people who are evangelical Protestants (the agency has since said it will consider Catholics who will sign the agency's statement of faith, which doesn't align with Aimee's beliefs). That's why, with our help, Aimee is suing her home state of South Carolina and the federal government to stop these discriminatory policies.

Aimee isn't alone in facing discrimination. Lydia Currie also reached out to Miracle Hill so that she and her husband could adopt, but she was turned away because she is Jewish. Beth Lesser, who is also Jewish, attended a three-day training to learn more about mentoring children in care but was told on the last day that non-Protestants were not welcome.

If Tennessee's bill becomes law, it's only a matter of time before this kind of religious discrimination could happen in the state. HB 836 undermines religious freedom, which gives Americans the right to believe, or not, as they choose, but it does not give anyone the right to use their religious beliefs to



discriminate against kids and families. That's especially true when organizations, like these adoption and foster care agencies, get public funding to provide a service on behalf of the government. No taxpayer-funded organization should be able to use religion to justify refusing to place them in a safe and happy family because of the religion of the prospective parents.

By signing this bill, Gov. Lee would put the religious beliefs of childplacing agencies ahead of the best interests of the children whom the agencies contract with the state to serve. Instead, he should put kids first. There's still time.

of families willing to take care of these kids. By allowing taxpayer-funded agencies to refuse to work with families that are a different religion or LGBTQ, HB 836 would only compound that problem. Because when an agency refuses to work with qualified parents, children in care face increased wait times, and the number of youth P.S. This bill is part of **Project Blitz**, a nefarious political movement that is sweeping through state legislatures across the country with an agenda aimed at establishing the U.S. as a Christian nation. Project Blitz has the goal of passing an increasingly ambitious set of state laws to incrementally tear down the separation of religion and government, promote prayer in public schools and misuse religious freedom to justify discrimination. AU and allies are tracking Project Blitz and working to block it from spreading. Join us!




