# Antonio Daza: "The Joys and Tribulations of Running for Congress Against a Gerrymander-Protected Incumbent"

AFS is proud to have again a major Atlanta political leader and a highly regarded and popular speaker, Antonio Daza to deliver a talk and lead us in discussion on Sunday, 11 February. We're glad to have this return engagement. Daza is among the most important American freethink-

ing political leaders in the United States." He ran for Congress in 2022 and again this year and last. He has recently suspended his campaign (though many supporters hope he'll remain on the ballot in November). He will talk to us about "The Joys and Tribulations of Running for Congress Against a Gerrymander-Protected

Daza noted, by way of introduction, "As an immigrant, a refugee, a member of the LGBTQ+ community, a small business owner, and an atheist, I am qualified to see where we fall short of addressing true liberty for all people in the United States. As one who has escaped dictatorship, I had a front-row seat witnessing how democracy was overthrown in my home country of Venezuela. Democracy is not a permanent, indestructible system. Democracy is not just a subjective idea. Democracy is a real thing that, if it is taken away, impacts your life in unimaginable ways. I've seen it happen, and I am watching it happen again right now in this county." The nominee of the Democratic Party for the 11th Congressional District against entrenched incumbent Barry Loudermilk, Daza won an impressive 113,571 votes in November 2022 and has run well and hard for 2024though without enough money.

Antonio Daza was a political activist in his home country of Venezuela against the Chavez regime. In 2003, he joined his family in the United States and was granted political asylum until he became a U.S. citizen. In 2008, after years of building a career as a professional ballroom dancer and instructor, Daza opened his own small business. In 2021, he graduated cum laude with a major in Women's, Gender, and Sexuality Studies from

# Members of Congress parcitipate in regressive circus at D.C. Bible Museum

On January 31, House Speaker **Mike Johnson** and other members of Congress participated in an extremist and hate-fueled event at the Museum of the Bible in Washington, D.C.

As we had **noted** prior to the event, the "National Gathering for Prayer & Repentance" was filled with Christian nationalists and conspiratorial extremists, many of whom participated in the event last year, including Johnson.

and declared that "each person, regardless of their race, nationality, [or] language" will serve and praise God, which she claimed formed the United States. Rep. **Greg Steube** (Fla.) similarly promised that "people everywhere shall repent of immorality... and their rejection of God."

Lawmakers in attendance this year knew what to expect — and shamefully supported it with the prestige of their elected offices.

Evangelical preacher Lou Engle, who reportedly helped plant the seeds for Uganda's law punishing homosexuality with death, screamed for a "baptism of fire" that would cause "a hundred thousand LGBT to be saved and transformed." Jon Hamill, another extremist preacher, called for God to "cleanse" the U.S. government so that



it has "no king but Jesus," claiming a betrayal of the country due to "idolatry, witchcraft, false religions and secret orders, secret societies."

Members of Congress in attendance joined in the Christian nationalist fever dream, such as Rep. Maria Elvira Salazar (Fla.), who proclaimed that the assembled group had "tied the hands of Satan and all his demons,"

In addition, Antonio is a passionate, high-energy community outreach leader with philanthropy experience and a record of surpassing goals for capital campaigns and fundraising initiatives while driving continuous improvements across various nonprofit operations.

Antonio Daza is an action-oriented political organizer with a substantial track record of success directing and driving long-range outcomes, developing policies, and cultivating procedures; a lifelong advocate for freedom, justice, and equality.

Expect to learn much more about elections, voting, and the advantages and problems—and there are \$ome—of running while an atheist or gay man. There will be time for some questions.

Because AFS is a 501-c-3 educational organization, we do not endorse candidates or parties in public elections. But we are certainly interested in such elections, many of our members are quite avid political activists, and AFS Hall is, as it happens, in the 11th Congressional District. We invited Congressman Loudermilk, but he turned us down, pleading a scheduling conflict (though we had expressly indicated interest in him speaking on any second Sunday).

We're always pleased to provide great programs for our members and visitors, and we are glad we'll be continuing 2024 with another good one.

Other lawmakers turned to politics, with Rep. Chris Smith (N.J.) calling abortion a "weapon of mass destruction" and complaining about the government funding Planned Parenthood, and Rep. Randy Weber (Texas) lamenting that we have legalized same-sex marriage and claiming that we had kicked God out of schools and replaced it with "drug-sniffing dogs, metal detectors, and armed police officers."

Right Wing Watch reports that other members

of Congress in attendance included Reps. Josh Brecheen (Okla.), Mark Alford (Mo.), Michael Cloud (Texas), Diana Harshbarger (Tenn.), Kevin Hern (Okla.), Gary Palmer (Ala.), Rick Allen (Ga.), Brandon Williams (N.Y.), Bob Good (Va.), Tracey Mann (Kan.), Glenn Grothman (Wis.), Warren Davidson (Ohio), Mary Miller (III.), Cathy McMorris Rodgers (Wash.), and Sens. Katie Britt (Ala.) and James Lankford (Okla.).

FFRF reiterates that this event is a showcase of what happens when extremist lawmakers allow their personal religious beliefs to dictate their policy work, rather than upholding the crucial American value of ensuring a secular government.

Members of the Congressional Freethought Caucus recently documented the shocking and underreported extent of Speaker Johnson's Christian nationalist history. Johnson's involvement in this event should serve as a major wake-up call to Americans, who must demand their elected representatives defend true religious liberty by championing the fundamental American principle of secular governance.

### **On Running for Public Office**

Have you ever thought about running for public office? What matters most about deciding to do something like that—time, money, ego, agreeing with voters on the issues, strong commitment to a particular issue, or ... ?

Maybe you just want to be sure that someone like you—an old white irreligious Southern short-ish guy with a lame sense of humor, say—is represented in the state legislature.

Maybe you think a specific incumbent is a wrong-headed jerk and you want somebody to run against him—even if he's gerrymandered into place so firmly that there's little hope of anyone unseating him.

Or your ego is so fragile that the idea of adoring crowds following you around begging to shake your hand, however improbable, drives you to seek the limelight.

Should you run, especially for legislative office, more to promote ideas and your preferences, to shape what voters think, to promote the common good, or to represent the preferences of voters? Issues related to this are sometimes referred to as deciding whether elected legislators are delegates or trustees. As Edmund Burke famously said in 1790—

Parliament is not a congress of ambassadors from different and hostile interests, which interest each must maintain, as an agent and advocate, against other agents and advocates; but Parliament is a deliberative assembly of one nation, with one interest, that of the whole... You choose a member, indeed; but when you have chosen him he is not a member of Bristol, but he is a member of Parliament.

(Would I like certain officeholders and office seekers in the US right now to grasp this? Hell, yes.)

Can lust for power and glory and fame drive you into office-seeking, maybe? Or you're sure getting elected will help you get rich, even if a bit of shady dealing might be necessary.

### Wonder what brought George Santos to mind?

Or—and this may be wildly unrealistic—public service appeals to you. Mayhap you think the community deserves an honest, decent, steadfast woman or man with your skills, talents, and knowledge—and you're willing to step up.

Does it take a fortune of your own to make running happen? Should it?

Should you spend some time in the political trenches for other candidates before you become a candidate yourself?

Enough with the Questions, Ed—How About Some Answers?

Disclaimer: I've never run for or held public office. I've engaged in electoral politics in various roles and for decades and I'm a political junkie, even staying up way past my bedtime on election night to watch returns—so I have plenty of opinions, but maybe not much expertise.

I wish far more people would think about running for public office. I think all of us who care who is in office and what the politicians are up to should be willing to donate time, ideas, and money to encourage candidates—and to consider running ourselves.

Running takes commitment—you need time,

### The National Prayer Breakfast is an anachronism that should go away

February Ist was the National Prayer Breakfast (NPB). Americans United is not fond of this event.

The NPB, Americans United has pointed out over the years, is a relic of the misbegotten "civil religion" era of the 1950s. For years the event was sponsored by the Fellowship Founda-

tion (AKA "The Family"), a shadowy Christian Nationalist organization with the chief aim of promoting fundamentalist Christianity among people of wealth, power and status. (You know, just like Jesus did!)

The Family held the event in Washington, D.C., hotels for decades but relinguished control of it last year - kind of. This year, the prayer breakfast took place in the Statuary Hall of the U.S. Capitol, which actually makes things worse by drawing it closer to the seat of government.

(Plus, several people connected to The Family are still involved.)

As AU President and CEO Rachel Laser told reporters, "Our public officials should not be organizing and promoting religious worship services

support from family and friends, and money. You need to not be shy. You need to be focused and self-aware. You need to know why you're running and to be able to tell others.

Identity? Only incidentally, in my opinion. What matters is not your ethnicity or age or height or sexual identity or religion, but what you think government's roles should include and what those rules should not include; what rules or policies or legislation will have what effect and what unintended consequences might follow. Your character and respect for your fellow citizens and ability to negotiate good compromises are far more important, generally, than how you identify.

As to representing others or promoting ideas, I'd urge balancing both. And I'd insist that doing both requires honesty, accuracy in communication (sometimes bluntness), and transparency, in your campaign and in office if you win. Voters who want to know if you agree with them on an issue that matters to them should be able to tell.


Much of what is best about seeking office does not take much moneygreeting and getting to know voters, talking informally and speaking to the local Rotary club or retirement community, ringing doorbells, and answering questions. But even a heavily ground-game-based campaign for school board-with little or no TV ads or billboards-takes some gas money, meals money, and printing money. However, the biggest cost, by far, for that sort

of campaign may be lost income. Even if you don't have to quit your job to run (and you might), you cannot be as available for overtime or for preparing a good sales pitch for your company's products. And especially if you do quit your job or close your business, you still gotta do things like eat, pay for childcare, pay rent or mortgage payments, and such. But remember, I'm trying to talk you into doing this, not out of it.

So what do you gain? Maybe some of that fame, glory, attention, ego-gratification I mentioned earlier.

But strong satisfaction at accomplishing something worthwhile, decent, and honorable, even if you lose, may be the greatest reward. You can make people think, convince them that they are not alone, offer a real alternative, and promote the common good.

And if you run and win, imagine the good you can do.




