Suzi Ehtesham-Zadeh

The daughter of a highprofile Iranian doctor and a small-town American science teacher. Suzi Ehtesham-Zadeh was born in Washington, D.C., came of age in Iran during the Shah's era, and later traveled back to the United States to attend university, receiving a degree in philosophy from Stanford University in 1978. The Islamic Revolution began brewing during her senior year at Stanford, and shortly after

graduating she returned to Iran and plopped herself down in the middle of it. She later moved to Spain, where she met and married a Spaniard, thus weaving a third cultural strand into her identity.

A career English teacher, Suzi has taught students in public schools, private schools, and universities on three continents and in three languages. She has taught ESL to children in Honduras, World Literature and Linguistics to university students in Tehran, IB Literature and Theory of Knowledge to high school students in Spain, Creative Writing to undergraduates at Boston University, and Literature and Composition to middle school, high school, and university students in Georgia.

Alongside her teaching career, Suzi has maintained a second career as a writer, editor, and translator. Rather late in life, she received an MFA degree in Creative Writing from Boston University, where she had the privilege of studying with National Book Award winners Sigrid Nunez and Ha Jin and Pen/Hemingway Award winner and New York Times Bestselling author Jennifer Haigh.

Suzi's fiction has appeared in The Georgia Review, Fiction International, Glassworks Magazine, Narrative Northeast, Mobius Journal for Social Change, Quiddity International Literary Journal, and elsewhere. Her recent story collection, titled

## Singer Anita Bryant Leaves Legacy of Homophobia and Extremism

Singer Anita Bryant died Dec. 16, though her death wasn't widely reported until Jan. 10. The headlines announcing her death were very similar to this one run by the Associated Press: "Anita Bryant, a popular singer who became known for opposition to gay rights, dead at age 84."

Bryant launched one of the nation's first anti-LGBTQ+ crusades in Dade County, Fla., which in 1977 passed an ordinance that barred discrimination in employment, housing and public services on the basis of sexual orientation.

A former beauty queen, Bryant was an Oklahoma native who had relocated to Florida with her husband (whom she later divorced). A fundamentalist Christian, she was appalled by the new law and began insisting, against all available evidence, that it would force Christian schools to hire gay men and women as teachers. (In fact, the law didn't apply to private schools.)

#### 'Save Our Children'

Bryant started a campaign, dubbed "Save Our Children," to overturn the law. The emphasis on children was intentional: LGBTQ+ people were tarred as a threat to children, a threat to families, a threat to America.


But eventually, Bryant and her supporters overreached. One of them, John Briggs, a California state senator, proposed Prop. 6, which would have barred gay men and women from teaching in the state's public schools as well as banned "public homosexual conduct." Critics said that provision was so broadly worded it could have made it illegal for state employees to express support for LGBTQ+ rights. Many conservatives opposed Prop. 6, which was defeated in 1978 with more than 58% voting no.

# The LGBTQ+ community strikes back

Bryant's activism also put LGBTQ+ Americans on notice: They were under assault. In response,

If these tactics sound familiar, there's good reason for that: Christian Nationalists still use them today. In fact, much of the hate and extreme rhetoric we hear from Christian Nationalists today about LGBTQ+ rights comes from a playbook penned by Bryant.

As I noted in a Church & State article last year, "During the



#### 'They must recruit!'

"Homosexuals cannot reproduce, so they must recruit," Save Our Children argued. "And to freshen their ranks, they must recruit the youth of America."

Bryant went so far as to compare LGBTQ+ rights to "murderer rights."

Sadly, Bryant's hateful crusade was initially successful, and voters overturned the Dade County ordinance. Flush with that victory, she went on to successfully challenge gay-rights ordinances in St. Paul, Minn.; Eugene, Ore.;



they increased their mobilization, and gayrights activism became more high profile. Slowly, the tide began turning in America. Polls now show solid support for LGBTQ+ rights, but these rights are coming under sustained assault since **Donald Trump** assumed the presidency.

As for Bryant, she never wavered in her opposition to

LGBTQ+ rights. Her views were so extreme, she became toxic. Companies that had used her as a spokeswoman dropped her, and Bryant's attempts to reignite her singing career failed. As the time of her death, she was running a ministry in Oklahoma.

Anita Bryant, despite whatever else she may have accomplished, will forever be linked to religious extremism and hateful homophobia. It did not have to be that way, but it's the legacy she chose. It's an unfortunate one indeed.

## Trump Administration's School Privatization Order Defies Will of the People

Again and again and again, voters have rejected school vouchers and other privatization schemes that attempt to defund and dismantle the nonsectarian public schools that 90% of U.S. families choose.

The mandate from the American people to their state and federal lawmakers is clear: Support public schools.

On January 29th, the Trump Administration issued yet another executive order that directly contradicts the will of the people. They justify their wholly unpopular position on school privatization by alluding to a "growing body of rigorous research." This is a lie.

Decades of independent research increasingly demonstrates vouchers do not work. In fact, they exacerbate racial and socioeconomic segregation and lead to declines in academic outcomes. Families in rural areas are particularly harmed by the funding cuts to public schools that accompany these voucher schemes.

And far from saving taxpayers money, privatization policies have proven to be egregiously, unsustainably expensive and rife with abuse. For what? The data shows the primary beneficiaries of so-called "school choice" are the corporations who receive exceedingly generous tax credits and the wealthy families who would have sent their children to private schools even without aid.

In states like lowa, religious schools have more than doubled their tuition rates in order to rake in taxpayer dollars while continuing to keep certain families out. The President's order to "expand opportunities for low-income, working families" indicates he and his Administration either fundamentally fail to understand how these programs operate or, more likely, they don't actually care about the real-world impact that school privatization policies have on the tens of millions of Americans who choose public schools.

Private and parochial schools can, by law, discriminate against students and their families. They are not held to the same rigorous standards as public schools. Until and unless private schools agree to play by the same rules — including nondiscrimination protections and local control they should not receive a single dollar of taxpayer money.

American Atheists will continue to work tirelessly with partners across the country to protect students' civil rights, defend the separation of religion and government, and ensure that nonsectarian public education receives the funding and support it needs to serve all of our nation's students.

## God's Gender: A Guerrila Campaign to Knock Sense into Right-Wing Christians

From the beginning, Christians have insisted that gender is not about genitalia.

Today, all of a sudden, most American Christians have changed their minds.

Christians insist, now, that sex and gender and genitalia must all be about the same: you can't have a sex or a gender that doesn't correspond to whatever your genitalia is.

Make that your genitalia at birth. As determined at conception.

Christians didn't used to believe this.

Christians didn't believe this in the 1980's when I was a young atheist trying to make sense of Christian beliefs.

Back then, I thought I was being smart in pointing out that God should not be referred to as He or Him—for the obvious reason that God, by definition, doesn't have a penis.

Shoot, God doesn't even have a body.

My Christian friends pushed back intelligently, explaining that one's gender was distinct from one's sex: that, in fact, gender was not tied to genitalia at all. And this distinction was why God, body or not, could be masculine. And was masculine as a matter of religious faith.

Okay, I could see they had a point.

This was the 1980's and I (who previously had never thought about the distinction between sex

and gender) was forced to realize that the issue was more complex than my simplistic gender = genitalia assumption.

So I backed off on referring to God as It.

Fast-forward to today.

Now most Christians have changed their mind. They have decided that sex = gender = genitalia is exactly right.

Even more so, it's got to be the genitalia you were born with.

Here's the new Christian theology: If you were born with a vagina (or with XX chromosomes, in some accounts) you are the female sex and gender, and if you were not then you are not. If you were born with a penis (or with XY chromosomes, in some accounts) you are the male sex and gender, and if you were not then you are not.

What about God?

Was God born with penis or vagina or chromosomes of any sort?

No.

God wasn't even born.

Therefore: God is neither male nor female, neither masculine nor feminine.

Hmm....

That's right, Christians now think the atheist back in 1980 was right all along.

God is an It after all.

Here's my modest proposal:

I propose that atheists—and transgender people and Democrats and old-fashioned Christians start referring to God as It in every instance.

And each time a Republican refers to God as He or Him, call them out for their wokeness.

Indeed, thinking the way these Christian Republicans think, it should be illegal to misgender God

> as male or female.<sup>1</sup> (Certainly it's blasphemous, so why not write it into our laws? We are a Christian nation, right?<sup>2</sup>)

God is an It. This is their theology.


