Books in Student Libraries—Who Decides?

Probably everyone—or nearly everyone at least—would agree that in public school libraries—elementary, middle, high school—there should some restrictions. Few would think that books that feature graphic pornography, malicious racism, virulent anti-human rights and the like shouldn't be kept out.

But students should, surely, be able to read material that widens their horizons, educates them enough to see that their own ideas are not the only ones, wakes them up to perspectives they haven't considered or don't like, and enlightens them about history that makes them uncomfortable. And what is available should include books that present different, even contradictory views. Education, not indoctrination, is the goal.

Should parents be able to exercise any veto power over what their children read? Even if one answers "Yes" (and not everyone would) there's still room for differences related to age and—probably—to subject matter.

Perhaps the questions of what books are made available to students should be settled and controlled by religious organizations?

Or maybe Darwin's On the Origin of Species (1859) should be excluded—

or should be the only work on biology on the shelf?

Or settle book choices by political parties governed by religious principles. What could go wrong?

If political parties, operating through school boards or state legislatures, set the standards, that would mean effectively that majorities could decide—and this is supposed to be a democracy, as everyone knows. Problem solved.

But what if the majority oppose democracy and just vote to let the pastor

of the biggest church in town choose. Or the majority is white and wants only books that describe white people as smarter to be in the library. Or the majority decides that a book that includes this—

There she lusted after her lovers, whose genitals were like those of donkeys and whose emission was like that of horses.

must be rejected even for high school students, no matter what the context is.

(And yes, that book *is* in most public school libraries—and should be, in my never humble opinion.)

Are there books in school libraries that describe white people unambiguously as superior? There are—and there should be—in the form of Mark Twain's finest novel, *The Adventures of Huckleberry Finn* (1884), that includes one of most off-handedly racist passages (about a steamboat accident) to be found anywhere. According to a *Gale Review*,

Soon after it was published, the public library in Concord, Massachusetts, refused to carry *The Adventures of Huckleberry Finn* because of

its perceived crudeness. This ban turned into a publicity coup for Twain and his book. In a letter published in the Hartford Courant, the author responds gratefully, noting that "one book in a public library prevents the sale of a sure ten and a possible hundred of its mates." Twain also notes that the library's newsworthy action will cause the purchasers of the book to read it, out of curiosity, instead of merely intending to do so ... and then they will discover, to my great advantage and their own indignant disappointment, that there is nothing objectionable in the book after all.

Let's get serious—however much books in public school libraries should be restricted, everyone

would surely agree that it is quite unreasonable to let parents restrict the reading of other people's children's. Or to let the Muslim imam decide for the Catholics or vice versa. Or to let political parties, even if they do represent the majority, decide on political or religious grounds.

So is there no answer?

There is, and it's parallel to letting biologists determine what should qualify as the right things to teach in biology class: professional librarians should decide.

A librarian can be counted on to know that, whatever Ezekiel 23:20 says

about horse and donkey genitals, the *Bible*, like the *Qur'an* or the *Tanakh* (or *Torah*), is culturally important enough to have available on the shelves of an American public school library, at least for high school students.

A librarian can be counted on to know that Twain's characters' racism was clearly in service of satirizing racism—and an exquisite example of the power of irony.

We don't need preachers and political parties choosing books for students. We need teachers and librarians, because we must support education.



Honor Nex Benedit by fighting to protect queer and trans kids

Nex was a straight-A student who enjoyed drawing, nature, and their cat, Zeus. Nex played Minecraft and listened to rock music with their friends. Nex deserved so much more from this world.

Nex Benedict, a transgender, 16-year-old teenager from Owosso High School in Oklahoma, died on Feb. 8, 2024, after enduring a violent assault in the school restroom the day before.

Nex traces their heritage to the Choctaw Nation, where they lived on the Cherokee Nation Reservation. Nex loved cooking, reading, and their favorite show was "The Walking Dead." Like many of us in the transgender community, Nex was on a journey of self-discovery that resulted in persistent bullying and harassment in school. Nex's grandmother, Sue Benedict, told the *Independent* that despite these hardships, "I was so proud of Nex. He was going someplace; he was so free."

Heartbroken doesn't begin to describe the grief felt throughout the LG-BTQ+ community. And yet, this feeling is all too familiar for so many of us who have lost loved ones due to violence. According to the Human Rights Campaign's Fatal Violence Report, there were at least 32 deaths of transgender and gender non-conforming people in 2023. There have been at least two recorded deaths in 2024 and it's only February as of this writing.

Let me be clear – every single one of those lives was a life taken too soon and in vain. And yet there is something about Nex's death in particular that rubs salt in the wound. Many in the LGBTQ+ community relate Nex's death to that of Matthew Shepard in 1998, a 21-year-old gay college student at the University of Wyoming who was attacked and left to die. History repeats itself if we do nothing to change it.

This tragedy is only the most recent manifestation of the harms of policies crafted by Christian Nationalists. Ten states, including Oklahoma, have passed bathroom bans, prohibiting transgender students from using the bathroom consistent with their gender identity. Make no mistake, Nex's death is a direct consequence of this legislative vitriol.

Fight to protect queer and trans kids

Nex's death places this country at an inflection point with the transgender community. We can choose to allow another year to unfold where marginalized children are the **punching bags** of political discourse (and we know it will be worse than ever since it's an election year), or we can declare that enough is enough and we refuse to lose another life.

Now more than ever, I want transgender and LGBTQ+ youth to know that you are loved, your light is so much brighter than their hate, and they can't take that away from us. We have to keep fighting because queer and trans kids deserve to grow up in a world safe from violence. And because I believe in a tomorrow Nex can be proud of

Good news: Most Americans continue to oppose Christian nationalism

The Freedom From Religion Foundation welcomes the recent findings that approximately two-thirds of Americans do not support Christian nationalism. It's truly good news that 57 percent of Americans "completely disagree" that U.S. laws should be based on Christian values, two-thirds completely disagree that being Christian is an important part of being truly American, 70 percent completely disagree that the U.S. government should declare America a Christian nation, 60 percent that we would not have a country anymore if the "U.S. moves away from our Christian foundations" and three-quarters that "God has called Christians to exercise dominion over all areas of American society."

The Public Religion Research Institute surveyed 22,000 adults throughout last year as part of its American Values Atlas and was able for the first time to research attitudes on Christian nationalism in all 50 states. The research finds that roughly three in 10 Americans qualify as adherents (10 percent) or sympathizers (20 percent) of Christian nationalism while 30 percent reject it and 37 percent are skeptical. These percentages are consistent with responses since PRRI started asking these questions in late 2022.

Notably, if not surprisingly, the group with the most bragging rights for agreeing least with Christian nationalism is the religiously unaffiliated: 61 percent reject it and 31 percent are skeptical. Jewish Americans are second-least supportive, followed by religious non-Christians.

Also not surprisingly, majorities of white evangelical Protestants and other Protestants of color fall into the Christian nationalist camp, with a near-majority of Hispanic Protestants close behind. However, it's heartening that majorities of Mormons, Black Protestants, other Christians, white mainline Protestants, white Catholics and white Hispanics reject or are skeptical of Christian nationalism.

Among other significant findings:

- "Residents of red states are significantly more likely than those in blue states to hold Christian nationalist beliefs." In red states, the number of Christian nationalist leaners is nearly four in 10. In five states, more than 45 percent of residents are Christian nationalist adherents or sympathizers: North Dakota, Mississippi, Alabama, West Virginia and Louisiana.
- "At the national level, Christian nationalism is strongly linked to Republican Party affiliation and holding favorable views of Trump." Republicans at 55 percent are twice as likely as independents and three times as likely as Democrats to hold such views.
- "Christian nationalism is strongly linked to evangelical/born-again identity and frequent church attendance." Majorities of white evangelical Protestants and Hispanic Protestants hold Christian nationalist beliefs. Christian nationalists are more likely to believe in modern-day prophecy, spiritual healing and the prosperity gospel. Of those who attend religious services weekly or more, 52 percent are Christian nationalist adherents or sympathizers, compared with 38 percent who attend a few times a year and 18 percent who seldom or never attend.
- "Christian nationalists are more likely than other Americans to see political struggles through the apocalyptic lens of revolution and to support political violence." Some of the disturbing findings are that a majority of Christian nationalist adherents and sympathizers agree that "there is a storm coming soon that will sweep away the elites in power and restore the rightful leaders." They are about twice as likely as other Americans to believe political violence may be justified.
- "While there is little variation in support for Christian nationalist beliefs by race or ethnicity alone, Christian nationalist beliefs are refracted through racial and ethnic identity, which produces divergent political outcomes among white, Hispanic and Black Americans." For example, among white Americans and Hispanic Americans — but not Black Americans — holding Christian nationalist beliefs is strongly correlated with Republican Party identity and support for Trump, according to PRRI.

The research is a follow-up from the major national survey PRRI released a year ago. As FFRF observed last year when that study came out, this is generally reassuring news for secularism. PRRI gauges Christian nationalist leanings based on adherence to the following statements:

- The U.S. government should declare America a Christian nation.
- U.S. laws should be based on Christian values.
- If the United States moves away from our Christian foundations, we will not have a country anymore.
- Being Christian is an important part of being truly American.
- God has called Christians to exercise dominion over all areas of American society.

"This survey generally speaks well of the American people's commitment to pluralistic values," maintains FFRF Co-President Annie Laurie Gaylor. "But let's remember the caveat by Katherine Stewart in the new documentary, 'God and Country,' who points out that in a country where 40 to 50 percent of the people don't vote, you don't need a majority to dominate an election cycle." That's why it's so important that nonbelievers and other "Nones" get out the vote. The "Nones," at 28 percent of the population, could cancel out the vote of Christian nationalists.


