Jenny Brown to talk on *Birth Strike: The Hidden Fight Over Women's Work*

On Sunday, May 12, Atlanta Freethought Society is fortunate to have **Jenny Brown** as our speaker. She will be talking about her book *Birth Strike: The Hidden Fight Over Women's Work*.

When House Speaker Paul Ryan urged U.S. women to have more children, and Ross Douthat requested "More babies, please," in a *New York Times* column, they openly expressed what policymakers have been discussing for decades with greater discretion.

Using technical language like "age structure," "dependency ratio," and "entitlement crisis," establishment think tanks are raising the alarm: if U.S. women don't get busy having more children, we'll face an aging workforce, slack consumer demand, and a stagnant economy.

Feminists generally believe that a prudish religious bloc is responsible for the protracted fight over reproductive freedom in the U.S. and that politicians only attack abortion and birth control to appeal to those "values voters." But hidden behind this conventional explanation is a dramatic fight over women's reproductive labor. On one side, elite policymakers want an expanding workforce reared with a minimum of employer spending and a maximum of unpaid women's work. On the other side, women are refusing to produce children at levels desired by economic planners. By some measures our birth rate is the lowest it has ever been. With little access to childcare, family leave, health care, and with insufficient male participation, U.S. women are conducting a spontaneous birth strike.

In other countries, panic over low birth rates has led governments to underwrite childbearing and

childrearing with generous universal programs, but in the U.S., women have not yet realized the potential of our bargaining position. When we do, it will lead to new strategies for winning full access to abortion and birth control, and for improving the difficult working conditions U.S. parents now face when raising children.

Jenny Brown is a **National Women's Liberation** organizer and former editor of *Labor Notes*. She was a leader in the grassroots campaign to have "morning-after pill" contraception available over-the-counter in the U.S. and was a plaintiff in the winning lawsuit.

In addition to *Labor Notes*, her work has appeared in *Jacobin*, *Huffington Post*, and *Alter-net*, and she is coauthor of the Redstockings book *Women's Liberation and National Health Care: Confronting the Myth of America*. She is the author of *Without Apology: The Abortion Struggle Now*.

Thanks for your participation and let's have a great time doing it!

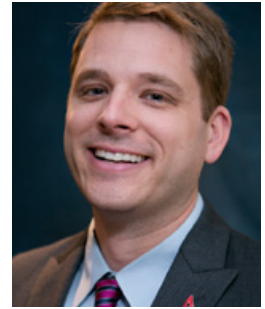

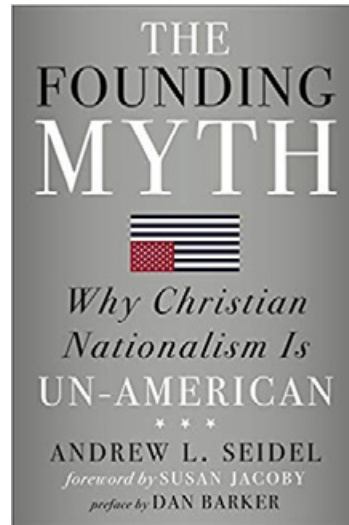
The Founding Myth: Why Christian Nationalism is Un-American

American Atheists condemns Health and Human Resources for putting religion ahead of healthcare

On May 2nd, American Atheists denounced a new “conscience rule” released by the Department of Health and Human Services (HHS). This final rule, which will now go into effect, allows health care providers, including hospitals and pharmacies, to deny treatment on the basis of religious disapproval.

“This new rule enshrines extreme religious viewpoints into law at the expense of the health and safety of millions of Americans,” said **Alison Gill**, Vice President for Legal and Policy. “With these changes, the **Trump** administration is putting the religious dogma of a few fundamentalists above the lives and well-being of women, elderly people, LGBTQ people, and others by allowing doctors and hospitals to refuse to provide necessary medical care to patients they disapprove of.”

“This has nothing to do with protecting religious freedom,” said **Nick Fish**, President of American Atheists. “This is about the Trump administration doing everything in its power to advance the extreme ideology of religious supremacists, even if it will result in the deaths of women and LGBTQ people. It is sad that this president is so transparently willing to trade lives for Evangelical votes.”

“Discrimination in health care is far too common already, and the Trump Administration is making it worse,” added Gill. “For millions of Americans who live in small towns across the nation, finding a different hospital, doctor, or pharmacist simply isn’t an option, especially when it’s an emergency.”

When this religious refusal rule was first proposed in January 2018, **American Atheists** **stridently opposed it**. This rule will allow a much broader range of people and entities involved in patient care—including insurance companies, receptionists scheduling appointments, and hospital administrators—to use religion to justify limiting patients’ access to needed health care.

“This attack on health care and access to reproductive services is just the latest action by the Trump administration to allow religion to be used as a weapon against the most vulnerable,” said Fish. “The American people see this for what it is—a cynical attempt to put religion above policy and dogma above people’s lives.”

Trump uses National Day of Prayer to announce discriminatory measures

As Americans United suspected, President **Donald Trump** used the May 2nd observance of the National Day of Prayer to unveil two new initiatives that are likely to be very harmful.

Trump announced a new rule giving health care workers the right to cite their religious beliefs to deny care to patients and said his administration will take steps to ensure that faith-based adoption and foster care agencies that receive taxpayer funding can turn away anyone who fails to meet their religious test.

As I noted May 1, this new denial of care rule is likely to fall hard on members of the LGBTQ community, but others – women seeking reproductive care, single moms, non-Christians, non-theists, etc. – could easily take a hit as well. Anyone could be at risk. Basically, what the Trump administration wants to do is give people the right to use their religion as a vehicle to discriminate and deny services to others, including medical care. Under these rules, your rights – and perhaps even your life – may hinge on someone else’s faith.

HHS has already released the new **denial of care rule**. Americans United’s legal and public policy teams are analyzing it. You’ll hear more from us on this rule soon.

Trump’s administration already has empowered taxpayer-funded foster care agencies in South Carolina to discriminate against prospective parents and volunteers who want to help children in need of loving families. AU’s client, **Aimee Maddonna**, has already been a victim of this discrimination when an evangelical Christian agency turned her away solely because she’s Catholic – the “wrong” kind of Christian for Miracle Hill Ministries. **AU is suing** on Aimee’s behalf to put an end to this practice that puts the religious beliefs of agencies ahead of the best interests of children.

You can call these policies lots of things, but it’s certainly not religious freedom. Religious freedom is a treasured right of the American people, but it bestows no power on a person to discriminate against others or treat them as second class.

Americans United is not about to let the Trump administration and its Religious Right allies subject Americans to oppressive and dangerous forms of discrimination, especially under the guise of the noble principle of religious freedom.

The balance of Trump’s remarks consisted of his usual mix of falsehoods and braggadocio. Trump claimed that he made it possible for houses of worship “to speak your mind” by repealing the Johnson Amendment, which protects the integrity of tax-exempt, nonprofit groups, including houses of worship, by ensuring they don’t intervene in partisan politics by endorsing or opposing candidates. Trump claims this frequently, but it’s not true. The Johnson Amendment **remains the law**.

Trump also asserted that people were afraid to say “**Merry Christmas**” before he took office, but now that’s changed – another lie. Trump also claimed that his administration was protecting faith communities, but then enumerated a few examples of the devastating violence that has been directed at houses of worship and people of certain faiths in recent months. Trump failed to acknowledge that his own xenophobic rhetoric has emboldened white Christian nationalists, neo-Nazis and racists who threaten religious freedom.

In short, it was another lousy day for religious freedom at the White House.

The unconstitutional National Day of Prayer and how to fight back

Some weeks, our attention is focused on a certain subject, and this week it was the misbegotten National Day of Prayer.

“The officially sanctioned National Day of Prayer — observed on May 2 this year — goes against the spirit of the secular Constitution,” **FFRF Co-President Annie Laurie Gaylor asserts in an op-ed written for the *Tribune News Service*** and published in the *Atlantic City newspaper*. She uncovers the evangelical origins of the day (hint: it involves a certain Rev. Graham) and contends that “it’s high time to end this phony tradition.”

In our “**Newsbite**” segment, FFRF Director of Strategic Response **Andrew Seidel** provides a primer on the unconstitutional nature of the day.

So why isn’t such a day illegal? Andrew explains in a column for *Rewire News*.

“When the Freedom From Religion Foundation sued over the National Day of Prayer statute in 2010, the district court correctly decided that it violated the First Amendment,” **he writes**. “On appeal, the 7th U.S. Circuit Court of Appeals did not disagree — it couldn’t — but it tossed the case. The court said that FFRF could not challenge the law in court, writing of its decision: ‘If this means that no one has standing, that does not change the outcome.’”

That’s why we have to suffer through the day every year — as well as endure the incredible amount of religious pandering that politicians engage in during the observance.

No one can outdo President **Trump** when it comes to such pandering, and he again rose to the occasion this week. This year, he actually started his groveling the evening before the day by boasting of his plans for a theocratic judiciary — a plot we’re doing our best to counter.

“FFRF has worked to stop some of the worst nominees, including **Jeff Mateer**,” **we said**. “We’ve seen some success, but not nearly enough. We need more members and more support, and we need this today.”

Trump continued his pandering at the National day of Prayer gathering at the Rose Garden by retelling a fib directly involving us: that he has gotten rid of the law that bans church electioneering.

“Trump is referring to the religious freedom executive order he signed on the National Day of Prayer in 2017,” **we wrote in a press release**. “FFRF sued him over that order the same day — and we prevailed. Trump’s attorneys admitted in court, ‘The [executive] order does not exempt religious organizations from the restrictions on political campaign activity applicable to all tax-exempt organizations.’”

Trump capped off the event by issuing a new Department of Health and Human Services religious rule that, **as we pointed out**, “could possibly endanger millions of Americans.” Not exactly the right thing to do for the head of a constitutionally secular country.

But we in the secular community aren’t taking the whole National Day of Prayer nonsense lying down; we’re fighting back. We have designated this week the Secular Week of Action, and **on our Facebook Live “Ask an Atheist”** feature, FFRF Co-President **Dan Barker** and Legal Assistant **Kristina Daleiden** are joined via Skype with **Sarah Levin** of the Secular Coalition of America to discuss what the week actually means for us secular activists.

Sweet constitutional victories

We won a sweet victory in New York.

“The Clymer Central School District will no longer host a baccalaureate

service ahead of graduation in addition to removing prayer from the opening and closing of commencement,” **the local paper reports**. “The decades-long tradition will end following a notice from the Freedom From Religion Foundation asking the school district to end what it viewed as ‘unconstitutional practices.’”

We also got a large bible verse painting removed from a California school. “The illustration of a bible verse on school property undeniably paints the picture that the school endorses that religious message,” **Annie Laurie noted**.

A sinister U.S.-Europe nexus

We delved into international matters, too. After noting Trump’s National Day of Prayer remarks on our radio show this week, we spoke with U.K. journalist **Nandini Archer**, who worked on the news site *Open Democracy*’s recent eye-popping report on how the U.S. Religious Right has funneled tens of millions of dollars to the European far right. **Don’t miss this interview**.

Made homeless twice over

And we put up an extremely poignant blog by a Pakistani freethinker who’s been made homeless once again due to reprisals after the Easter Sunday bombings in Sri Lanka.

“We would never choose to come to Sri Lanka if it was safe for us in Pakistan,” **he writes**. “And now Sri Lanka has become Pakistan.”

We had more cheerful news to announce, too. An advocate who captured national attention for standing up — at great length — for abortion rights is a headline speaker at the Freedom From Religion Foundation’s 42nd annual convention in Madison, Wis. **Wendy Davis**, who catapulted into prominence in 2013 when she held a marathon filibuster to protect women’s reproductive freedoms in Texas, will receive FFRF’s 2019 Forward Award in October. Davis will be played in a forthcoming biopic by a major Hollywood star.

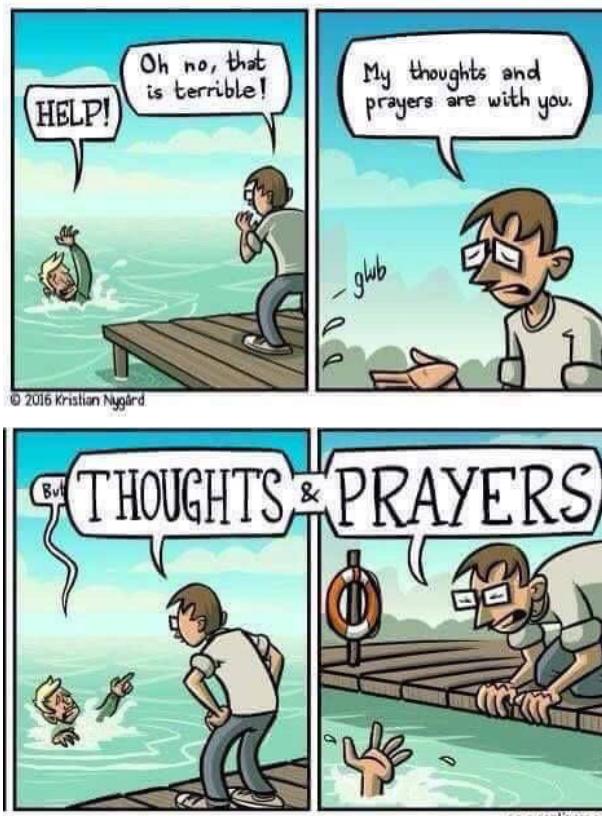

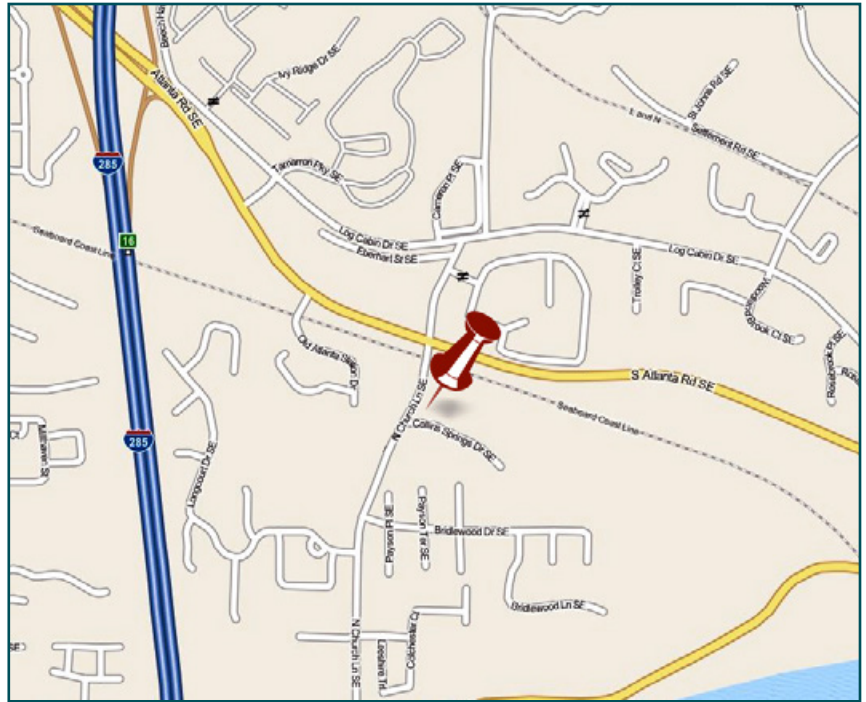
