
few minutes of social distanced (seriously distanced!) socializing starting about 12:30 P.M. EDT for those interested.

Canceling Comedians While the World Burns: A Critique of the Contemporary Left Ben Burgis

Zer0 Books, 2021, \$16.95 paperback

Life is nuanced, complex, contradictory, and hard to understand. A decent living wage, socialized healthcare for everyone, racial and gender equality, and workplace democracy matter—and so does having a good laugh. Moreover, getting people to care about and understand what democratic socialism is, and working for it, means keeping a sharp focus; it means "staying on message."

In his new book, Canceling Comedians While the World Burns: A Critique of the Contemporary Left, Ben Burgis wants the Left to stay on message. He's not saying that personal choice of pronouns or avoiding "triggering" words don't matter. He does not argue for being politically correct or for ignoring political correctness. He argues, quite cogently, for focusing on what matters most, for paying serious attention to priorities. And, as his previous book (Give Them an Argument: Logic for the Left, 2019) demonstrated, he knows how to argue.

Much of what Burgis presses in Canceling... can be summed up in one memorable sentence: "[P] oring through a standup special or any other work of art for moral and political flaws is usually a silly exercise that only serves to reenforce the worst image of the left in the minds of the undecided."

Burgis likes Dave Chappelle, and he uses Chappelle's work to illustrate his theme. In one riff, Chappelle tells the audience that they'll have to guess who it is:

"Duh...hey...der...if you do anything wrong in your life and I find out about it, I'm going to try to take everything away from you. And I don't care when I find out. It could be today, tomorrow, I5, 20 years from now, if I find out, you're fucking finished."

After the crowd shouts out a few guesses, he tells them, "That's right. That's you! That's what the audience sounds like to me."

Writer Barbara Ehrenreich came under fire for a now-infamous tweet about decluttering expert Marie Kondo. Burgis de-

fends Ehrenreich eloquently, pointing out that she has been "an anti-empire activist since the presidency of **Richard Nixon**, who "served for a long time as an Honorary Co-Chair of the DSA." He explains that anyone familiar with her work would understand her intent. Most tellingly he demonstrates that piling on about Ehrenreich's tweet, even if it had been narrowly accurate to do so, would have been misguided, foolish, and dangerous.

As this book makes clear, much too often, we on the Left sound like people determined to take everything away from what we really ought to care about, to make some ephemeral moral or political point. Or just to ruin a joke.

Because he has broad and deep knowledge of socialism, history, humor, and logic, Burgis manages to educate us about Joseph Stalin, Jeff Bezos, the French Revolution, Nathan Robinson, "tankies," Natalie Wynn, Mark Fisher, and much more—all without his readers having to break a metaphorical sweat. His writing is that lucid, and he makes reading his words that much of a joy.

Ben Burgis is, in this book and in life, a happy warrior (not at all prowar—but a cheerful, upbeat, ardent socialist activist)—what the late **Christopher Hitchens** considered, positively, a "knee-jerk" leftist—meaning a consistent or predictable leftist. Burgis is a scholar, a philosopher, a professor, and a writer—a frequent contributor to *Jacobin* and other socialist publications and podcasts.

My wife and I had the pleasure recently of hearing Burgis give a talk based on his book to the Atlanta Freethought Society. We had been members and supporters of the Democratic Socialists of America but had let our membership lapse because we perceived a loss of focus by DSA. Hearing Burgis and reading Canceling has persuaded us that we should rejoin. And not merely because DSA is the only strong organizational alternative available (though it is); or because criticism that makes it better can only come from the inside (though that's true, too), but because humor and human decency are necessary but not sufficient. Collective, effective, organized work

is necessary. Ben Burgis is the coach we need, and reading Canceling Comedians While the World Burns is a great start for anyone who wants DSA and the movement not just to be admirable and virtuous but to change the world.

Secular Organizations Call on Biden to Grant Refugee Status to Nonreligious and Religious Minority Afghans

The national human and civil rights organization, American Atheists, in a letter signed by all American members of the international humanist community, Humanists International, has called on the Biden Administration to protect the lives of Afghans, particularly atheists, humanists, and ex-Muslims, as the United States withdraws military forces from Afghanistan.

"Afghans who are atheists, secular humanists, or ex-Muslims, and those who campaign for humanist values, are in imminent danger under Taliban rule," said **Nick Fish**, president of American Atheists. "**President Biden** must take every possible step to protect these vulnerable people. That means expanding eligibility for Special Immigrant Visas, expediting approvals, and getting people on planes immediately."

"Nonreligious Afghans can't afford to wait on paperwork and red tape, while the Taliban is literally going door-to-door searching for them," added Fish.

American Atheists, the American Humanist Association, the American Ethical Union, and Humanists International sent a letter to President Biden on Thursday calling on his administration to extend Refugee Admissions Program Priority 2 designation to Afghan nationals who are likely to face persecution on the basis of religion.

So that the United States can meet the needs of this humanitarian crisis, the organizations have also called on President Biden to issue an Emergency Presidential Determination on Refugee Admissions that raises the number of refugee admissions permissible for FY 2021, and to further increase his administration's commitment for FY 2022 above the previously stated admissions level of 125,000.

On August 15, during Humanists International's 69th General Assembly, the president of the organization, Andrew Copson, called on all national humanist organizations, including American Atheists, to "urg[e] the government of their countries to take whatever action they can—unilaterally and multilaterally—to secure the human rights and equitable treatment of everyone within Afghanistan."

"The things most valued by our humanist movement—freedom of thought, speech, and choice; human rights including of women, LGBTI+ people, and children; knowledge, rationality; human empathy—are the things most hated by the Taliban and those who have allied or will ally with them," added Copson.

"As atheists and humanists, we welcome refugees fleeing persecution into our communities," said Fish, referencing a survey that found that atheists are among the religious demographics most supportive of refugees. "Accepting refugees who are most at risk with open arms is our moral and ethical obligation. And it's what we owe the Afghan people after decades of conflict."

Statement from the AHA on the Texas Abortion Ban

On September 1st, Texas S.B. 8, a law effectively banning abortion as early as six weeks of pregnancy, went into effect, since the Supreme Court failed to act on an emergency request from the Center for Reproductive Rights, Planned Parenthood, and the ACLU. Using a shadow docket and a 5-4 ruling 23 hours later, the Supreme Court refused to block that law. The American Humanist Association is deeply disappointed by this news and outraged by the devastating loss of access to abortions for the 29 million people who call Texas home.

"We're disappointed in the Supreme Court's failure to intervene on Texas Senate Bill 8," comments AHA Deputy Director Nicole Carr, "This nearly outright ban on abortions completely violates the constitutional rights protected by Roe v. Wade and will adversely affect countless people across the state, especially already vulnerable populations."

Under the law, abortions would still be permitted within approximately the first six weeks, however, many providers and abortion rights advocacy groups have said that at least 85% of people seeking abortions don't even know they're pregnant before six weeks. Additionally, even if one knew that early, it would still be difficult to get an appointment within the restrictive time frame. This ban will disproportionately affect lower-income and vulnerable populations, especially those who would be unable to travel to other states for abortion access.

Texas S.B. 8 was intentionally drafted to make it difficult to challenge in court. The state isn't technically enforcing the law as it, instead, deputizes private citizens to sue anyone who "aids and abets" an abortion procedure. This nefarious framing was intentional, as lawmakers behind the policy believe that it enables S.B. 8 to sidestep the rights affirmed by Roe.

"As humanists, we strongly oppose Texas S.B. 8 and urge Congress to protect access to abortion by passing the Women's Health Protection Act (WHPA)," concludes Carr. "Abortion is a human rights issue, as well as a Church-State separation issue. Everyone is entitled to bodily autonomy, and to make the personal decisions that would impact their lives and futures, unrestrained by the religious beliefs of elected officials."

Freedom From Religion Foundation condemns outrageous Supreme Court blow to Roe

In a shocking action, the U.S. Supreme Court issued an **order** just before midnight September 1st officially declining to block Texas's draconian abortion ban.

In a 5-4 ruling, the high court rejected a request to bar enforcement of the law, contending that applicants failed to meet their burden to stay the law. The one-paragraph opinion was unsigned. Gratifyingly, Chief Justice John Roberts joined the court's liberal bloc — Justices Sonia Sotomayor, Stephen Breyer and Elena Kagan — in dissenting.

The Texas law that went into effect Sept. I is the most restrictive abortion law in the country, banning abortion procedures after six weeks of gestation — which is two weeks after a missed period and before most women even know that they are pregnant. Outrageously, the law deputizes private citizens to file civil suits against abortion providers or anyone who assists someone in obtaining an abortion, offering a "bounty" reward of \$10,000 and attorneys' fees for a successful lawsuit.

Roberts, joined in his dissent by Kagan and Breyer, noted that the Texas law is "not only unusual, but unprecedented" and "appears to insulate the state from responsibility." Given the novelty of the law and the questions still before the court, he stated he would have blocked implementation of the law "to preserve the status quo."

Sotomayor, who has become the new voice of dissent on the high court, wrote her own passionate dissent, also joined by Breyer and Kagan, appropriately calling the order "stunning." She termed the law "a breathtaking act of defiance — of the Constitution, of this court's precedents, and of the rights of women seeking abortions throughout Texas." She castigated the majority for "bury[ing] their heads in the sand." Her footnote noted the immediate and devastating impact of the court's failure upon pregnant people in Texas.

Kagan issued her own dissent, also joined by Sotomayor and Breyer, highlighting concerns that the shadow docket ruling departed "from the usual principles of appellate process." She added, "the majority's decision is emblematic of too much of this Court's shadow-docket decision-making — which every day becomes more unreasoned, inconsistent, and impossible to defend."

The unsigned majority opinion acknowledged that the fight is not over, contending "this order is not based on any conclusion about the constitutionality of Texas's law, and in no way limits other procedurally proper challenges to the Texas law, including in Texas state courts."


The case will continue in the lower courts. Later this year, the Supreme Court is expected to hear arguments in *Dobbs v. Jackson Women's Health Organization*, involving the constitutionality of a Mississippi law banning abortions after the 15th week of pregnancy.

"The court's action over the last 24 hours has stripped millions of Texans of their fundamental rights under our Constitution and has effectively overruled Roe v. Wade and Casey v. Planned Parenthood," says FFRF Legal Director Rebecca Markert. "This decision makes clear that we cannot rely on the current Supreme Court — packed with ultraconservative Christian nationalist justices during President Trump's term in office — from abiding by the rule of law. The only path forward is to fix our broken federal judiciary through legislation."
