
Once Upon a Time in a Land Not So Far Away: Georgia's Tugaloo State Park, Bibles, Steve & Phillip Wells, Perry Mitchell & Pam Woodley, & a Fine Thanksgiving Surprise (Or, "What We Did for Thanksgiving")

In April 2013 the **Buckners** went to a Georgia State Park on an impromptu visit to celebrate **Michael's 43rd** 

birthday; we found there nine, yes, 9!, Gideons Bibles in the three bedrooms of the cabin we rented. Complaints led, in fairly short order, to the Georgia Department of Natural Resources ordering all the bibles removed from state park lodging across the state, only to be countermanded in even shorter order by a directive from the Governor and Georgia Attorney General to leave those sacred tomes alone, by god. Though well okay, since there's a First Amendment and all, other books could also be donated and placed in state park cabins, if rules then being worked out were carefully followed. (No rules had ever been needed regarding the Gideons propaganda, of course.)

Lots of hoopla and publicity followed, as well as donations of books, visits to place said books in state parks, and the like. Easily the most generous and impressive donation of books were the fifteen cases (!) of leather-bound, deluxe, *Skeptic's Annotated Bibles* that **Steve** (annotator) **Wells** and his son **Philip** (editor and publisher) **Wells** gave for the effort. These are collectible books, rich with the full text of the entire King James Version of the Bible, with scholarly, comprehensive, wise annotations, a sewn-in ribbon, and serious heft, physical and intellectual. I feared that they might all be wasted, as we certainly did not have (or anticipate having) any effective means of policing the use—or abuse—of these fine books, but the Wells gave anyway. And they came all the way from Moscow\* to Georgia at one point to support our efforts.



Our hope, apparently realized in part, was that the publicity around all this would help us educate Georgians and travelers alike that it is unreasonable and dangerous to allow state government to have a role in religious indoctrination, even if good books got mostly wasted protesting against the "Good Book."

Fast forward six and a half years to ten or twelve days ago—to Thanksgiving weekend 2019. Again we managed to persuade Michael to go with us to a state

park to celebrate (we see him fairly often, but never enough to suit us). We chose a park I didn't remember knowing about before—Tugaloo State Park, on Lake Hartwell near the South Carolina state line. I never thought about the bibles in cabins stuff until we arrived and Michael came out of his bedroom, grinning. In the bedroom we chose, arbitrarily, was the usual Gideons, so we joined Michael's delight at what he'd discovered in his: A Skeptic's Annotated Bible, in good shape, labeled as being for #10 (our cabin) but also including the label we had applied, giving Governor Nathan Deal and Attorney General Sam Olens credit for its presence (see photo for full text of label on the title page).

Imagine someone idly leafing through the Gideons, confused or maybe even appalled at all the sexist, pornographic, absurd, violent, anti-scientific

material it contains. Then imagine that person opens *Skeptic's Annotated Bible (SAB)* to the same parts of *SAB* as earlier consulted in Gideons, to learn that indeed *Song of Solomon* is a pornographic poem or that the *Book of Ezekiel* is mostly truly filthy stuff or that there are a few good bits (even in Ezekiel there are three verses that qualify), some honest bits, some hilarious (mostly unintentionally) verses, many contradictory and/ or unscientific ideas, etc. Wells details all this effectively, and his book is well worth reading

and owning (great reference book and collectible).

So, we had a great start to our Thanksgiving break, mostly thanks to Steve and Philip Wells, and we urge you to buy their fine book.



But how

did that book even get there? Turns out we have two more people to be thankful to (and that my memory isn't what it used to be). In late 2014, AFS members Perry Mitchell and his wife Pam Woodley volunteered to help with the books-tocounter-bibles-in-state-parks program. They're huge fans of Georgia's State Parks and had plans to welcome in 2015 at one, and they agreed to carry 40 copies of this wonderful book with them, to Tugaloo State Park. (There should have been one in each bedroom, but I'm actually thankful there was even one in the cabin at all five years along. Maybe someone was so happy about finding SAB that they "borrowed" a copy, or maybe park management is holding back half the books in case someone borrows or mutilates a copy, or.... Gotta think positive, right?)

# Florida school district should stop taking part in religious football event, FFRF insists

The Flagler County school system is committing a major foul in being a part of an annual religion-suffused football event, contends the Freedom From Religion Foundation in a letter of complaint to the district.

Each year, Flagler County Public Schools participates in a religious event called Football Sunday at the Palm Coast United Methodist Church. Superintendent James Tager, Flagler Palm Coast High School Principal Thom Russell and Mantanzas High School Principal Jeffery Reaves all join in this religious worship service, and the event is attended by members of both schools' football teams, coaches, cheerleaders and the band (which performs there).

Flagler Palm Coast High School head football coach **Travis Roland** said at last year's event:

"I was raised in a Christian household and we can't preach religion in high school, but this opportunity to invite them to come to church gives them the opportunity to hear the word. As a Christian man, I've done my job by at least giving them the open invitation."

It is illegal for school administrators and coaches to organize or participate in religious activities with their students, including team visits to a church for a religious sermon, FFRF points out. School officials may not use their position as public school employees to give religious leaders unique access to students.

"It is well settled that public schools may not advance or promote religion," FFRF Staff Attorney Chris Line writes to the school district's legal counsel. "Courts have consistently held that it is illegal for a public school to organize, sponsor or lead religious activities, including at public high school athletic events. Organization of and/or participation in a team visit to a church for a religious sermon are also clearly prohibited."

The promotion of religious views by school staff turns any nonbelieving and non-Christian students into outsiders at their own school, FFRF emphasizes. This is especially problematic in the context of athletics, given the pressure players feel to conform to coaches' expectations so as to not lose favor with the coaches or hurt their playing time.

And the U.S. Constitution's prohibition against school-sponsored religious exercise cannot be overcome by claiming that such activities are "voluntary." As the Supreme Court said in Engel v. Vitale (1962), "Neither the fact that the prayer may be denominationally neutral nor the fact that its observance on the part of students is voluntary can serve to free it from the limitations of the Establishment Clause." It also makes no difference if the school requires parents to opt-in to religious practices.

"The combination of football and religion in public schools is insidious and discriminatory," says FFRF Co-President Annie Laurie Gaylor.
"A public school system can't be permitted to continue playing a role in this devotional event."

FFRF is requesting that the district immediately investigate and take action to ensure that school administrators and coaches not organize or participate in such events.

# Department of Education proposed data collection rules may put atheist students at risk

On Nov. 21, in order to avoid an increase in anti-atheist bullying, American Atheists offered improvements to the U.S. Department of Education's proposal to collect religious bullying data.

According to the proposal, the Trump Administration would force school staff to collect data on the victim's apparent religion and report the number of incidents of bullying and harassment associated with each religion. However, with this data collection method, schools would routinely consider, investigate, and record students' religion—endangering student privacy and safety.

"When a student's religion or lack thereof is disclosed to other students and school staff, the student may be bullied, harassed, or face discrimination for their worldview," said Alison Gill, American Atheists' Vice President for Legal and Policy.

"Sadly many Americans are deeply biased against atheists and religious minorities and likely will not treat them fairly," she added. "Teachers may discriminate against students with contrasting religious beliefs by grading the students differently, offering less help to the students, or failing to include the students in opportunities and activities."

Instead of a staff-driven data collection method, American Atheists recommended anonymous student self-reporting to improve reliability and ensure privacy.

"Anonymous self-reporting would be a more workable solution because atheist and religious minority students who are bullied would be better positioned to identify the cause of the bullying than school faculty," added Gill. "This method of data collection would give bullied students control over their privacy and security and allow them to decide whether or not to report the religious aspect of the bullying."

In addition to employing anonymous self-reporting, American Atheists suggests creating additional privacy safeguards and providing resources for training to local educational agencies.

# Let's Not Forget The Human Cost Of **Trump's Denial Of Care Rule**

As we've noted on this blog several times, Americans United is in court defending patients from the Trump administration's reckless Denial of Care Rule in court. This dangerous directive would invite anyone who works in the health care field, from an intake clerk at a hospital to an EMT in an ambulance, to cite their religious beliefs to deny services to others. It would place the health care of millions of Americans at risk.

The rule, which was promulgated by the U.S. Department of Health and Human Services (HHS), was scheduled to go into effect Nov. 22. Thanks to legal action by Americans United and other groups, that didn't happen. Three federal courts have blocked the rule.

But there was another development last week that shouldn't be overlooked: A federal judge in Washington state, who had previously ruled from the bench that the Denial of Care Rule must be invalidated, issued a written opinion explaining why the rule must fail.

U.S. District Judge Stanley A. Bastian's written opinion is notable because he does something the other judges who have heard this matter haven't done: He goes into detail about the real harm to real people this rule would cause.

"It seems elementary that increasing the number of medical professionals who would deny care based on religious or moral objections would not increase access to care; instead, access to care will deteriorate, especially for those individuals in vulnerable populations who will be the target of religious or moral objections," observed Bastian.

Bastian also discussed how the rule would disproportionately harm members of vulnerable populations.

"[T]he Court agrees with Plaintiff's position that the Rule is arbitrary and capricious because HHS disregarded the comments and evidence showing the Rule would severely and disproportionately harm certain vulnerable


- renders the rulemaking process arbitrary and capricious."

Bastian also added an important detail: The Denial of Care Rule violates the basic tenets of medical ethics.

"[T]he Rule is arbitrary and capricious because HHS failed to conduct a reasoned analysis of the requirements of basic medical ethics in adopting the Rule," he wrote. "HHS failed to consider that the Rule's new statutory definitions, which would allow an employee to refuse to participate in life-saving treatment without notice and permits health care entities and providers to withhold basic information from patients, would contravene medical ethics and deprive patients of the ability to provide informed consent."

Arguments made in a court of law are sometimes difficult for the layperson to grasp. That's why Americans United, as it has pursued this litigation, has also used social media, press statements and Church & State articles to make it clear what's at stake: You or someone you love could be denied vital medical care because of a stranger's religious beliefs.

That's not right, and with your help, Americans United will continue to fight the misguided Denial of Care Rule in court. We'll also explain to the American people exactly what's at stake




